This matter came before the Disciplinary Commission of the Supreme Court of Arizona on March 12, 2005, pursuant to Rule 58, Ariz. R. S. Ct., for consideration of the Hearing Officer's Report filed February 9, 2005 recommending acceptance of the Tender of Admissions and Agreement for Discipline by Consent (Agreement) and Joint Memorandum in Support of Agreement for Discipline by Consent (Joint Memorandum) providing for a six month and one day suspension, two years of probation upon reinstatement, fee arbitration in file No. 03-1743, and costs of these disciplinary proceedings.

Decision

The nine members of the Commission unanimously recommend accepting and adopting the Hearing Officer's findings of fact, conclusions of law¹ and recommendation for a six month and one day suspension, two years of probation upon reinstatement, fee arbitration in file No. 03-1743, and costs of these disciplinary proceedings.²
