

LIMITED JURISDICTION COURTS

Narrative Summary

This section combines data from both Justice of the Peace and Municipal Courts and presents them statewide and by county. These data are intended for users who are concerned only with types of limited jurisdiction cases, irrespective of the specific court in which they occurred. Justice of the Peace and Municipal Courts are examined individually in subsequent sections.

Total filings (including transfers in) decreased 0.9% in FY 2002, from 2,257,790 last year to 2,237,246. Traffic cases comprised the majority (69.6%) of the filings in Limited Jurisdiction Courts. Total traffic filings (criminal and civil) decreased by 1.0%, from 1,572,450 last year to 1,556,077 in FY 2002. Criminal filings (misdemeanors and felonies) decreased by 0.3%, from 380,926 in FY 2001 to 379,706 in FY 2002.

Continuing the upward trend from the last four years, petitions for orders of protection in domestic violence cases increased from 19,948 in FY 2001 to 22,968 in FY 2002, an increase of 15.1%. Petitions for injunctions against harassment increased sharply, from 16,676 in FY 2001 to 18,663 in FY 2002, an increase of 11.9%.

Total dispositions (including transfers) increased by 1.2%, from 2,188,547 last year to 2,213,759 in FY 2002. Traffic dispositions (criminal and civil) increased by 2.5% while criminal dispositions (misdemeanor and felony) dropped by 3.0% from last year. Only 8.5% of the orders of protection and 13.5% of the harassment petitions ruled upon were denied.

Total end of year pending cases increased from 1,468,662 in FY 2001 to 1,472,895 in FY 2002, an increase of 0.3%. Most of the increase was in the criminal case category, which increased from 551,992 in FY 2001 to 584,222 in FY 2002, an increase of 5.8%.

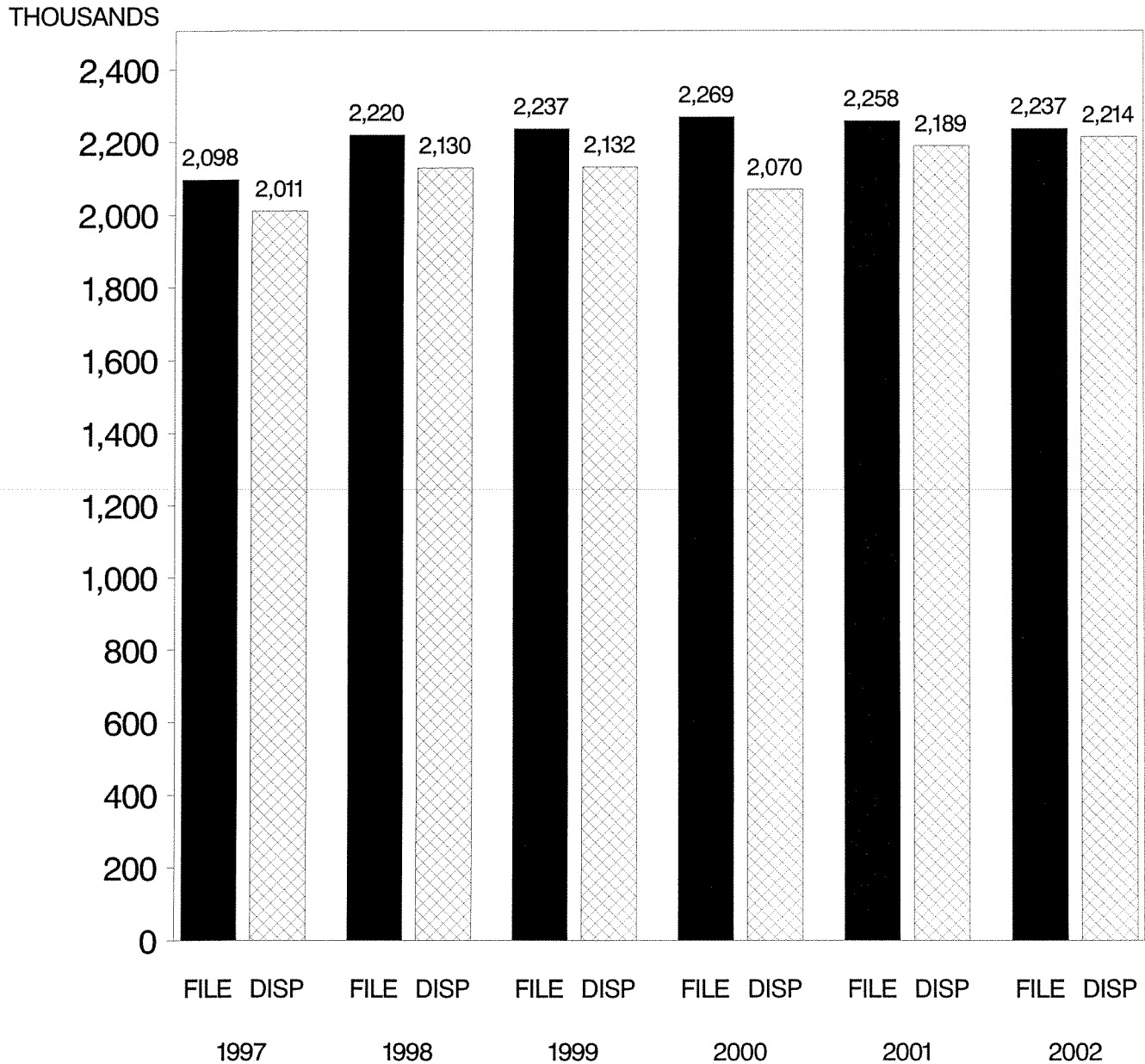

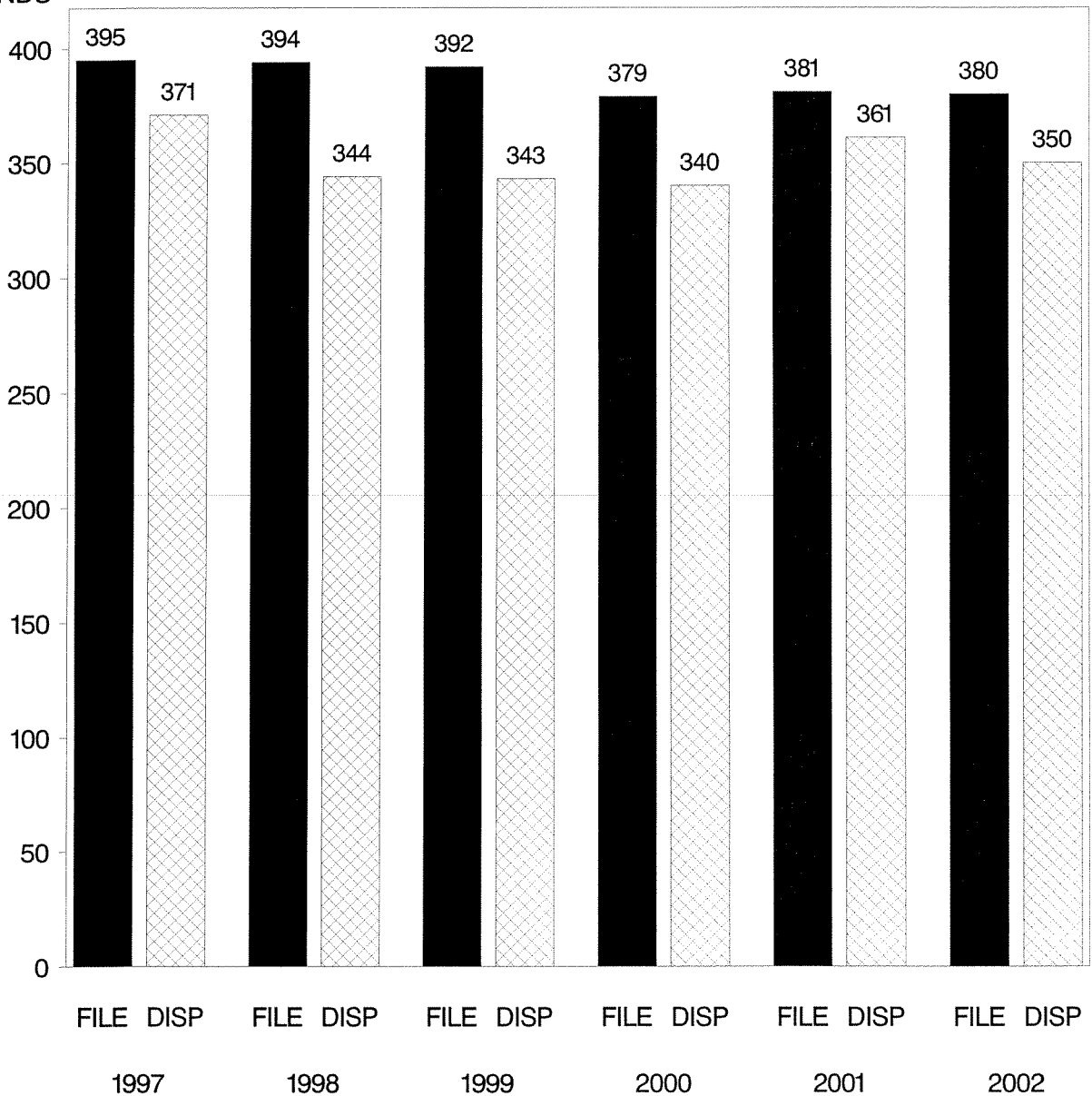

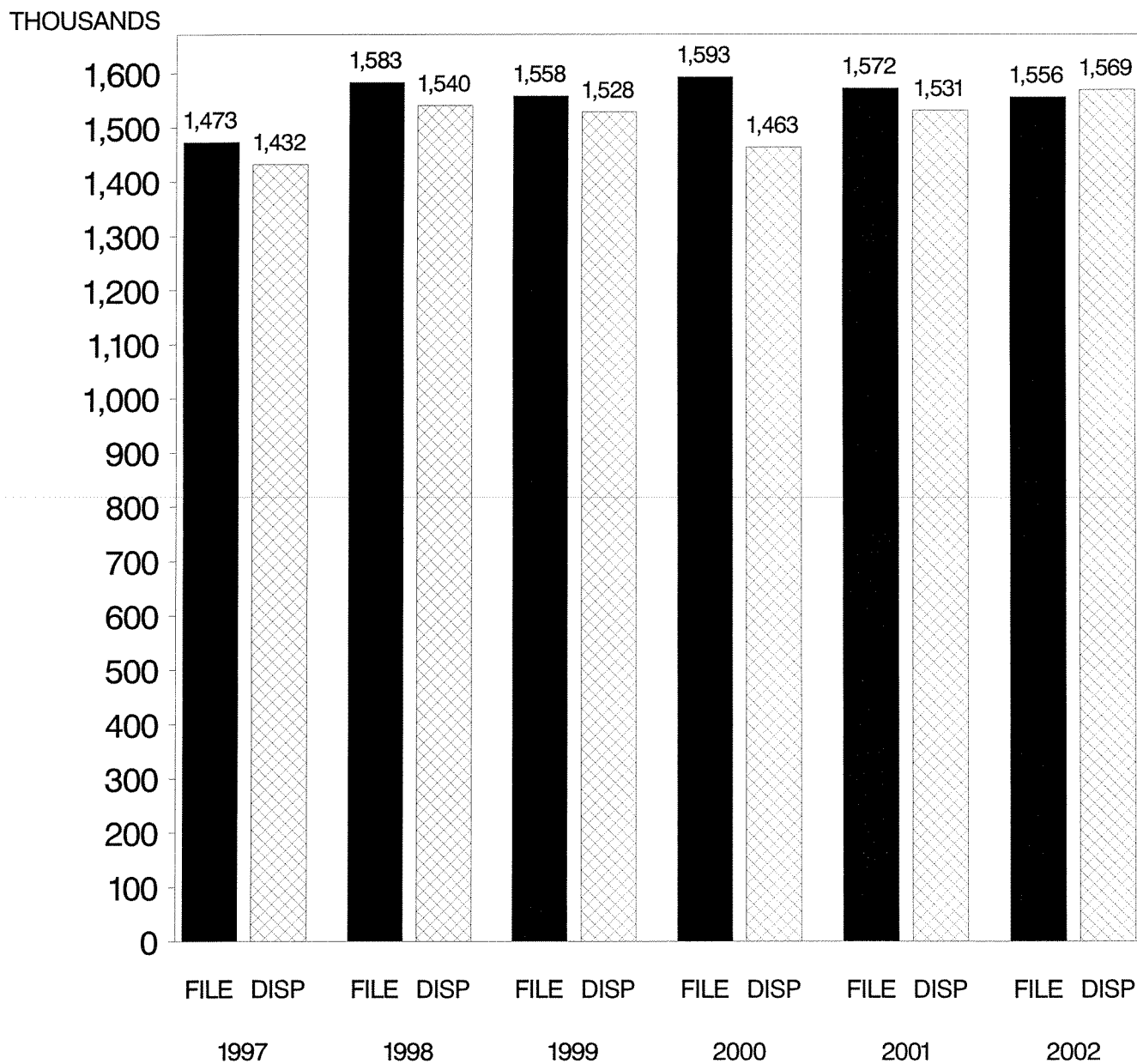

CASES FILED AND DISPOSED

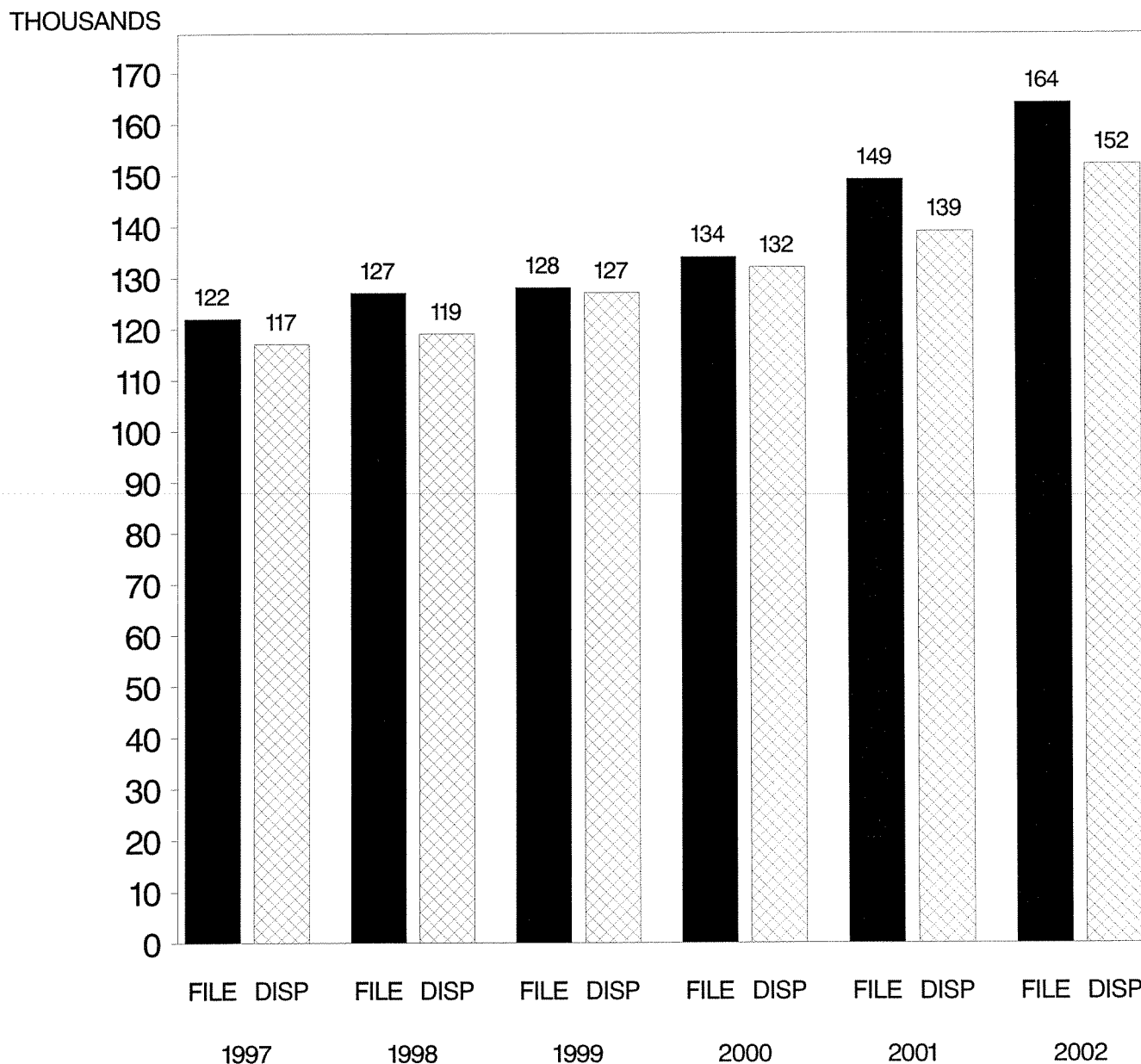

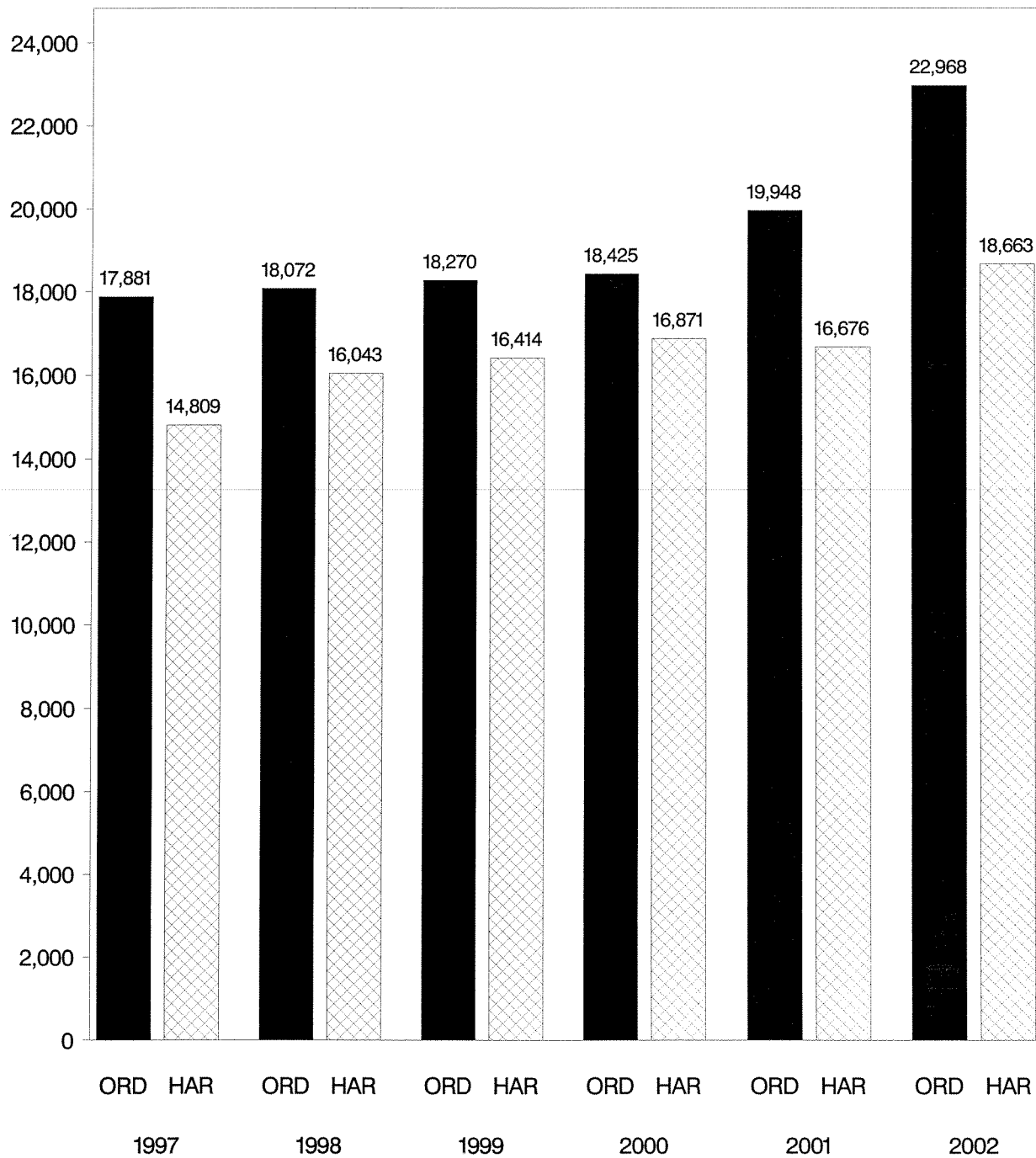
