**ORDER REGARDING
CONDITIONS OF SUPERVISION
PENDING APPEAL**

The Hearing Panel reviewed Respondent's Proposed Conditions of Supervision Pending Appeal, the State Bar's Response thereto, and directed the parties to submit a stipulated form of order approving proposed conditions of supervision pending appeal, and has now reviewed the parties' stipulation regarding this Order. The Hearing Panel finds those stipulated terms to be appropriate conditions of supervision and therefore meet the requirements of Supreme Court Rule 59(c).

IT IS ORDERED that the following conditions of supervision apply pending Respondent's appeal of the Hearing Panel's March 19, 2013 Report and Order Imposing Sanctions:

- (1) Gary Hendrickson, Esq., shall act as a mentor and supervise Respondent's calendaring and office management. Mr. Hendrickson shall provide a monthly report to the State Bar by the 15th of each month addressing the status and condition of Respondent's calendaring and office management, with the first such report due in June of 2013;

- (2) Susan Traylor shall conduct an assessment of Respondent's calendaring and office management systems by June 3, 2013. Respondent shall advise the State Bar of the date of the assessment and shall provide to the State Bar a copy of Ms. Traylor's assessment, including any recommendations made by Ms. Traylor as a result of the assessment. Respondent shall follow all of Ms. Traylor's recommendations and shall further advise the State Bar of his compliance with any recommendations made by Ms. Traylor; and
- (3) Per Respondent's statement in his Proposed Conditions of Supervision Pending Appeal filed on May 1, 2013, Respondent shall continue to maintain his caseload at a level in which he can devote adequate attention to each client that he represents.
