No. 2 Rule Petitions Judge O'Neil/Kathleen Curry

- Early Bar Exam – Order signed December 10, 2012
 - Court wanted the law student to sign the affidavit.
 - The law school's certification decision is final.
 - ARC is to file a report with the court in 2015.
 - Evaluation and status updates to be provided at future ARC meetings by Jim Drake.
 - Clinical, statistical analysis of passage rates
 - Evaluation with applicants on the impact
- Military Spouse Licensure – Order signed December 10, 2012
 - Applicant would go through a full Character and Fitness process but it will be expedited.
- Admission on Motion – Order signed December 10, 2012
 - Allows attorney to be admitted on motion if they have been admitted by bar exam in any state and practiced for five of seven years in a reciprocal state.
- Appeals Process – Comments due May 21, 2013
 - New petition filed, no number yet
 - Appeals process in disciplinary matters to match the appeals process in the Court of Appeals.
 - Can be looked at in the Rules subcommittee
