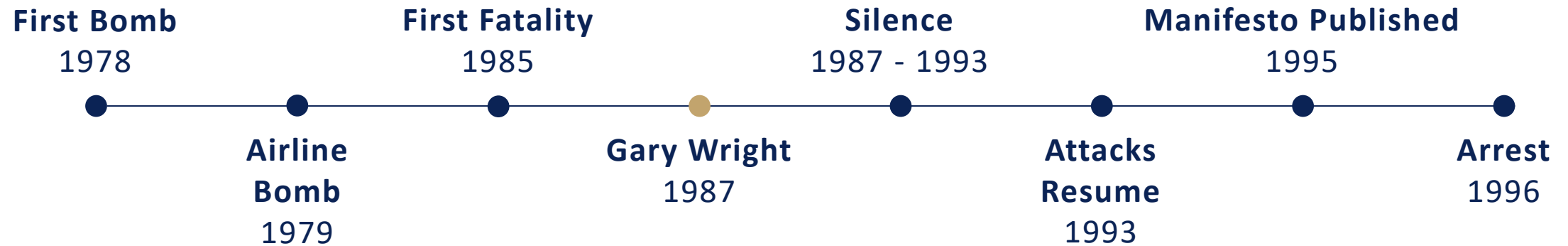

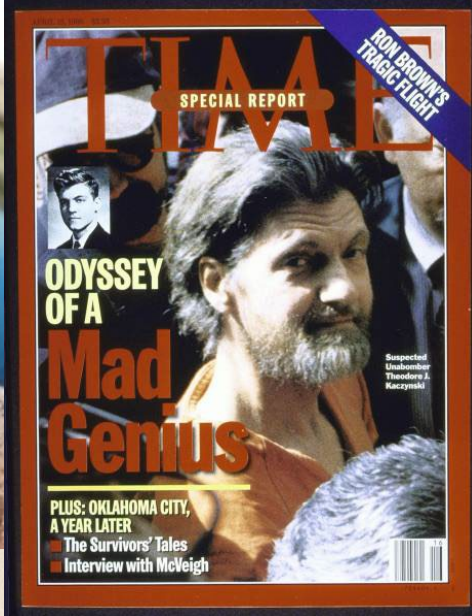
Unabomber Timeline

May 1978 – April 1996

23 Injuries **3** Deaths

THE U.S. POSTAL SERVICE MAY PAY A REWARD OF UP TO \$50,000 FOR INFORMATION AND SERVICES LEADING TO THE ARREST AND CONVICTION OF ANY PERSON(S) FOR PLACING OR MAILING AN EXPLOSIVE DEVICE IN A POSTAL DEPOSITORY.

ON FEBRUARY 20TH, 1987 A PACKAGE EXPLODED AT A COMPUTER BUSINESS AT 270 E. 900 S. SALT LAKE CITY, UTAH 84111. BOMBS HAVE BEEN EITHER RECEIVED IN THE MAILS AND OR PLACED IN THE FOLLOWING STATES: UTAH, PENNSYLVANIA, ILLINOIS, CALIFORNIA, MICHIGAN AND WASHINGTON. THIS INCIDENT HAS BEEN LINKED TO 11 OTHER INCIDENTS WHICH HAVE OCCURRED ACROSS THE UNITED STATES SINCE 1978 INJURING 21 PEOPLE AND KILLING ONE.

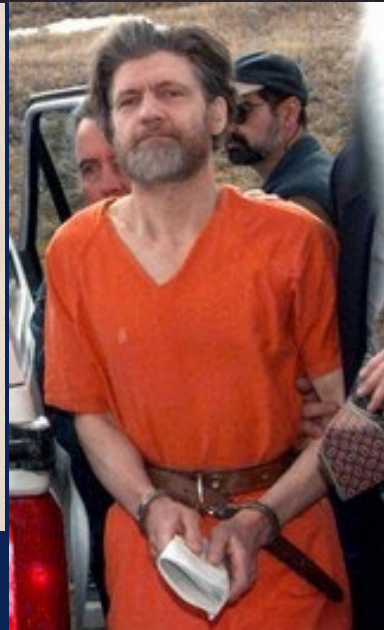
White Male

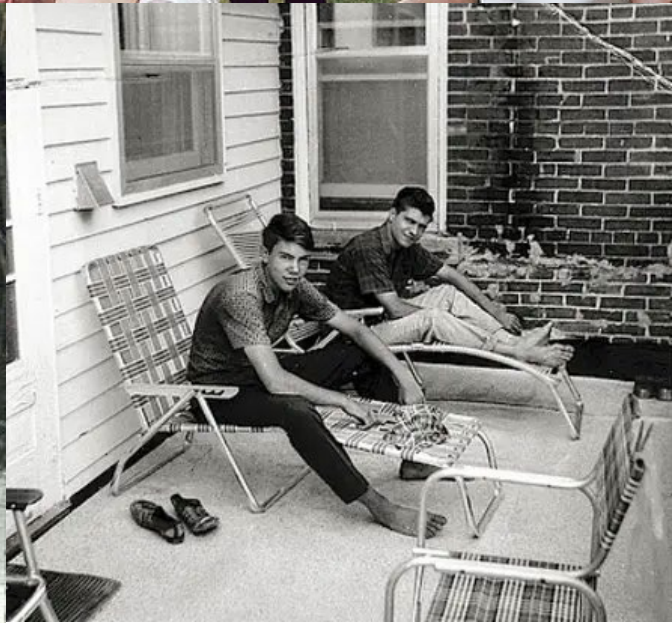

“At that point, there was nothing that connected me or my family to what had happened to Gary.”

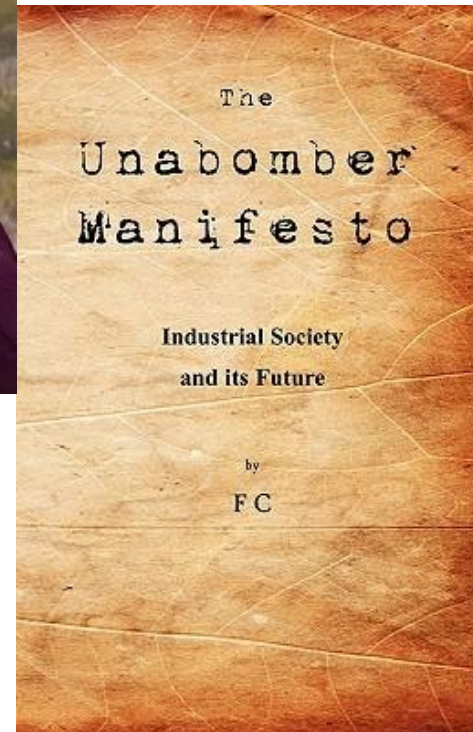
