

Cómo hacer una búsqueda por el número de caso

Para realizar una búsqueda por el **número de caso**, necesitará:

1. Seleccionar la pestaña *Case and Party Search* (Búsqueda por caso y partes) o la pestaña *Case and Event Search* (Búsqueda por caso y audiencia o documento presentado).
2. Ingresar el número de caso: Formato del número de caso: [IDENTIFICACIÓN DEL TRIBUNAL][TIPO DE CASO][AÑO][SECUENCIA]. Ejemplo: P1300CV200200106
 - a. No es necesario incluir la identificación del tribunal para los casos de los condados de Maricopa y Pima. El formato del número de caso es [TIPO DE CASO][AÑO][SECUENCIA] Ejemplo: CR2010123456
3. Hacer clic en *Search* (Buscar).
