Para realizar una búsqueda por el **nombre de una de las partes**, necesitará:

1. Seleccionar la pestaña *Case and Party Search* (Búsqueda por caso y partes)
2. Ingresar el nombre de una de las partes. Actualmente la aplicación no puede realizar búsquedas por nombres ni coincidencias parciales.
3. Hacer clic en *Search* (Buscar).
