On June 4, 2008, Administrative Order No. 2008-47 was issued to clarify the disposition codes that courts are required to use in reporting to the Motor Vehicle Department. Legislation was implemented in 2021 that required the addition or updating of disposition codes. These new codes require revising and replacing Administrative Order No. 2008-47.

Therefore, pursuant to Article VI, Section 3, of the Arizona Constitution,

IT IS ORDERED that the attached disposition codes are adopted for use by all Arizona courts when recording case dispositions or when reporting case dispositions to non-judicial agencies.

IT IS FURTHER ORDERED that courts may continue to adopt additional disposition codes to accommodate their operations, so long as they are used for internal purposes only. All reporting of traffic violation status external to the court of jurisdiction shall be accomplished by using the attached codes.
