**Effective 10/30/2023**

**Directions: If CMS has functionality to end date, then juvenile only funds provided below should be end date as of 10/29/2023. Funds not specific to juvenile cases only will be training to not assess. If CMS does not have the functionality to end date then all the funds below will be training to not assess on juvenile cases.**
