This person has two different cases at Youngtown Municipal court. Though the defendant originally selected the top case number (as reflected on the left hand panel), the defendant does have the choice on which case he wants to apply the payment. Selecting the radio button next to the original case number and pressing the “Continue with payment” button returns the following screen:

On this screen the user can enter the amount to be paid for the case. This field is pre-loaded with the existing case balance but can be overridden by the user with any amount between \$20 and the case balance. An amount less than \$20 can be entered only if that is the remaining case balance.

Leaving the case balance in place and clicking the "Continue with payment" button returns the following screen:
