Finding the Security Code


A credit card Security Code provides an additional security measure to prevent card misuse with on-line transactions. The Security Code is also known as the credit card Verification Value.

For the majority of credit cards, the security code is the last three or four digits of the number shown above on the signature strip on the reverse side of the credit card. In the example below, the Security Code is '123'.




