

## **SUPERIOR COURT Narrative Summary**

Total filings (including transfers in) were up by 5.8%, from 211,380 in FY 2007 to 223,676 this fiscal year. Superior Court's second largest category, criminal filings, experienced an increase of 2.9%, from 59,601 in FY 2007 to 61,322 in FY 2008. The largest category, civil filings increased by 23.4%, from 58,291 in FY 2007 to 71,911 in FY 2008. Domestic relations filings decreased by 2.9%, from 51,720 in FY 2007 to 50,244 in FY 2008. These three categories account for 82.0% of the total filings in Superior Court.

Prior to 1996, petitions for orders of protection and injunctions against harassment in Superior Court were reported together under domestic violence petitions. In FY 2008, these petitions together increased by 6.6 %, from 11,940 in FY 2007 to 12,727 in FY 2008. Separately, orders of protection were up by 6.5% from FY 2007 while injunctions against harassment increased by 7.1% in FY 2008. Juvenile delinquent and incorrigible filings decreased, from 18,599 to 18,472 or 0.7%.

Total dispositions (including transfers) were up from 203,860 in FY 2007 to 214,901 in FY 2008, an increase of 5.4%. Domestic relations dispositions experienced a decrease of 2.1%, from 52,579 in FY 2007 to 51,488 in FY 2008. Civil dispositions increased by 19.2%, from 55,440 in FY 2007 to 66,064 in FY 2008. Criminal dispositions increased by 4.6% in FY 2008, from 55,836 in FY 2007 to 58,390 in FY 2008, an increase of 2,554 cases. These three categories account for 81.9% of the dispositions in Superior Court.

Total end of year pending cases showed an increase of 6,618 or 3.0%, from 221,175 in FY 2007 to 227,793 in FY 2008.

**In 1996, two additional categories were added to the Superior Court report, Adult Adoption, previously reported in the probate category, and Mental Health. In this report, criminal filings and juvenile petition statistics represent the number of persons; all other statistics represent cases.**

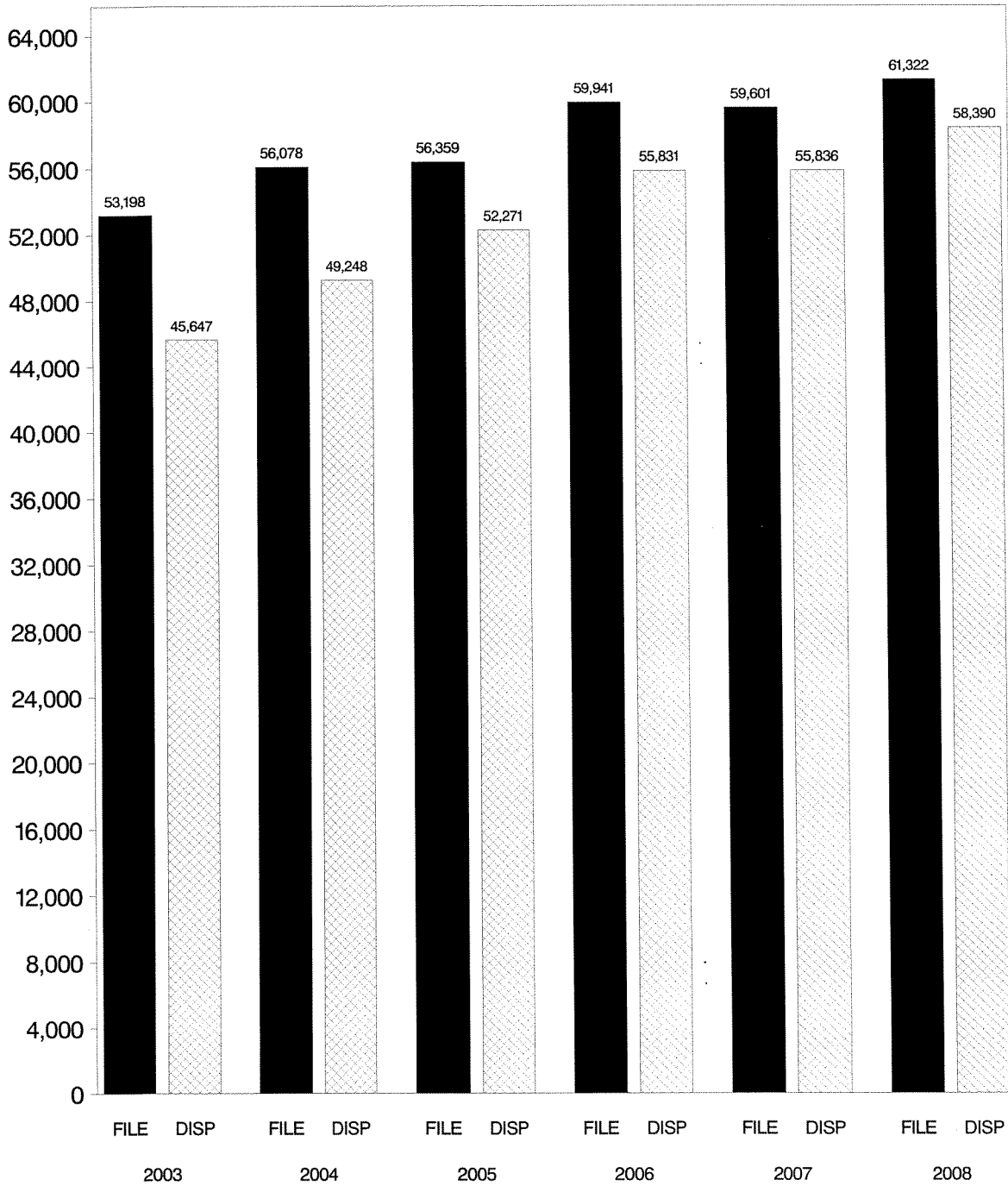

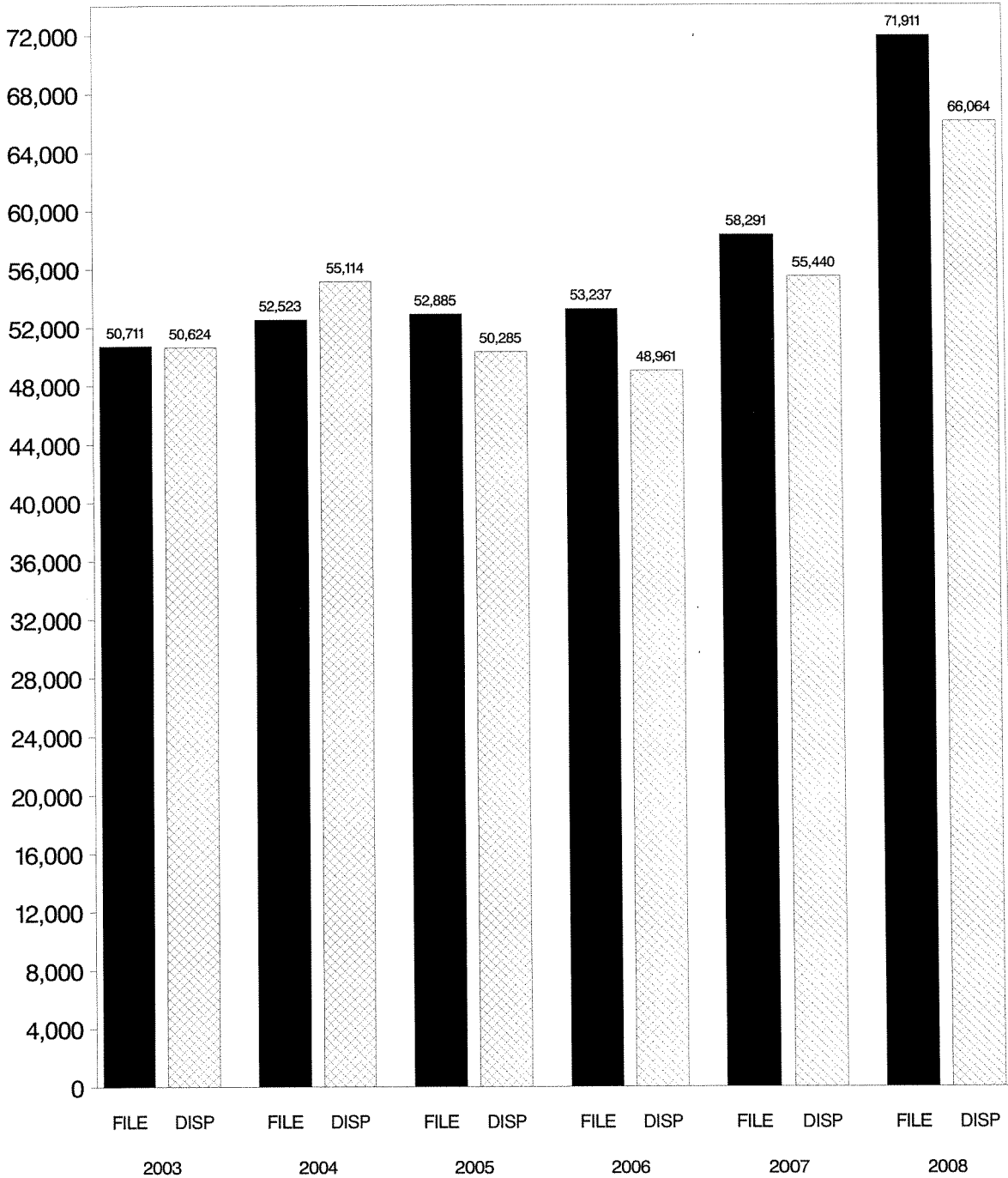

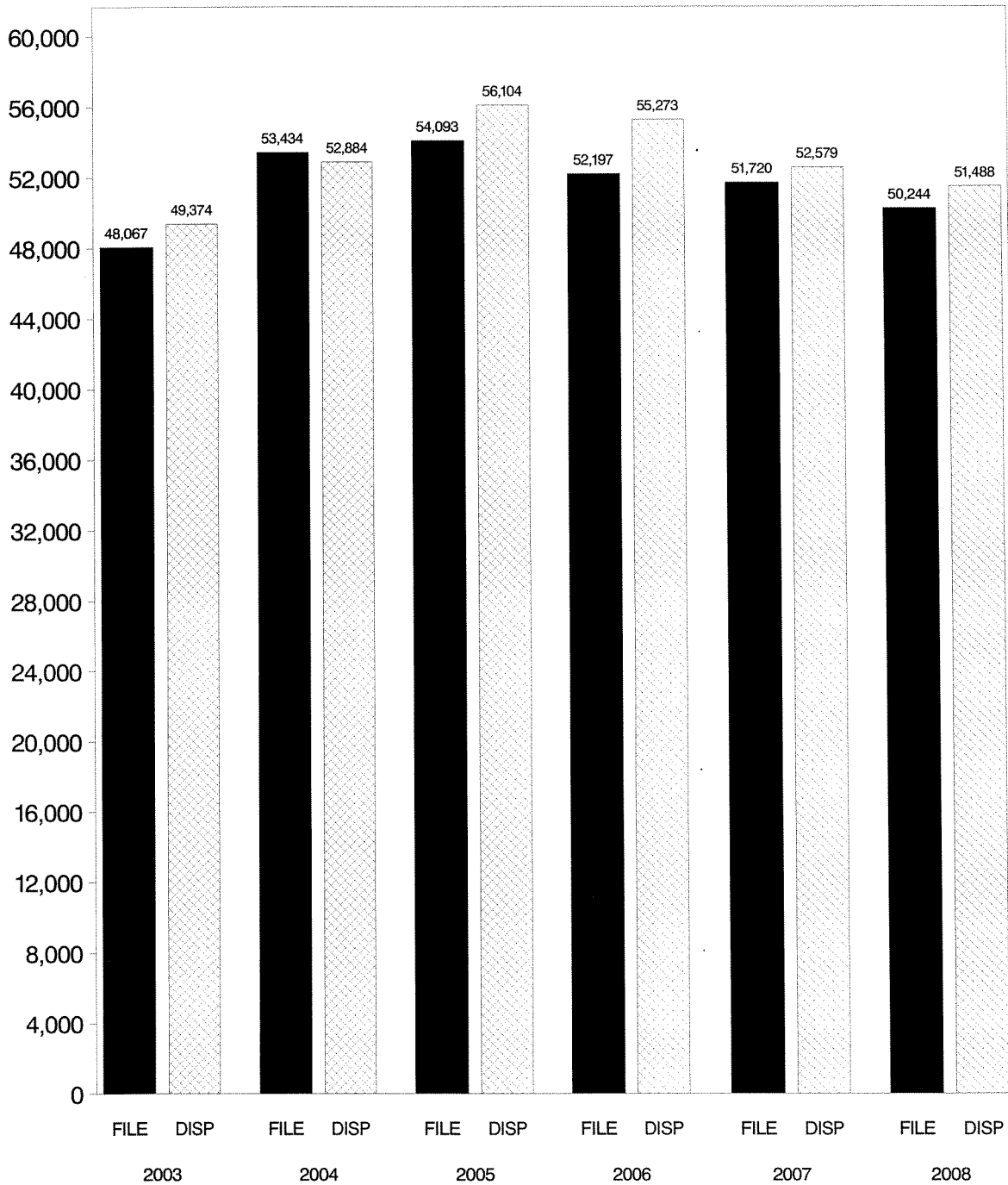
