

## **COURT PERSONNEL**

### **Limited Jurisdiction Courts Narrative Summary**

The limited jurisdiction summary illustrates all court positions in Justice of the Peace and Municipal Courts as of June 30, 2009 including positions funded from both primary and non-primary budget sources. The information was reported by the individual courts in response to the Supreme Court personnel survey which was electronically distributed in August 2009.

The total number of persons working full-time in the Limited Jurisdiction Courts decreased by 2.0%, from 1,936 in FY 2008 to 1,897 in FY 2009. In FY 2009, there were 779 people employed full-time in the Justice Courts, compared with 768 the previous year. Full-time employees in the Municipal Courts decreased from 1,168 the previous fiscal year to 1,118 in FY 2009.

The Limited Jurisdiction Courts employed an additional 545 part-time personnel in FY 2009, compared to 550 in FY 2008, a decrease of 0.9%. The Justice Courts employed 131 part-time personnel, versus 138 the previous fiscal year. The Municipal Courts employed 414 part-time personnel, compared to 412 in FY 2008.

The courts also had the services of 86 regular volunteers in FY 2009. Volunteers include non-professionals and professionals who serve in various capacities, from support staff to on-call magistrates. The Justice Courts utilized 29 regular volunteers while the Municipal Courts had the services of 57.

Additionally, the Limited Jurisdiction Courts utilized 28,081 hours of temporary personnel assistance in FY 2009. The Justice Courts used 11,815 hours of temporary personnel, while the Municipal Courts had 16,266 hours.
