Limited Jurisdiction Courts Narrative Summary

The revenue data provided here are for the Limited Jurisdiction Courts of Arizona. The figures were compiled from quarterly revenue surveys submitted to the Supreme Court during fiscal year 2009. Major revenue categories shown represent monies collected from four sources:

FINES, SANCTIONS, FORFEITURES: Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that were forfeited;

SURCHARGES: Revenue from monetary assessments authorized by statute above and beyond criminal and traffic penalties and certain civil and other fees;

FEES: Revenue from collectible fees for services of the court and chargeable aspects of case processing;

OTHER REVENUE: Revenue from sources not otherwise specified.

Total revenue collected by Limited Jurisdiction Courts increased from \$288,012,010 in FY 2008 to \$309,023,738 in FY 2009, an increase of 7.9%. Justice Court revenue increased from \$95,915,809 last year to \$116,927,535 in FY 2009, up 21.9%. Justice Court revenue included \$9,671,742 from civil traffic State Photo Enforcement cases. Municipal Court revenue went from \$192,096,201 in FY 2008 to \$193,935,193 in FY 2009, an increase of 1.0%.

The fines category is the largest at \$135,822,571, accounting for 43.7% of the total. Most of these fines (\$84,386,082 or 62.1%) were assessed in Municipal Courts. The second largest category is surcharges, accounting for \$90,936,390, or 29.4% of the total revenue. Again, the majority of the surcharges were assessed in Municipal Courts (\$59,634,612 or 65.6%).

Maricopa and Pima County Justice Courts comprise 57.7% of all Justice Court revenue. Municipal Courts from these two counties constitute 84.4% of all Municipal Court revenue. The two largest Municipal Courts--Phoenix and Tucson--not only account for 35.2% of all Municipal Court revenue, but 21.9% of the revenue from all Arizona Limited Jurisdiction Courts. In all, Maricopa and Pima County Limited Jurisdiction Courts collect 74.3% of all Justice and Municipal Court revenue.

The Annual Trust Money Collection Summary shows that the Limited Jurisdiction Courts processed \$35,490,339 in "pass-through" trust monies in FY 2009, most of which (86.6%) were for bail bonds.
