

LIMITED JURISDICTION COURTS

Narrative Summary

This section combines data from both Justice of the Peace and Municipal Courts and presents them statewide and by county. These data are intended for users who are concerned only with types of limited jurisdiction cases, irrespective of the specific court in which they occurred. Justice of the Peace and Municipal Courts are examined individually in subsequent sections.

Total filings (including transfers in) decreased 6.0% in FY 2010, from 2,497,670 last year to 2,349,036. Traffic cases comprised the majority (69.5%) of the filings in Limited Jurisdiction Courts. Total traffic filings (criminal and civil) decreased by 6.3%, from 1,742,550 last year to 1,632,005 in FY 2010. Criminal filings (misdemeanors and felonies) decreased by 4.6%, from 376,217 in FY 2009 to 358,879 in FY 2010.

Petitions for orders of protection in domestic violence cases increased from 21,953 in FY 2009 to 22,598 in FY 2010, an increase of 2.9%. Petitions for injunctions against harassment decreased, from 18,590 in FY 2009 to 17,142 in FY 2010, a decrease of 7.8%. Only 11.5% of the orders of protection and 17.8% of the harassment petitions ruled upon were denied.

Total dispositions (including transfers) decreased by 5.8%, from 2,675,895 last year to 2,520,210 in FY 2010. Traffic dispositions (criminal and civil) decreased by 6.8% while criminal dispositions (misdemeanor and felony) decreased by 4.3% from last year.

The total pending caseload figure decreased from 1,561,224 in FY 2009 to 1,532,468 in FY 2010, a decrease of 1.8%. Most of the decrease was in the non-criminal ordinance category, which decreased from 69,920 in FY 2009 to 60,824 in FY 2010, a decrease of 13.0%. The criminal traffic category also decreased, from 265,072 in FY 2009 to 252,684 in FY 2010, which was a decrease of 4.7%.

NOTE: Some of the FY 2009 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.

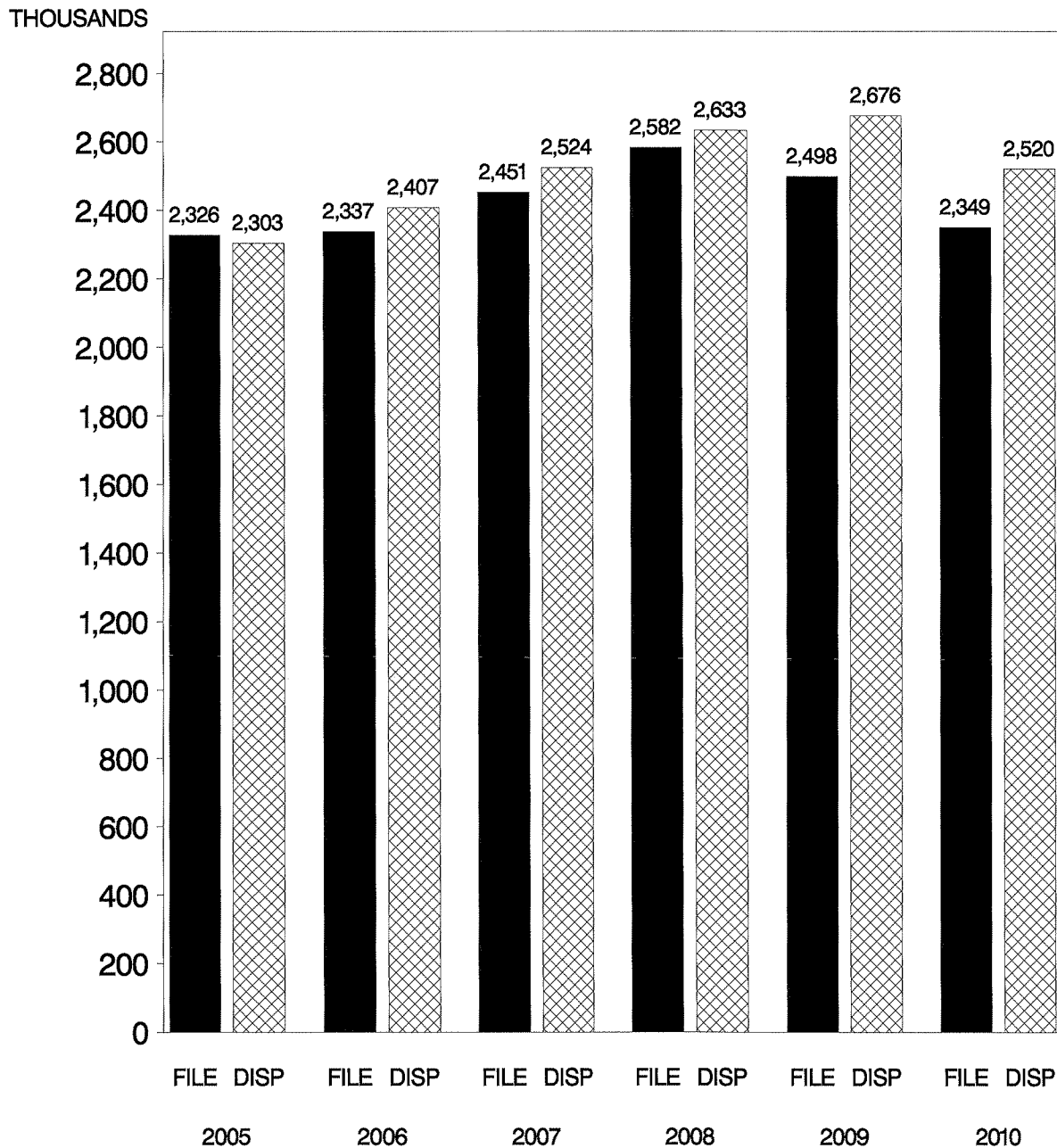

COMBINED ANNUAL CASE ACTIVITY, FY 2005 – 2010 CASES FILED AND DISPOSED

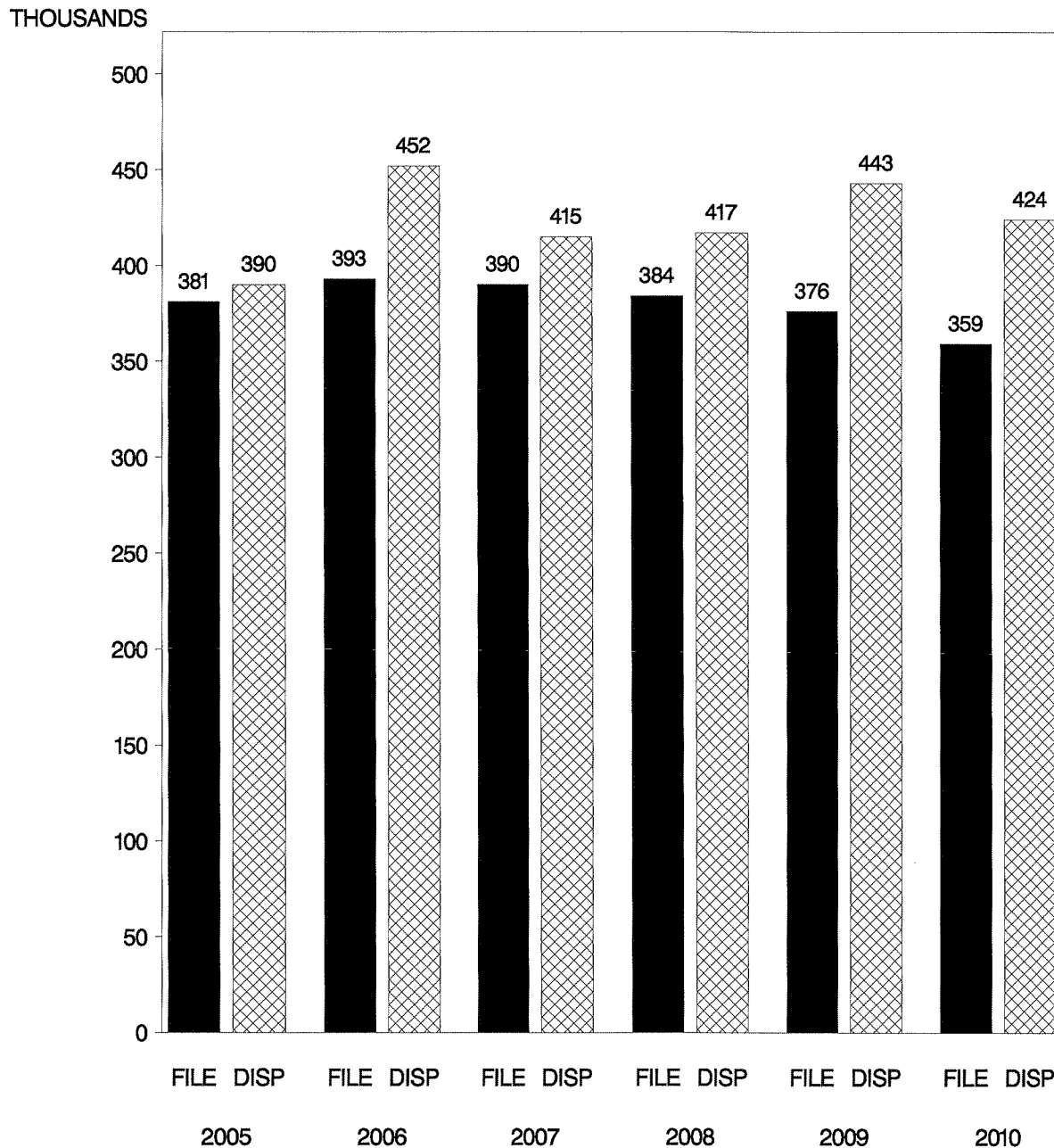

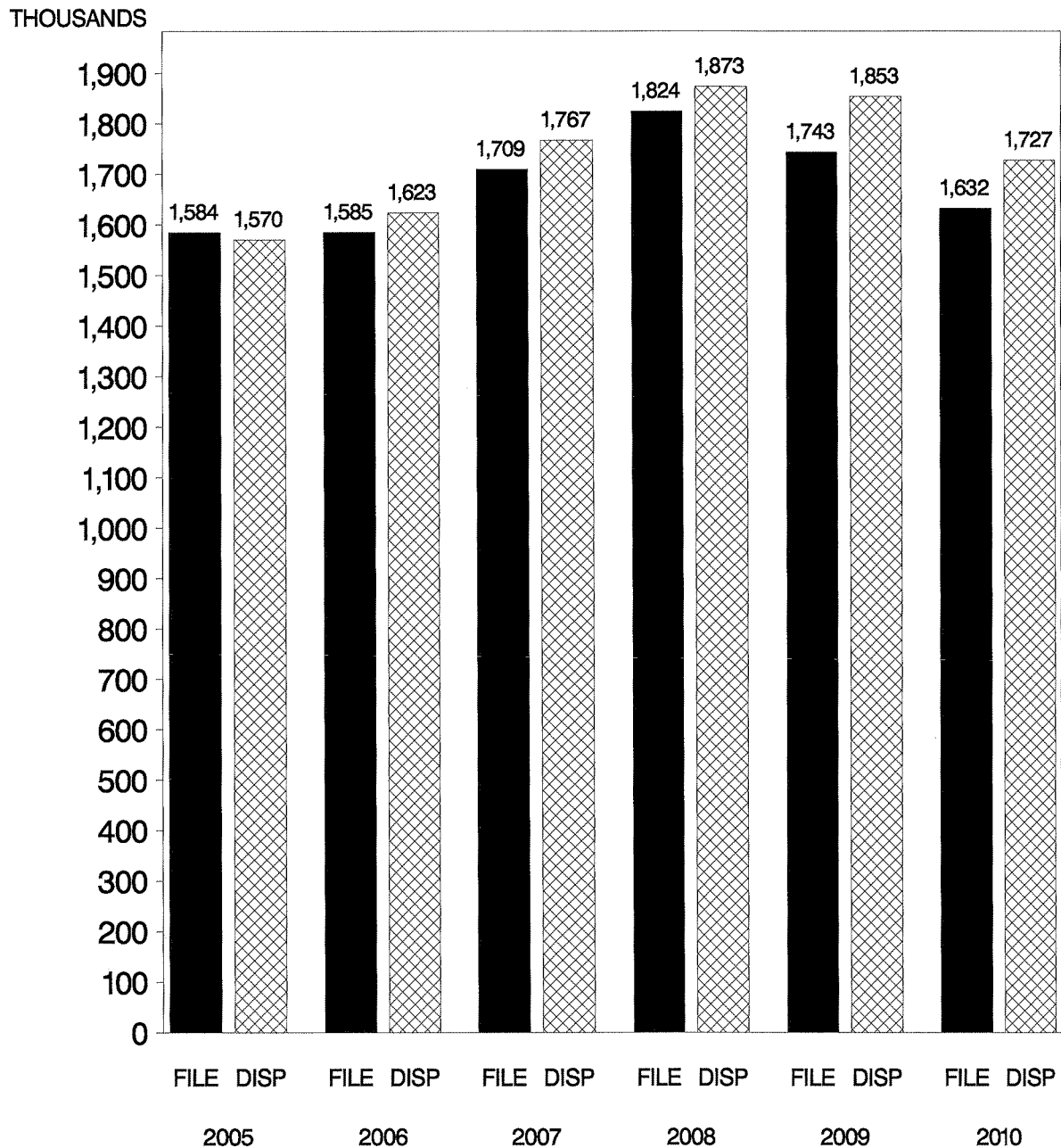

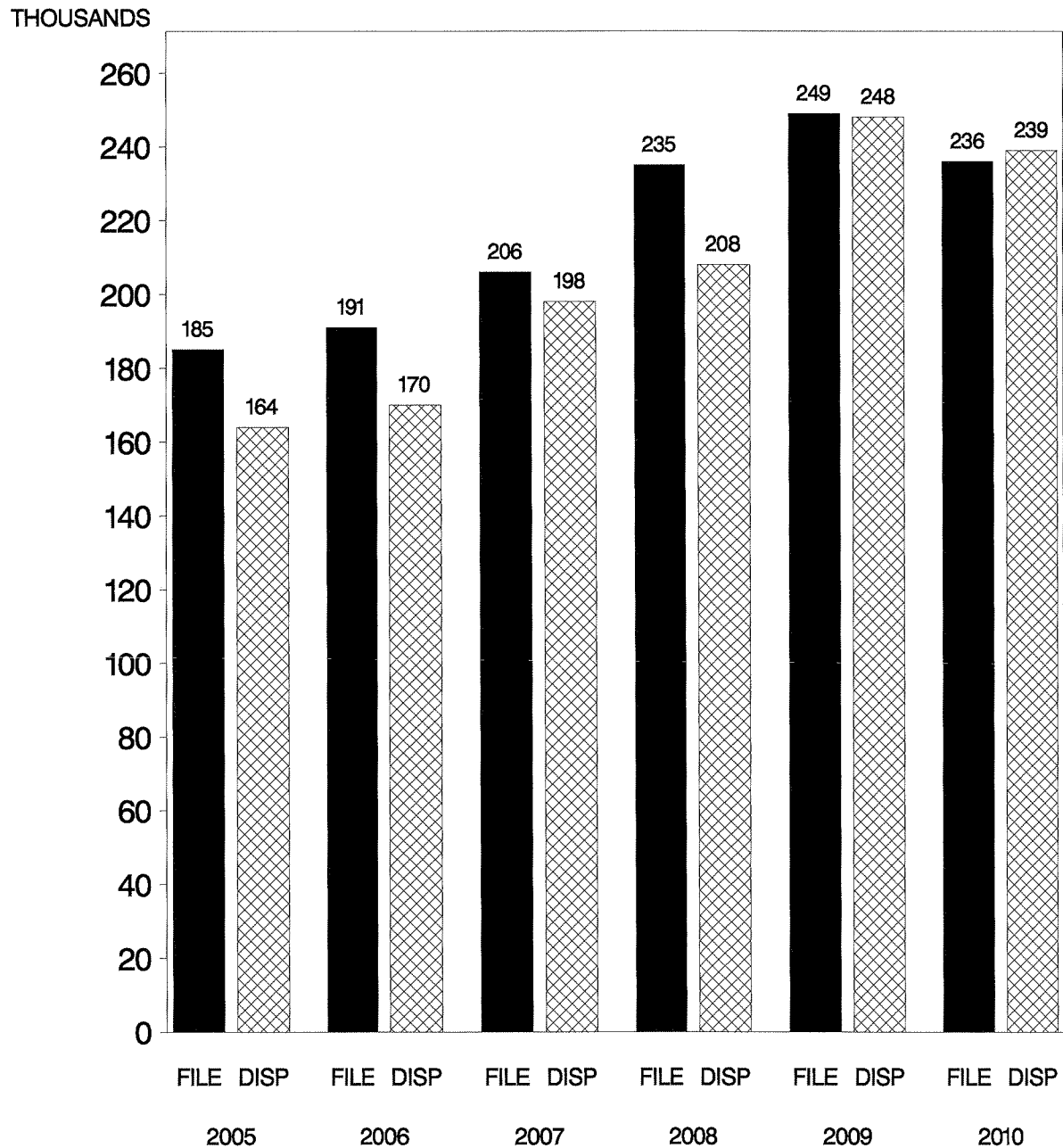

CIVIL CASE ACTIVITY, FY 2005 – 2010

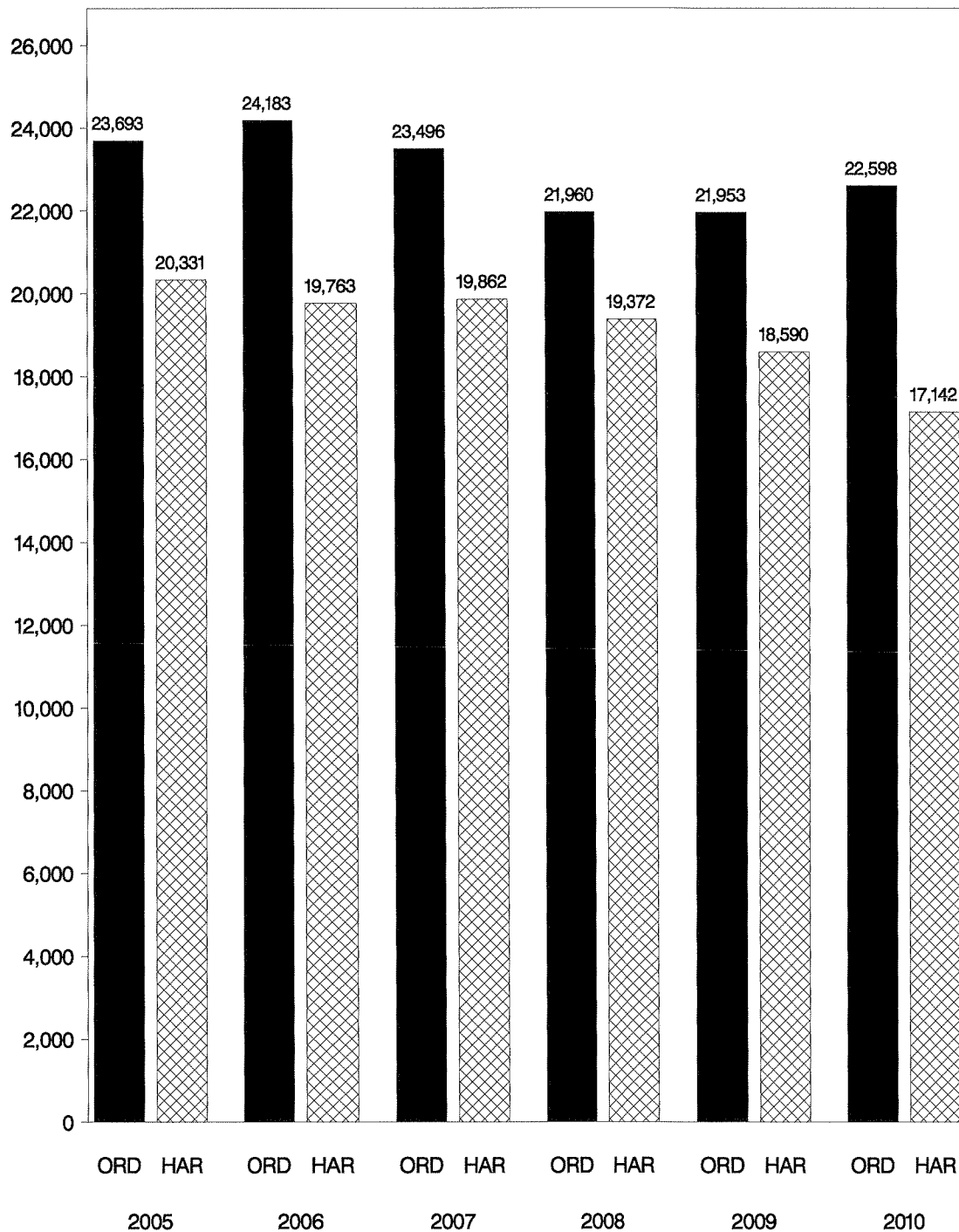
