Limited Jurisdiction Courts Narrative Summary

The limited jurisdiction summary illustrates all court positions in Justice of the Peace and Municipal Courts as of June 30, 2010 including positions funded from both primary and non-primary budget sources. The information was reported by the individual courts in response to the Supreme Court personnel survey which was electronically distributed in August 2010.

The total number of persons working full-time in the Limited Jurisdiction Courts decreased by 2.8%, from 1,897 in FY 2009 to 1,843 in FY 2010. In FY 2010, there were 795 people employed full-time in the Justice Courts, compared with 779 the previous year. Full-time employees in the Municipal Courts decreased from 1,118 the previous fiscal year to 1,048 in FY 2010.

The Limited Jurisdiction Courts employed an additional 553 part-time personnel in FY 2010, compared to 545 in FY 2009, an increase of 1.5%. The Justice Courts employed 137 part-time personnel, versus 131 the previous fiscal year. The Municipal Courts employed 416 part-time personnel, compared to 414 in FY 2009.

The Limited Jurisdiction Courts also had the services of 45 regular volunteers in FY 2010. Volunteers include non-professionals and professionals who serve in various capacities, from support staff to on-call magistrates. The Justice Courts utilized 17 regular volunteers while the Municipal Courts had the services of 28.

Additionally, the Limited Jurisdiction Courts utilized 28,446 hours of temporary personnel assistance in FY 2010. The Justice Courts used 14,723 hours of temporary personnel, while the Municipal Courts had 13,723 hours.

Some of the FY 2009 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the report.
