Limited Jurisdiction Courts Narrative Summary

The revenue data provided here are for the Limited Jurisdiction Courts of Arizona. The figures were compiled from quarterly revenue surveys submitted to the Supreme Court during fiscal year 2010. Major revenue categories shown represent monies collected from four sources:

FINES, SANCTIONS, FORFEITURES: Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that were forfeited;

SURCHARGES: Revenue from monetary assessments authorized by statute above and beyond criminal and traffic penalties and certain civil and other fees;

FEES: Revenue from collectible fees for services of the court and chargeable aspects of case processing;

OTHER REVENUE: Revenue from sources not otherwise specified.

Total revenue collected by Limited Jurisdiction Courts increased from \$311,843,832 in FY 2009 to \$327,881,084 in FY 2010, an increase of 5.1%. Justice Court revenue increased from \$117,908,639 last year to \$140,176,356 in FY 2010, up 18.9%. Justice Court revenue included \$26,058,273 from civil traffic State Photo Enforcement cases. Municipal Court revenue went from \$193,935,193 in FY 2009 to \$187,704,728 in FY 2010, a decrease of 3.2%.

The fines category is the largest at \$144,878,534, accounting for 44.2% of the total. Most of these fines (\$80,168,833 or 55.3%) were assessed in Municipal Courts. The second largest category is surcharges, accounting for \$92,608,835, or 28.2% of the total revenue. Again, the majority of the surcharges were assessed in Municipal Courts (\$57,662,641 or 62.3%).

Maricopa and Pima County Justice Courts comprise 64.2% of all Justice Court revenue. Municipal Courts from these two counties constitute 83.7% of all Municipal Court revenue. The two largest Municipal Courts--Phoenix and Tucson--not only account for 36.7% of all Municipal Court revenue, but 21.0% of the revenue from all Arizona Limited Jurisdiction Courts. In all, Maricopa and Pima County Limited Jurisdiction Courts collect 75.4% of all Justice and Municipal Court revenue.

The Annual Trust Money Collection Summary shows that the Limited Jurisdiction Courts processed \$31,488,363 in "pass-through" trust monies in FY 2010, most of which (86.8%) were for bail bonds.

Some of the FY 2009 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report. Revenue reports received from courts are checked for mathematical accuracy, but are not audited by the Supreme Court.
