

## **SUPERIOR COURT Narrative Summary**

Total filings (including transfers in) were down by 0.3%, from 243,867 in FY 2009 to 243,179 this fiscal year. Superior Court's second largest category, criminal filings, experienced a decrease of 8.2%, from 57,475 in FY 2009 to 52,782 in FY 2010. The largest category, civil filings increased by 9.5%, from 92,800 in FY 2009 to 101,596 in FY 2010. Domestic relations filings decreased by 3.7%, from 52,308 in FY 2009 to 50,388 in FY 2010. These three categories account for 84.2% of the total filings in Superior Court.

Prior to 1996, petitions for orders of protection and injunctions against harassment in Superior Court were reported together under domestic violence petitions. In FY 2010, these petitions together decreased by 0.8 %, from 14,838 in FY 2009 to 14,712 in FY 2010. Separately, orders of protection were up by 3.6% from FY 2009 while injunctions against harassment decreased by 15.2% in FY 2010. Juvenile delinquent and incorrigible filings decreased, from 17,337 to 15,423 or 11.0%.

Total dispositions (including transfers) were up from 233,288 in FY 2009 to 246,156 in FY 2010, an increase of 5.5%. Domestic relations dispositions experienced a decrease of 6.9%, from 52,266 in FY 2009 to 48,637 in FY 2010. Civil dispositions increased by 25.8%, from 81,541 in FY 2009 to 102,569 in FY 2010. Criminal dispositions decreased by 11.8% in FY 2010, from 60,229 in FY 2009 to 53,150 in FY 2010, a decrease of 7,079 cases. These three categories account for 83.0% of the dispositions in Superior Court.

Total end of year pending cases showed a decrease of 2,192 or 1.0%, from 220,943 in FY 2009 to 218,751 in FY 2010.

Data for all counties except Maricopa, Pima and Pinal were estimated for FY2010 due to the transition from the AZTEC case management system to the new case management system called AJACS (Arizona Judicial Automated Case System).

**In 1996, two additional categories were added to the Superior Court report, Adult Adoption, previously reported in the probate category, and Mental Health. In this report, criminal filings and juvenile petition statistics represent the number of persons; all other statistics represent cases.**

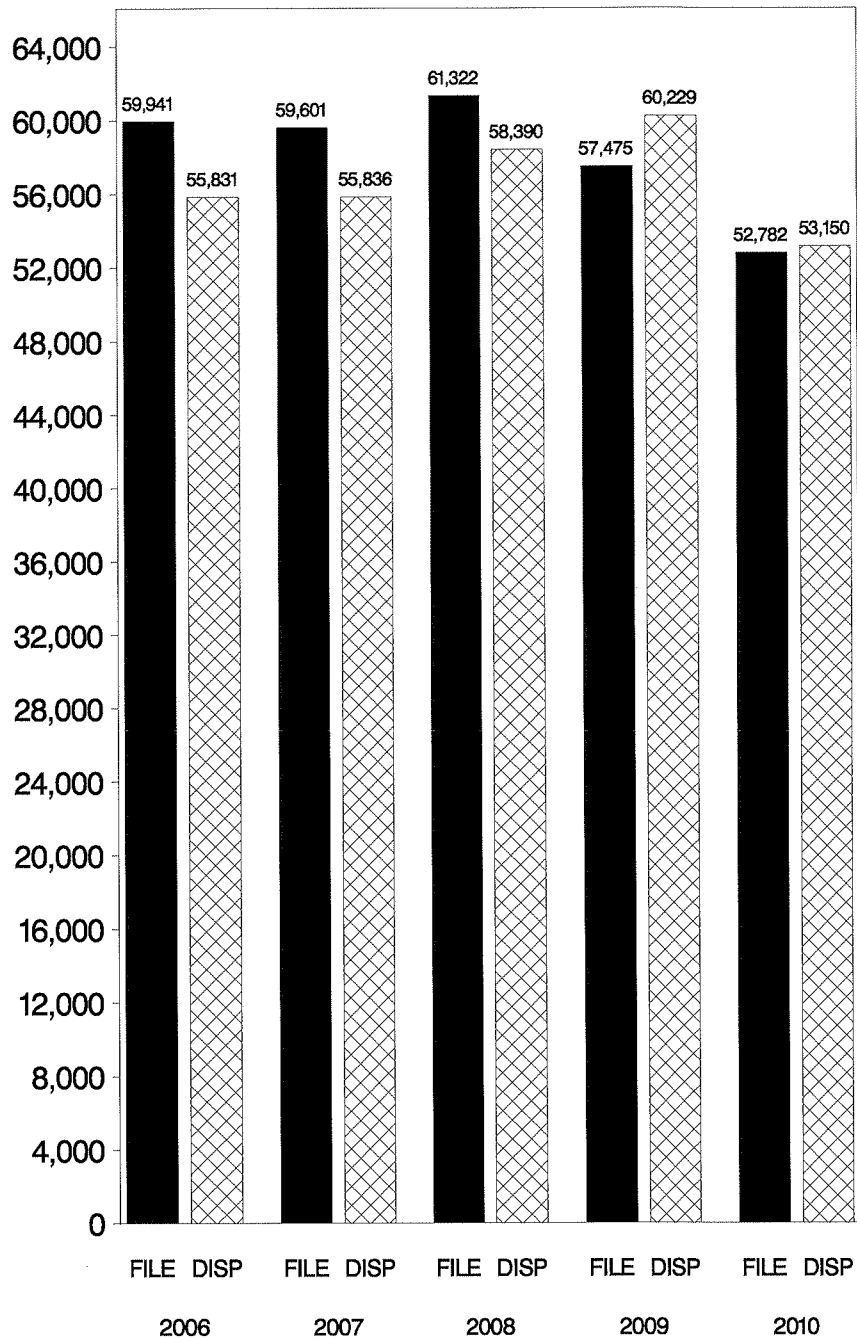

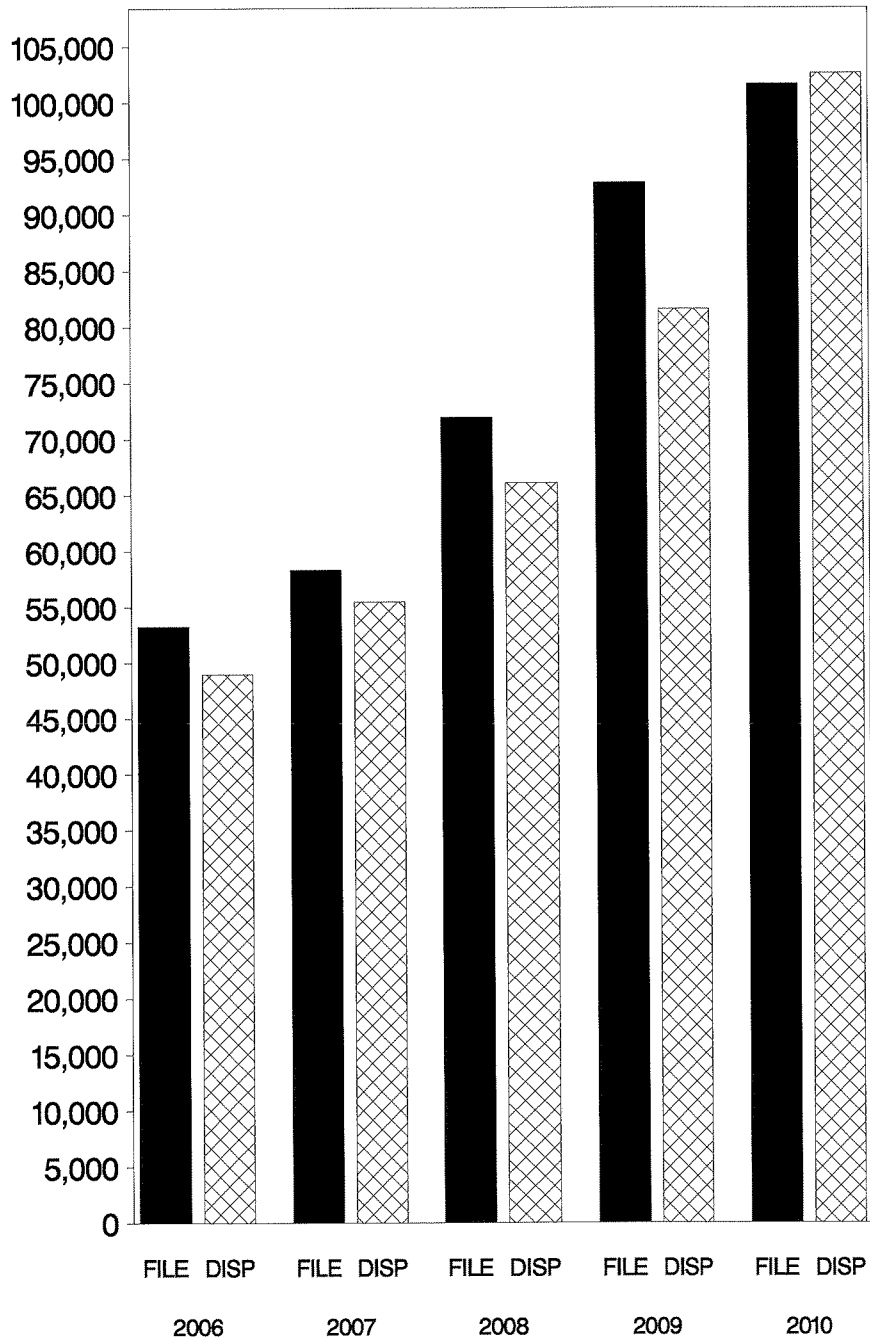

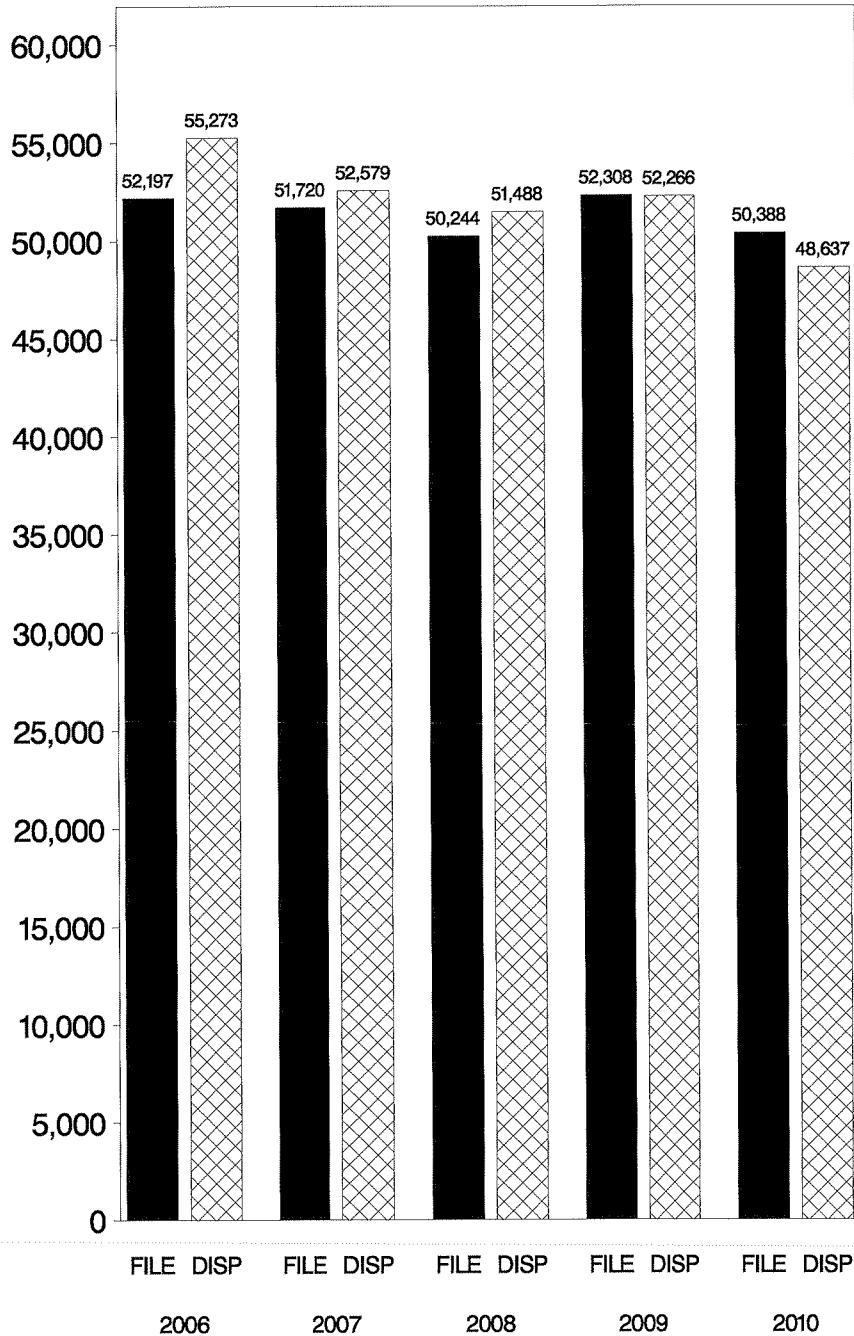
