

LIMITED JURISDICTION COURTS Narrative Summary

This section combines data from both Justice of the Peace and Municipal Courts and presents them statewide and by county. These data are intended for users who are concerned only with types of limited jurisdiction cases, irrespective of the specific court in which they occurred. Justice of the Peace and Municipal Courts are examined individually in subsequent sections.

Total filings (including transfers in) decreased 9.4% in FY 2011, from 2,355,282 last year to 2,134,685. Traffic cases comprised the majority (67.8%) of the filings in Limited Jurisdiction Courts. Total traffic filings (criminal and civil) decreased by 11.3%, from 1,632,026 last year to 1,447,037 in FY 2011. Criminal filings (misdemeanors and felonies) decreased by 9.5%, from 365,104 in FY 2010 to 330,345 in FY 2011.

Petitions for orders of protection in domestic violence cases decreased from 22,598 in FY 2010 to 22,295 in FY 2011, a decrease of 1.3%. Petitions for injunctions against harassment decreased, from 17,139 in FY 2010 to 15,620 in FY 2011, a decrease of 8.9%. Only 13.7% of the orders of protection and 21.5% of the harassment petitions ruled upon were denied.

Total dispositions (including transfers) decreased by 7.1%, from 2,526,738 last year to 2,346,312 in FY 2011. Traffic dispositions (criminal and civil) decreased by 10.2% while criminal dispositions (misdemeanor and felony) increased by 2.6% from last year.

The total pending caseload figure decreased from 1,538,236 in FY 2010 to 1,484,939 in FY 2011, a decrease of 3.5%. Most of the decrease was in the misdemeanor category, which decreased from 766,909 in FY 2010 to 737,431 in FY 2011, a decrease of 3.8%. The criminal traffic category also decreased, from 252,857 in FY 2010 to 236,941 in FY 2011, which was a decrease of 6.3%.

NOTE: Some of the FY 2010 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.

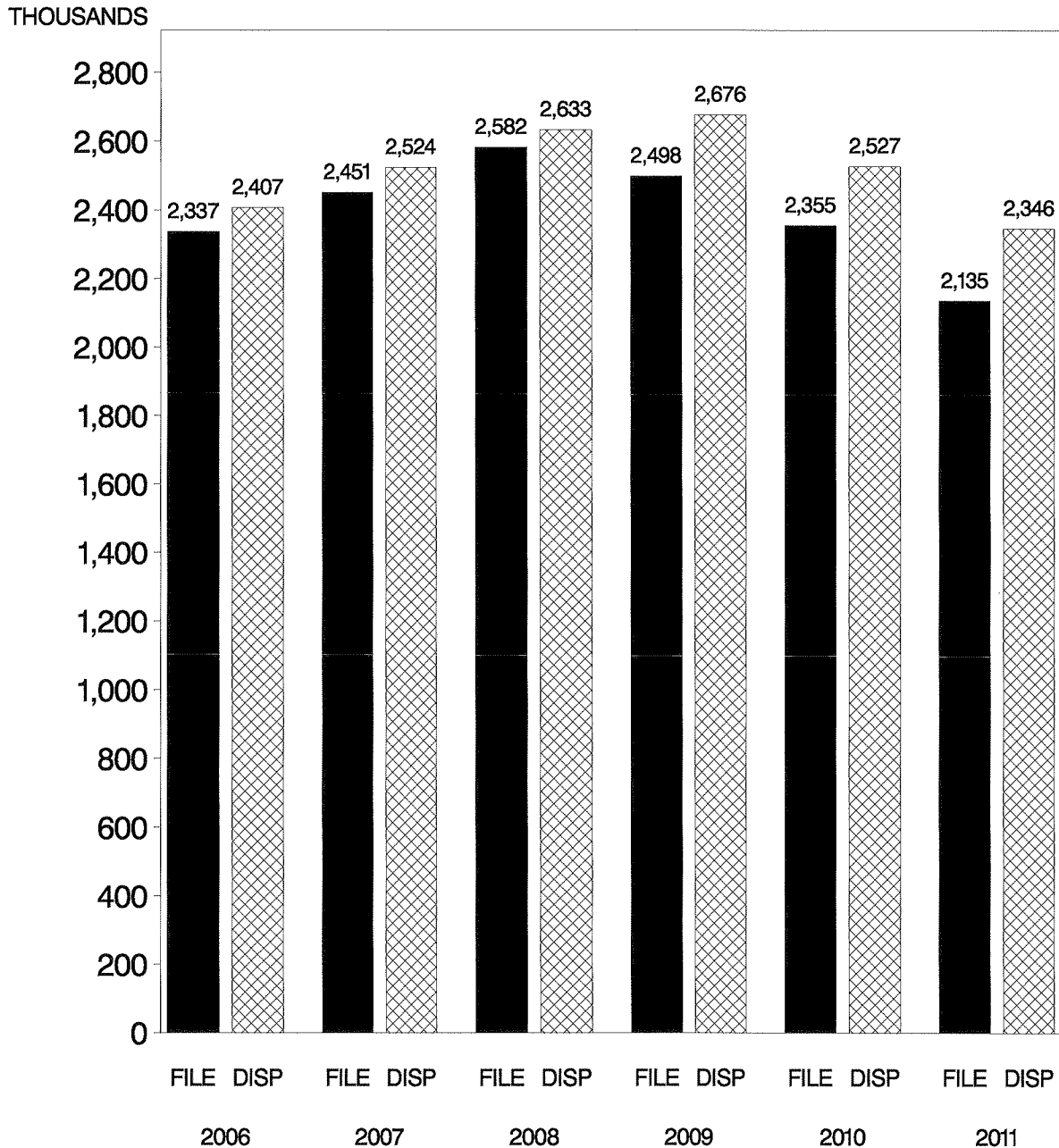

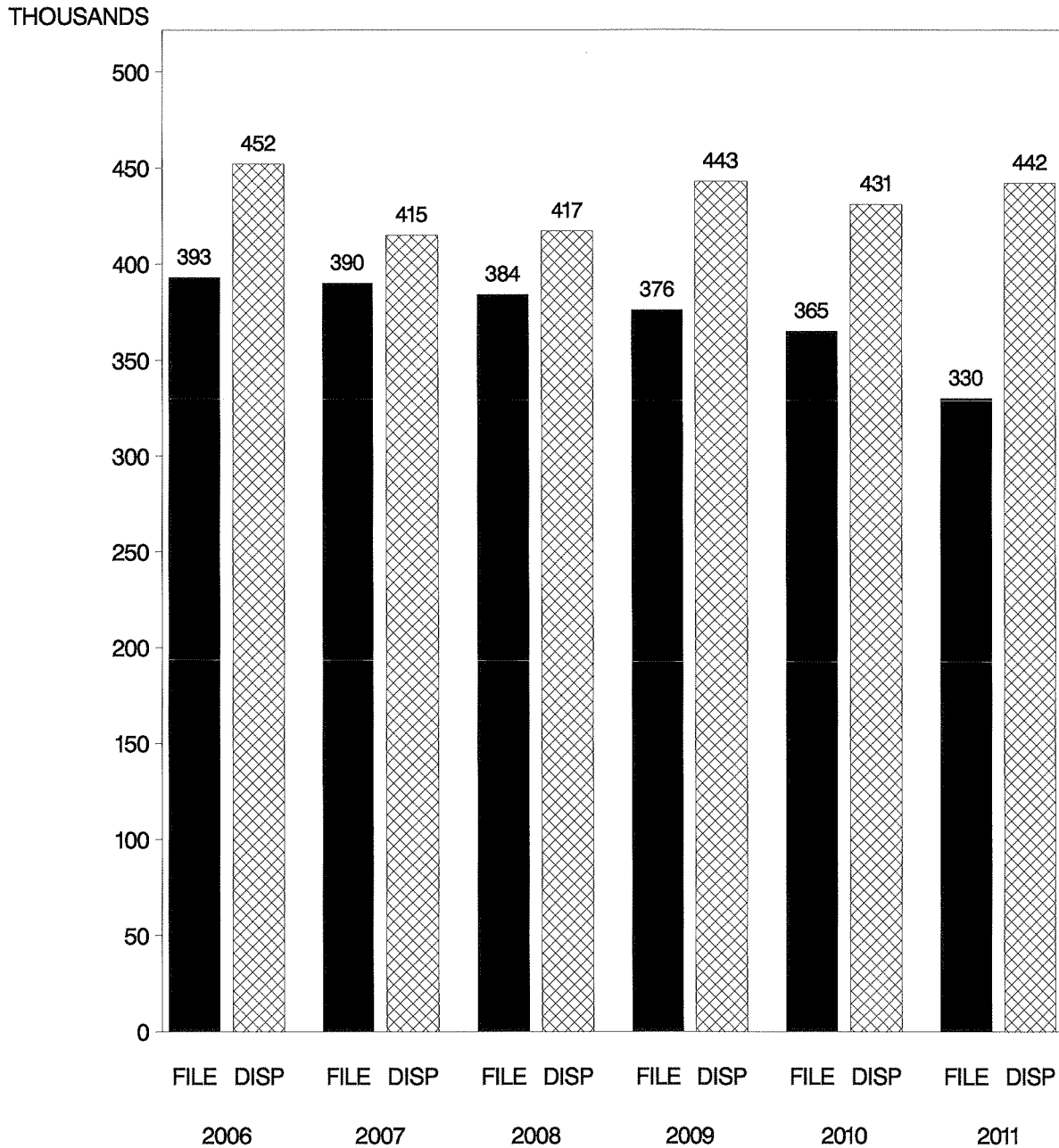

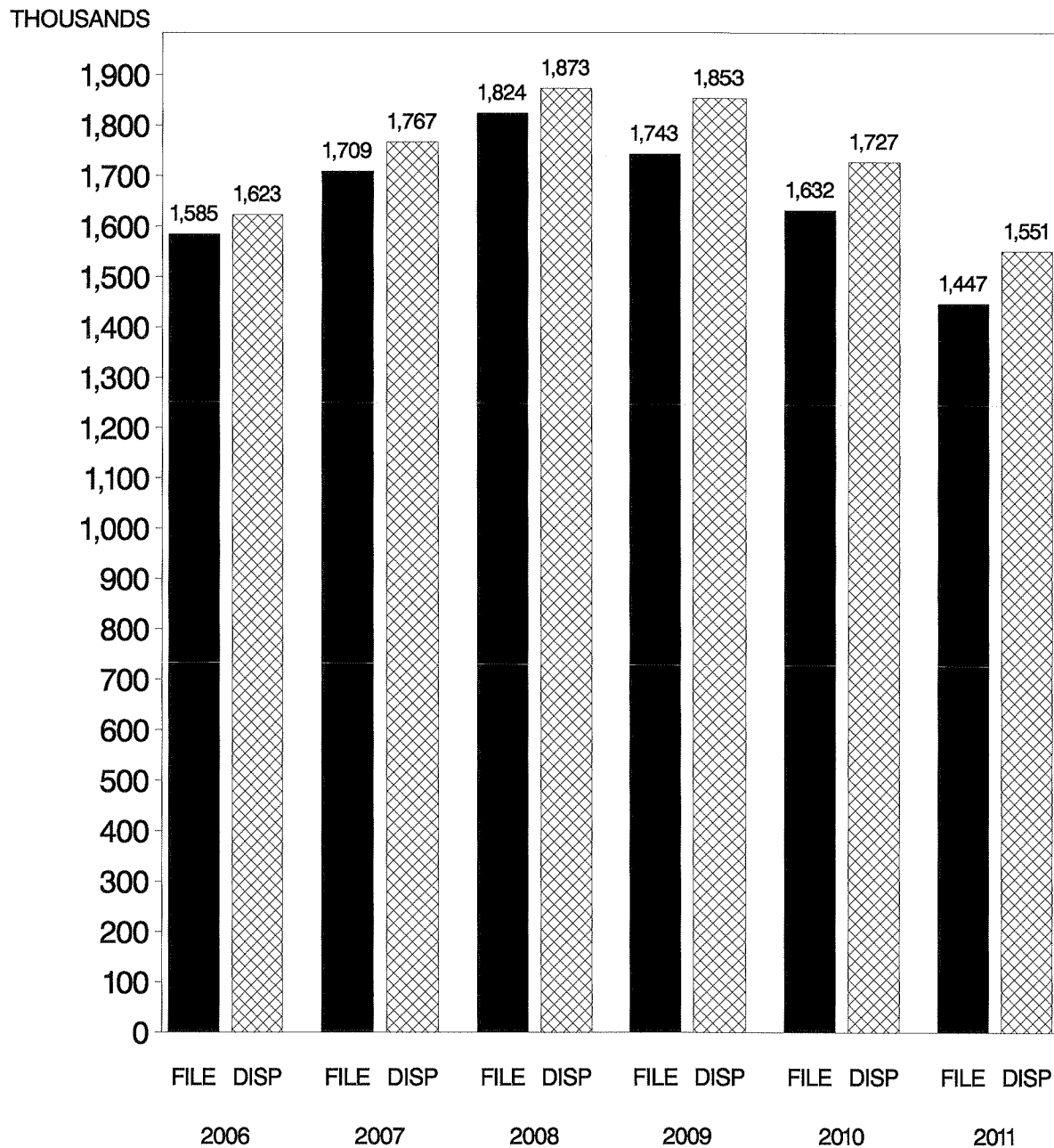

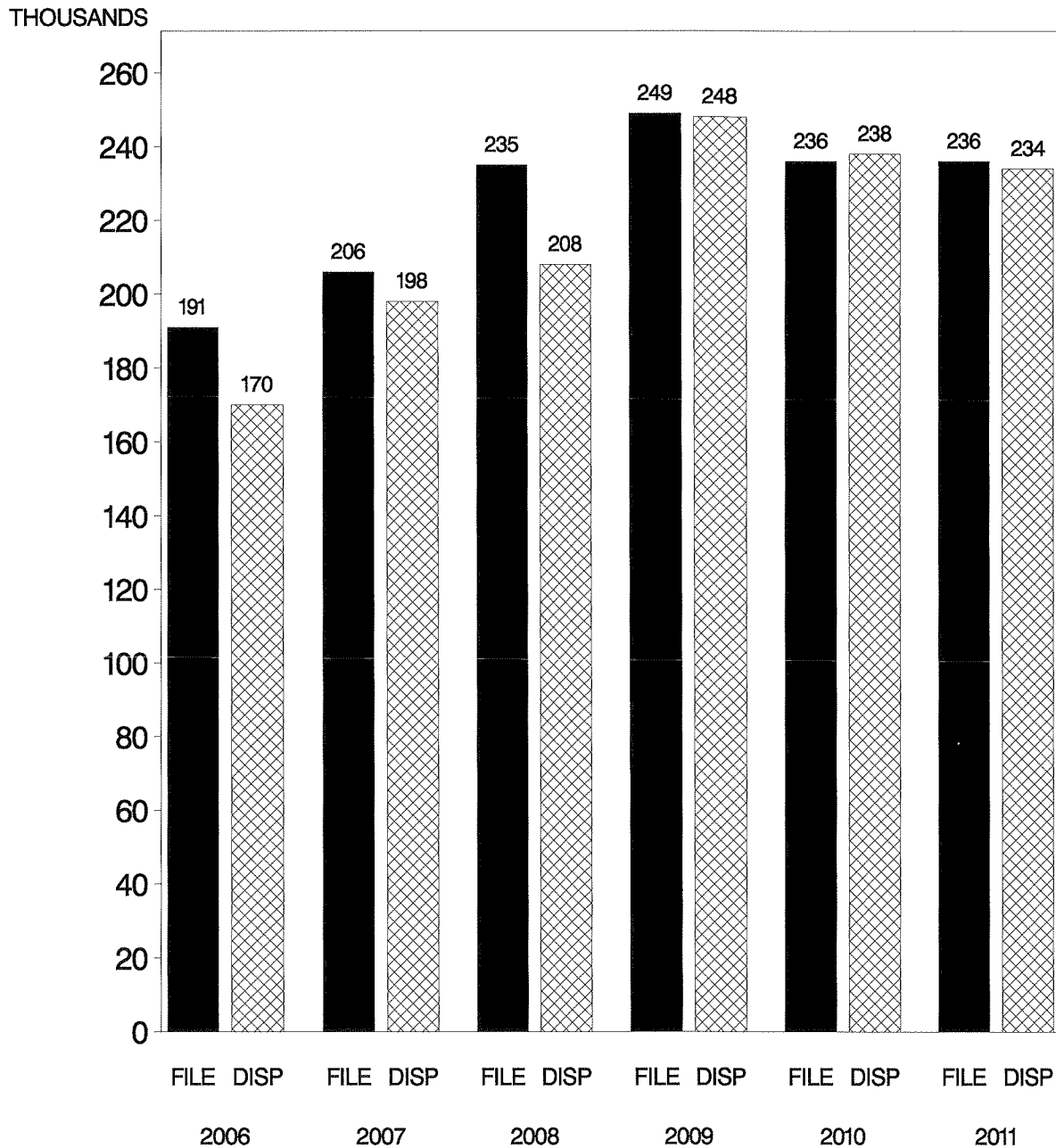

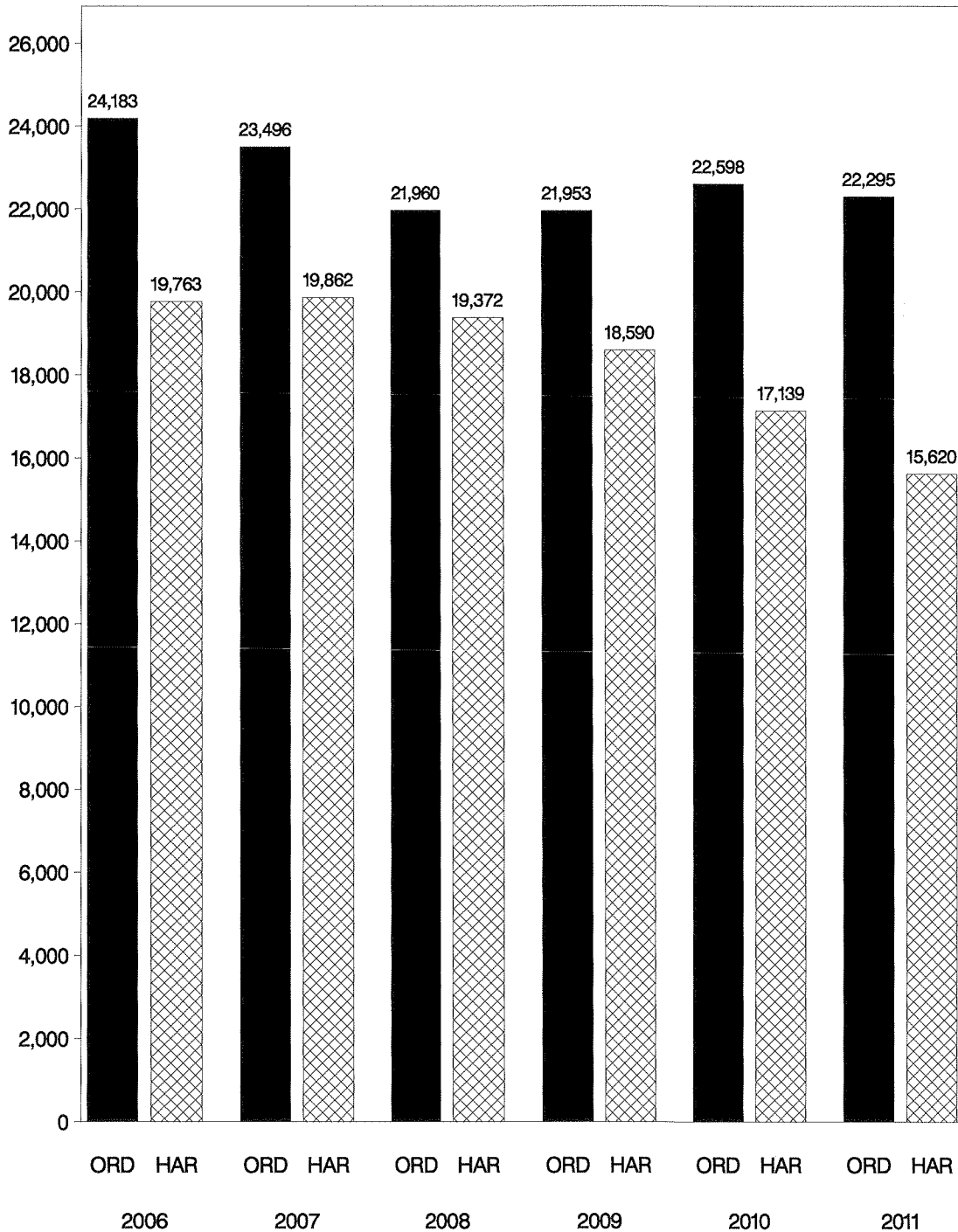
