Limited Jurisdiction Courts Narrative Summary

The limited jurisdiction summary illustrates all court positions in Justice of the Peace and Municipal Courts as of June 30, 2011 including positions funded from both primary and non-primary budget sources. The information was reported by the individual courts in response to the Supreme Court personnel survey which was electronically distributed in July 2011.

The total number of persons working full-time in the Limited Jurisdiction Courts decreased by 1.6%, from 1,843 in FY 2010 to 1,813 in FY 2011. In FY 2011, there were 797 people employed full-time in the Justice Courts, compared with 795 the previous year. Full-time employees in the Municipal Courts decreased from 1,048 the previous fiscal year to 1,016 in FY 2011.

The Limited Jurisdiction Courts employed an additional 532 part-time personnel in FY 2011, compared to 553 in FY 2010, a decrease of 3.8%. The Justice Courts employed 150 part-time personnel, versus 137 the previous fiscal year. The Municipal Courts employed 382 part-time personnel, compared to 416 in FY 2010.

The Limited Jurisdiction Courts also received assistance from 35 regular volunteers in FY 2011. Volunteers include non-professionals and professionals who serve in various capacities, from support staff to on-call magistrates. The Justice Courts utilized 10 regular volunteers while the Municipal Courts received assistance from 25 volunteers.

Additionally, the Limited Jurisdiction Courts utilized 24,843 hours of temporary personnel assistance in FY 2011. The Justice Courts used 14,313 hours of temporary personnel, while the Municipal Courts used 10,530 hours.

Some of the FY 2010 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the report.
