Limited Jurisdiction Courts Narrative Summary

The revenue data provided here are for the Limited Jurisdiction Courts of Arizona. The figures were compiled from quarterly revenue surveys submitted to the Supreme Court during fiscal year 2011. Major revenue categories shown represent monies collected from four sources:

FINES, SANCTIONS, FORFEITURES: Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that were forfeited;

SURCHARGES: Revenue from monetary assessments authorized by statute above and beyond criminal and traffic penalties and certain civil and other fees;

FEES: Revenue from collectible fees for services of the court and chargeable aspects of case processing;

OTHER REVENUE: Revenue from sources not otherwise specified.

Total revenue collected by Limited Jurisdiction Courts decreased from \$327,882,461 in FY 2010 to \$307,760,299 in FY 2011, a decrease of 6.1%. Justice Court revenue decreased from \$140,176,869 last year to \$119,013,294 in FY 2011, down 15.1%. Most of the decrease occurred in the DPS Photo enforcement where revenue dropped from \$23,743,252 in FY 2010 to \$5,958,520 in FY 2011. Municipal Court revenue went from \$187,705,592 in FY 2010 to \$188,747,005 in FY 2011, a slight increase of 0.6%.

The fines category is the largest at \$123,745,782, accounting for 40.2% of the total. Most of these fines (\$78,469,225 or 63.4%) were assessed in Municipal Courts. The second largest category is surcharges, accounting for \$88,809,631, or 28.9% of the total revenue. Again, the majority of the surcharges were assessed in Municipal Courts (\$56,640,894 or 63.8%).

Maricopa and Pima County Justice Courts comprise 60.4% of all Justice Court revenue. Municipal Courts from these two counties constitute 84.0% of all Municipal Court revenue. The two largest Municipal Courts--Phoenix and Tucson--not only account for 37.4% of all Municipal Court revenue, but 22.9% of the revenue from all Arizona Limited Jurisdiction Courts. In all, Maricopa and Pima County Limited Jurisdiction Courts collect 74.8% of all Justice and Municipal Court revenue.

The Annual Trust Money Collection Summary shows that the Limited Jurisdiction Courts processed \$26,907,598 in "pass-through" trust monies in FY 2011, most of which were for bail bonds.

Some of the FY 2010 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report. Revenue reports received from courts are checked for mathematical accuracy, but are not audited by the Supreme Court.
