

SUPERIOR COURT Narrative Summary

Total filings (including transfers in) were down by 3.4%, from 243,663 in FY 2010 to 235,386 this fiscal year. Superior Court's second largest category, criminal filings, experienced a decrease of 4.1%, from 53,271 in FY 2010 to 51,066 in FY 2011. The largest category, civil filings increased by 3.7%, from 101,591 in FY 2010 to 97,856 in FY 2011. Domestic relations filings decreased by 1.8%, from 50,388 in FY 2010 to 49,493 in FY 2011. These three categories account for 84.3% of the total filings in Superior Court.

Prior to 1996, petitions for orders of protection and injunctions against harassment in Superior Court were reported together under domestic violence petitions. In FY 2011, these petitions together increased by 5.2 %, from 14,712 in FY 2010 to 15,473 in FY 2011. Separately, orders of protection were up by 7.3% from FY 2010 while injunctions against harassment decreased by 3.1% in FY 2011. Juvenile delinquent and incorrigible filings decreased, from 15,423 to 13,664 or 11.4%.

Total dispositions (including transfers) were up slightly from 244,385 in FY 2010 to 244,572 in FY 2011, an increase of 0.1%. Domestic relations dispositions experienced an increase of 2.3%, from 48,637 in FY 2010 to 49,768 in FY 2011. Civil dispositions increased by 2.5%, from 100,390 in FY 2010 to 102,922 in FY 2011. Criminal dispositions increased by 1.5% in FY 2011, from 53,558 in FY 2010 to 54,372 in FY 2011. These three categories account for 84.7% of the dispositions in Superior Court.

Total end of year pending cases showed a decrease of 7,812 or 3.5%, from 220,313 in FY 2010 to 212,501 in FY 2011.

Data for all counties except Maricopa, Pima and Pinal were estimated for FY2011 due to the transition from the AZTEC case management system to the new case management system called AJACS (Arizona Judicial Automated Case System).

A third page contains information regarding the disposition of criminal defendants and appeals from Limited Jurisdiction Courts.

In 1996, two additional categories were added to the Superior Court report, Adult Adoption, previously reported in the probate category, and Mental Health. In this report, criminal filings and juvenile petition statistics represent the number of persons; all other statistics represent cases.

Some of the FY 2010 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.

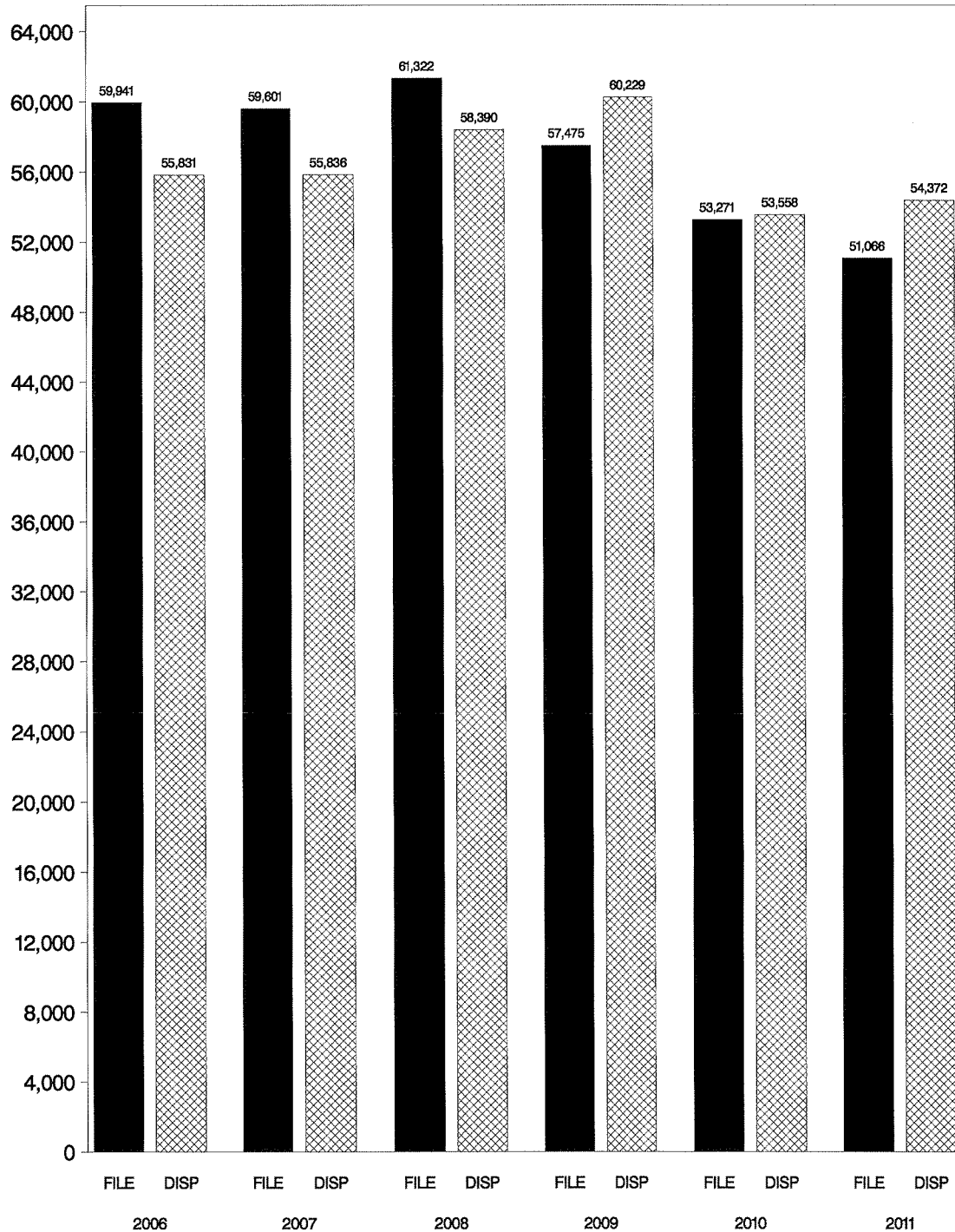

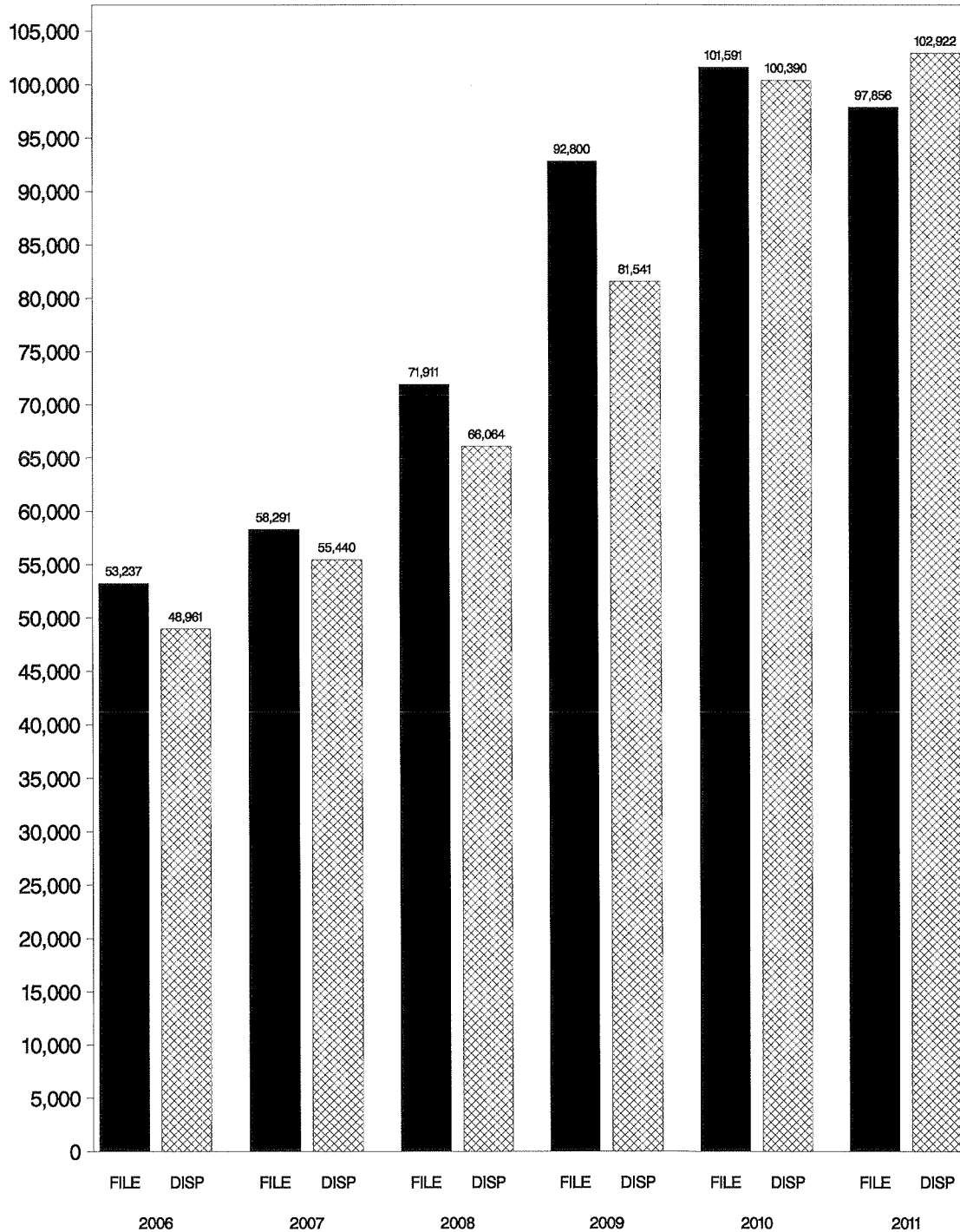

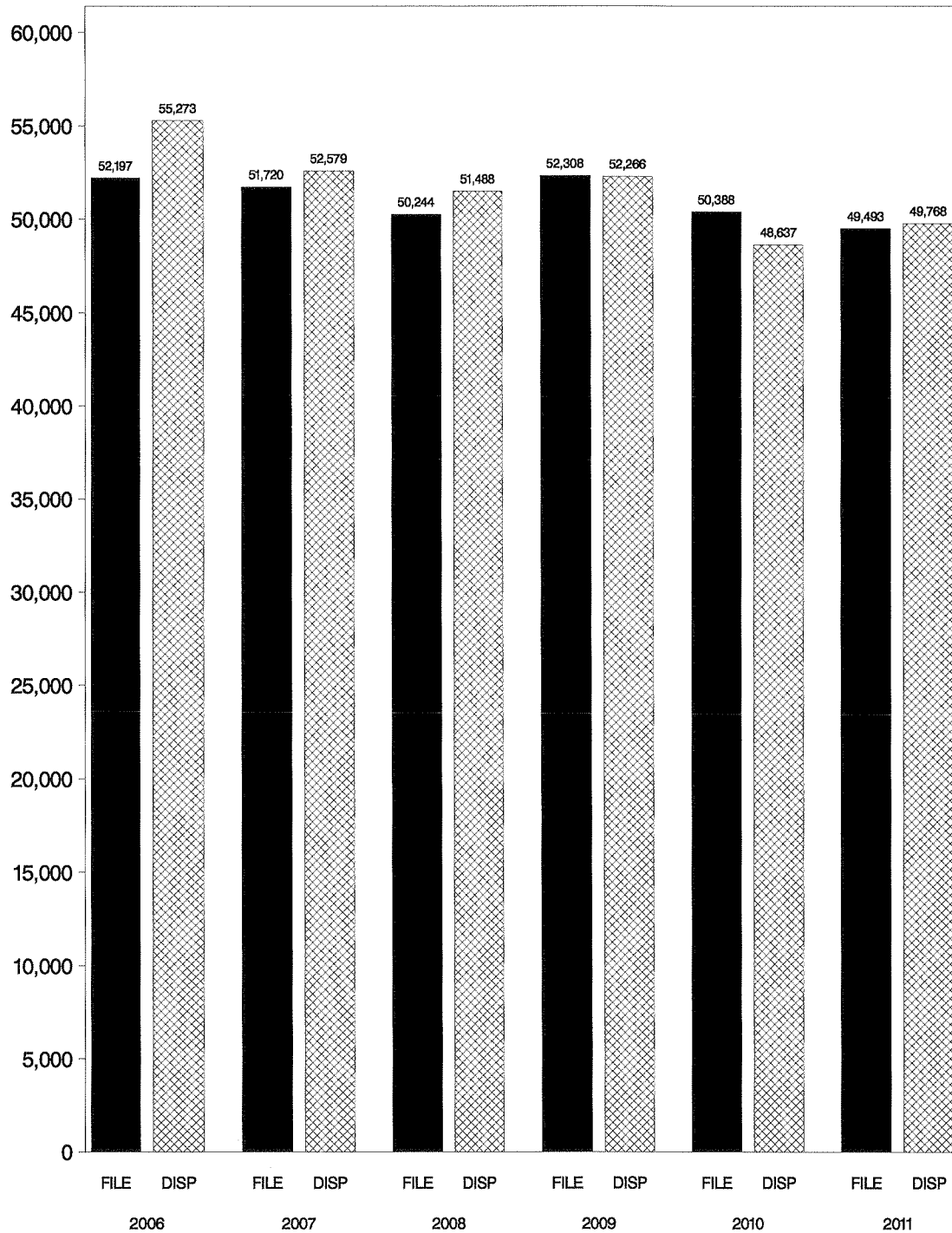
