Limited Jurisdiction Courts Narrative Summary

The limited jurisdiction summary illustrates all court positions in Justice of the Peace and Municipal Courts as of June 30, 2012 including positions funded from both primary and non-primary budget sources. The information was reported by the individual courts in response to the Supreme Court personnel survey which was electronically distributed in July 2012.

The total number of full-time positions in the Limited Jurisdiction Courts increased slightly from 1,813 in FY 2011 to 1,826 in FY 2012. In FY 2012, there were 818 full-time positions in the Justice Courts, compared with 797 the previous year. Full-time positions in the Municipal Courts decreased from 1,016 the previous fiscal year to 1,008 in FY 2012.

The Limited Jurisdiction Courts employed an additional 464 part-time personnel in FY 2012, compared to 532 in FY 2011, a decrease of 12.8%. The Justice Courts employed 128 part-time personnel, compared to 150 the previous fiscal year. The Municipal Courts employed 336 part-time personnel, compared to 382 in FY 2011.

The Limited Jurisdiction Courts also received assistance from 76 regular volunteers in FY 2012. Volunteers include non-professionals and professionals who serve in various capacities, from support staff to on-call magistrates. The Justice Courts utilized 7 regular volunteers while the Municipal Courts received assistance from 69 volunteers.

Additionally, the Limited Jurisdiction Courts utilized 33,647 hours of temporary personnel assistance in FY 2012. The Justice Courts used 14,625 hours of temporary personnel, while the Municipal Courts used 19,022 hours.

Some of the FY 2011 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the report.
