

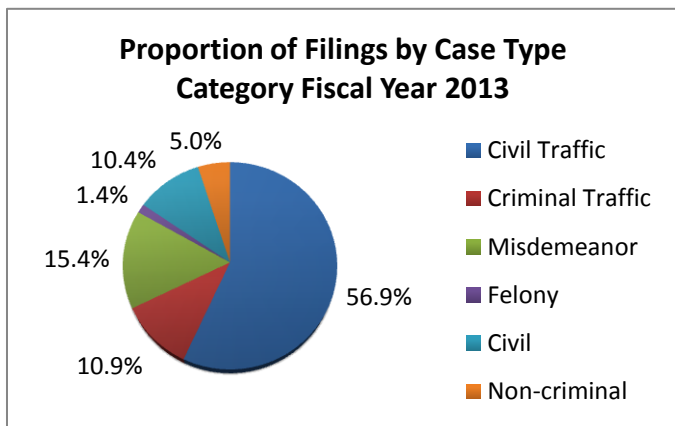
LIMITED JURISDICTION COURTS

Narrative Summary

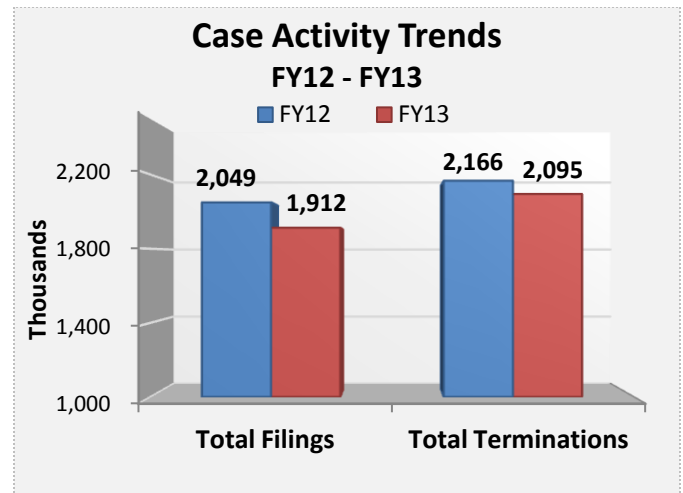
This section combines data from both Justice of the Peace and Municipal Courts and presents them statewide and by county. These data are intended for users who are concerned only with types of limited jurisdiction cases, irrespective of the specific court in which they occurred. Justice of the Peace and Municipal Courts are examined individually in subsequent sections.

Filings in limited jurisdiction courts decreased 6.7% from 2,049,029 in FY12 to 1,912,411 in FY13. The civil traffic category experienced the most significant numerical decrease, dropping 92,322 filings from 1,181,032 in FY12 to 1,088,710 in FY13. Non-Criminal cases had the most significant percentage decrease, dropping by 11,299 filings or 10.6%. Civil, Criminal traffic and misdemeanor categories also saw decreased filings of 8.0%, 4.4% and 3.5% respectively. Felony filings were the only case type category to increase in FY13, up 23.1% from 20,999 in FY12 to 25,859 in FY13.

Civil traffic cases make up more than half of all filings in the limited jurisdiction courts with 56.9%, or 1,088,710 filings. Misdemeanor, Criminal traffic and Civil case filings each account for 15.4%, 10.9% and 10.4% of the total filings, respectively. The smallest categories include non-criminal filings with 95,513 filings, or 5.0% and felony filings with 25,859 filings, or 1.4% of the total.

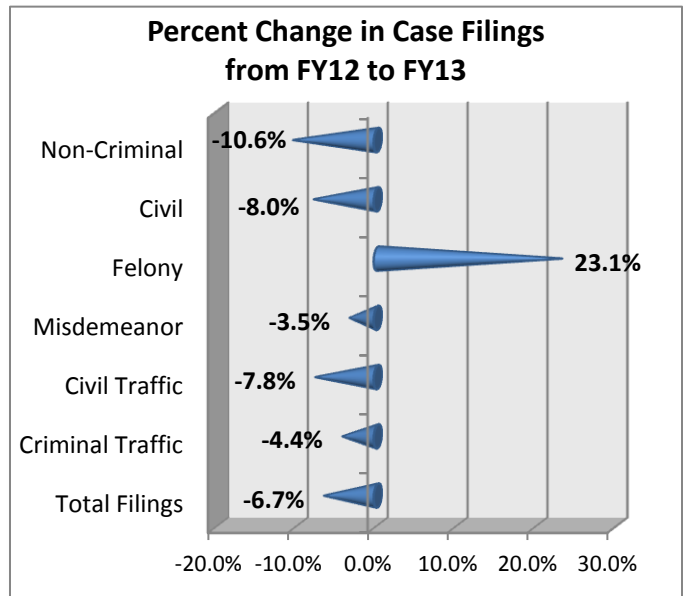


Statewide, limited jurisdiction courts terminated 2,094,676 cases during FY13, a 3.3% decrease over the 2,166,059 cases terminated the prior fiscal year. Terminations decreased across all case types except felony and non-criminal cases, which increased by 13.9% and 36.6% respectively. As of June 30, 2013, 1,326,951 cases were pending in the limited jurisdiction courts a decrease of 8.5% from the 1,450,240 cases pending on July 1, 2012.



Both petitions for Orders of protection and injunctions against harassment decreased from FY12 to FY13. Petitions for orders of protection decreased 1.5% from 22,467 in FY12 to 22,124 in FY13. Petitions for injunctions against harassment decreased from 14,320 in FY12 to 13,812 in FY13, a decrease of 3.5%. Statewide, 8.5% of orders of protection are issued and 7.5% of injunctions against harassment are issued. An additional 5,709 order of protection review hearings and 3,002 injunctions against harassment review hearings were held during FY13.

Limited jurisdiction courts held 11,306 court trials and 950 jury trials during FY13. Of the trials held during FY13, 19.1% were for criminal traffic, 37.8% were for misdemeanor and 43.1% were for civil cases. As of June 30, 2013, 448,713 warrants were outstanding in the limited jurisdiction courts. Of those warrants, 231,112 were for criminal traffic violations and 217,601 were for criminal violations (misdemeanor or felony).

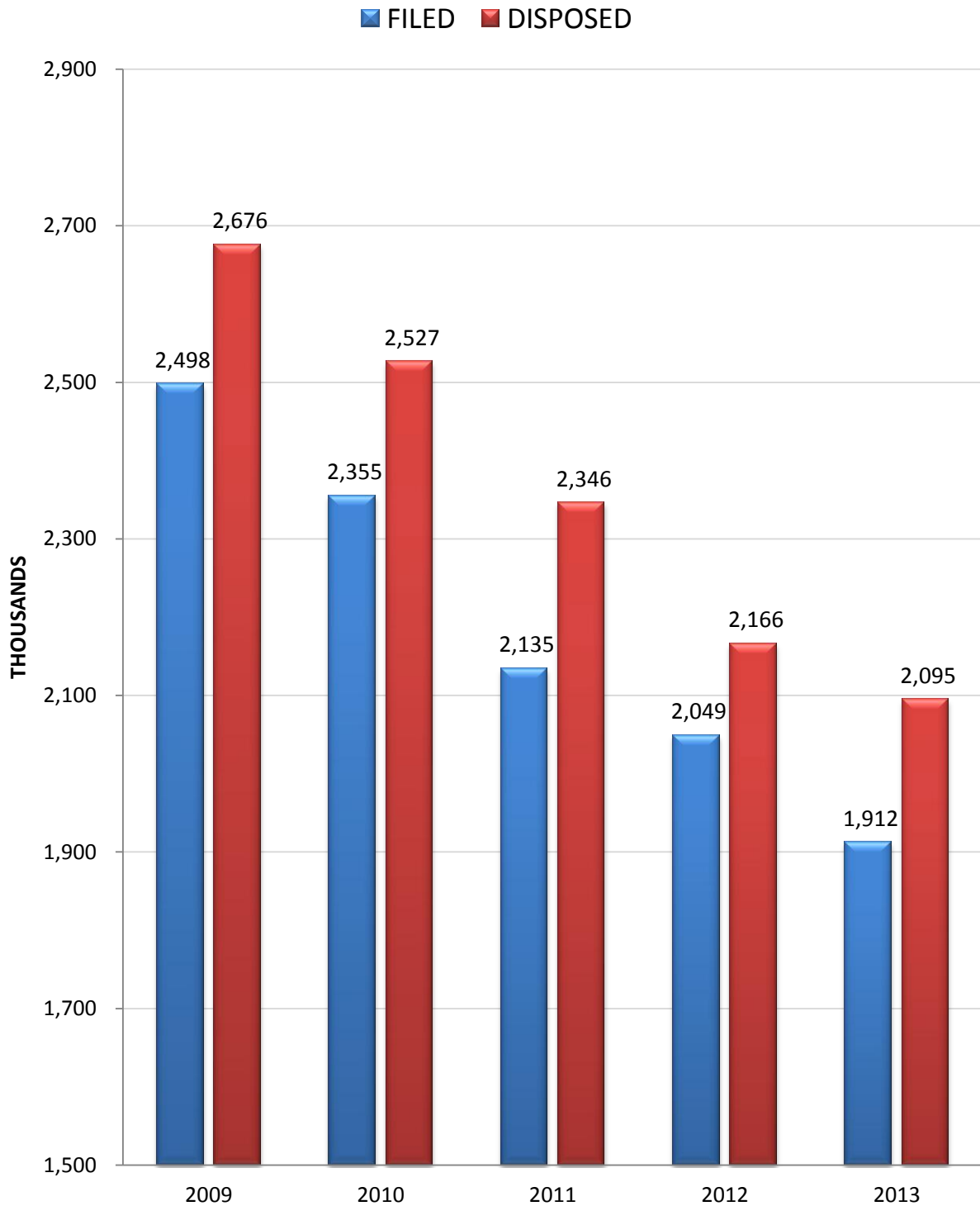

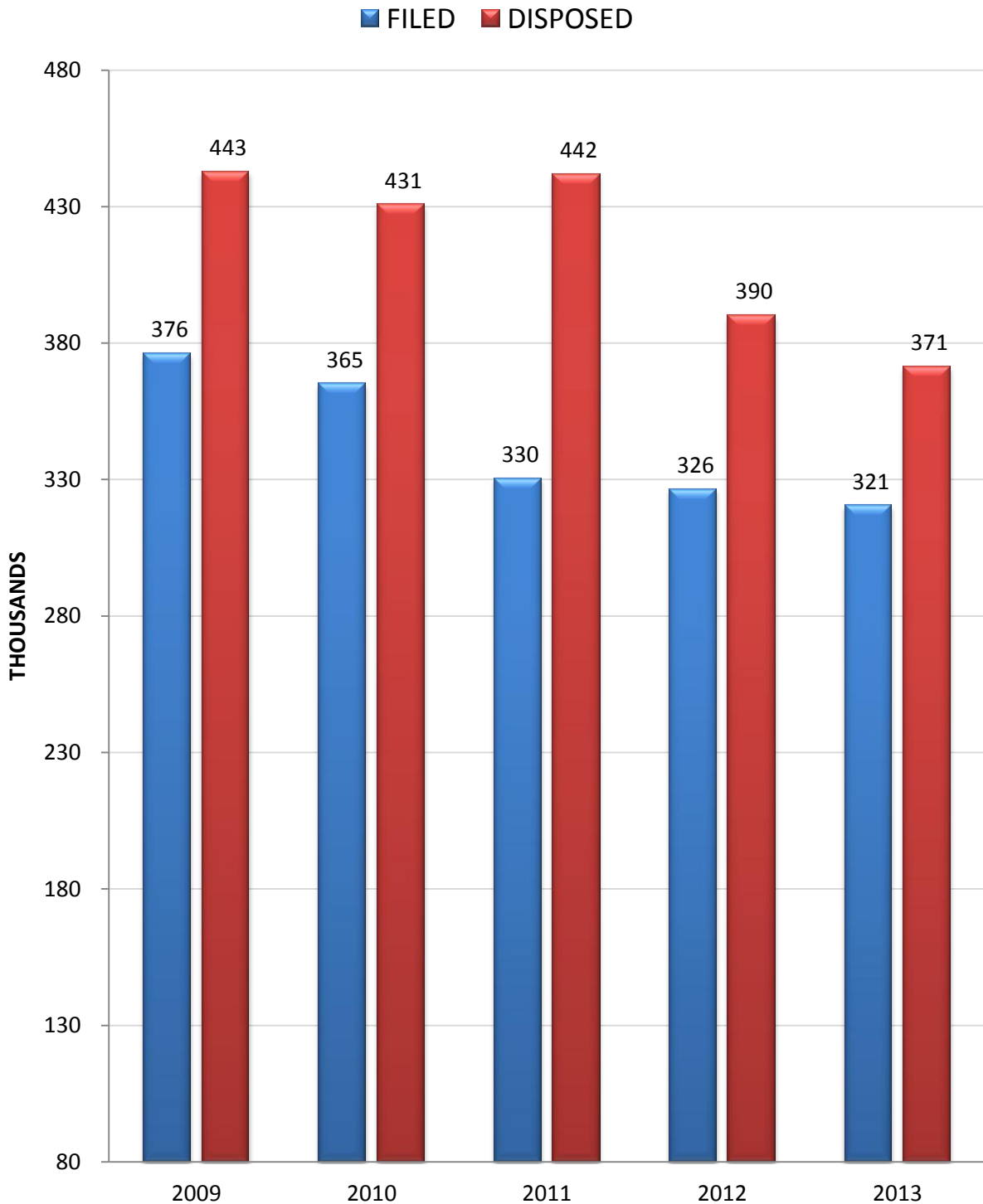
COMBINED ANNUAL CASE ACTIVITY, FY 2009 - 2013

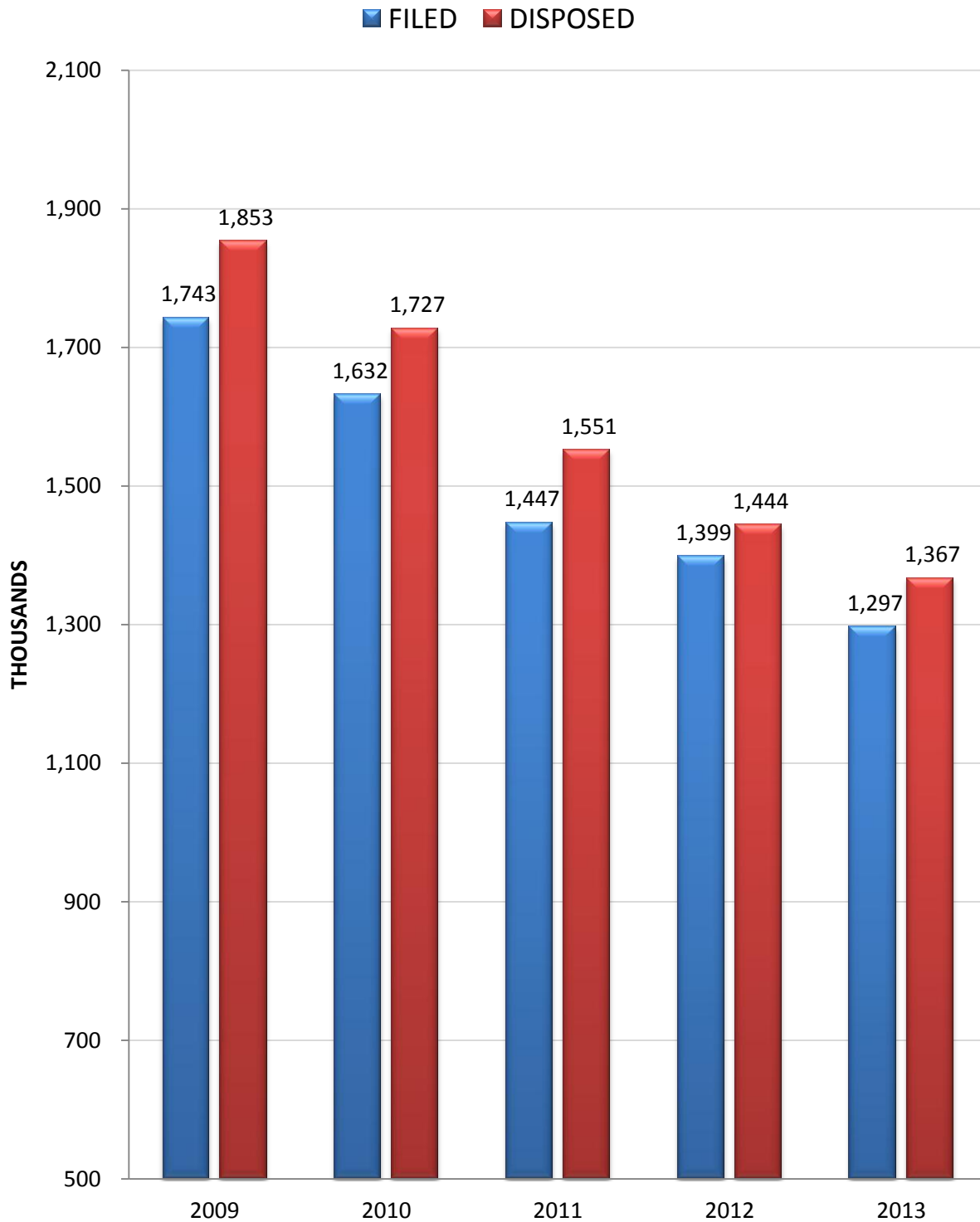

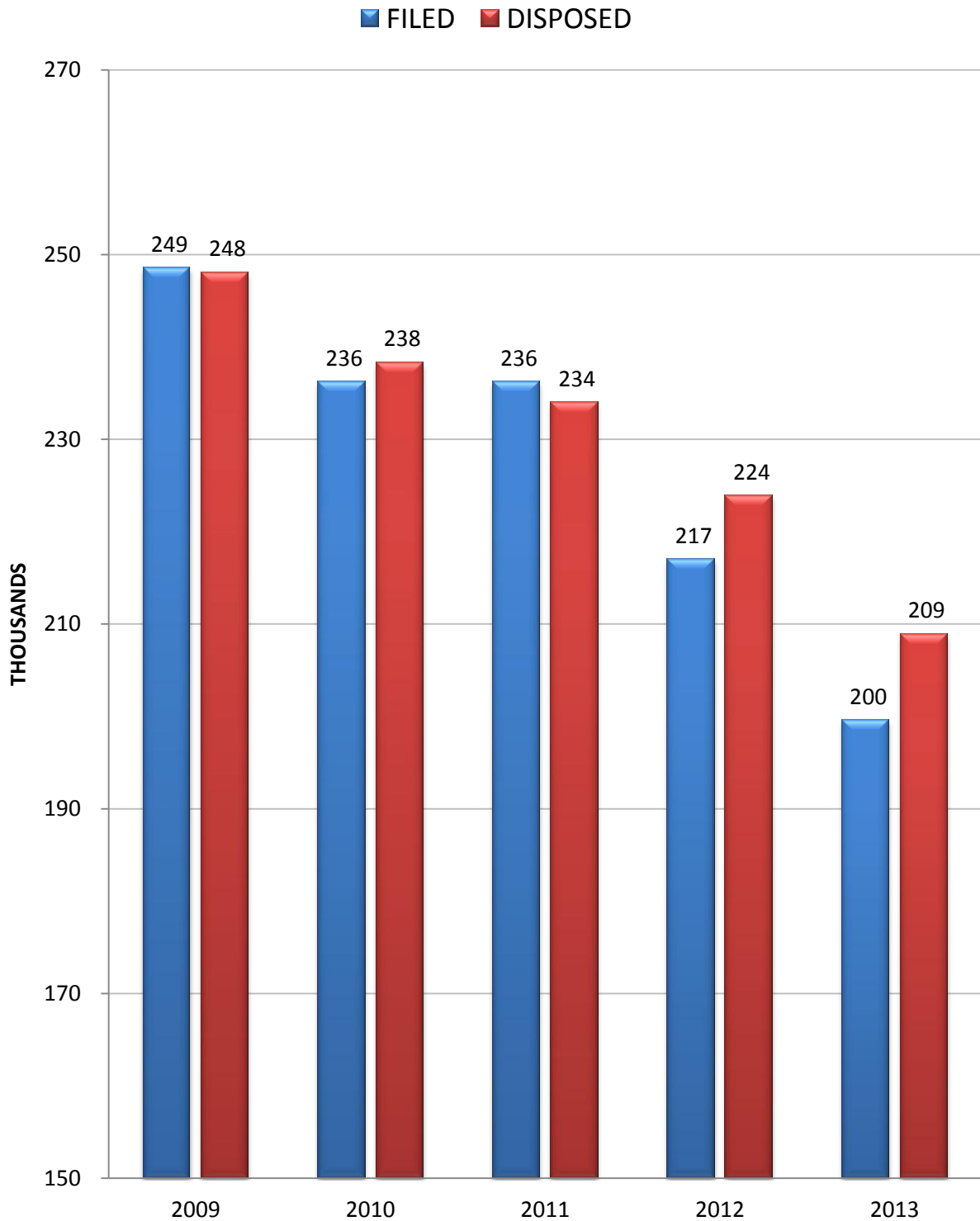

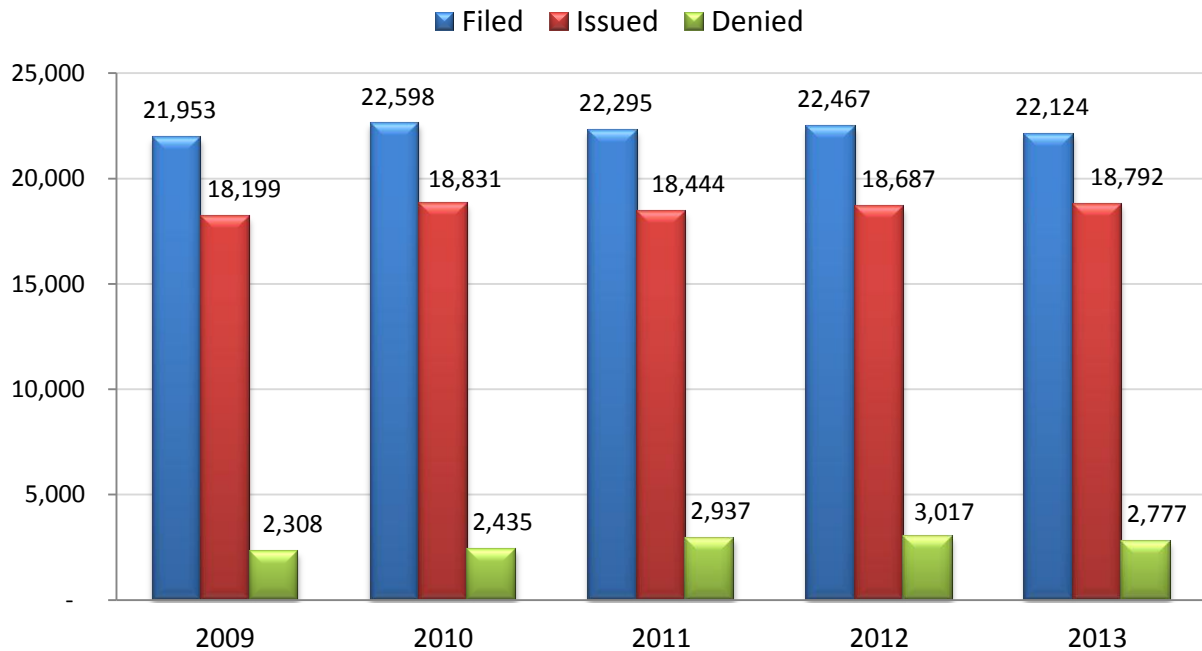
CIVIL CASE ACTIVITY, FY 2009 - 2013

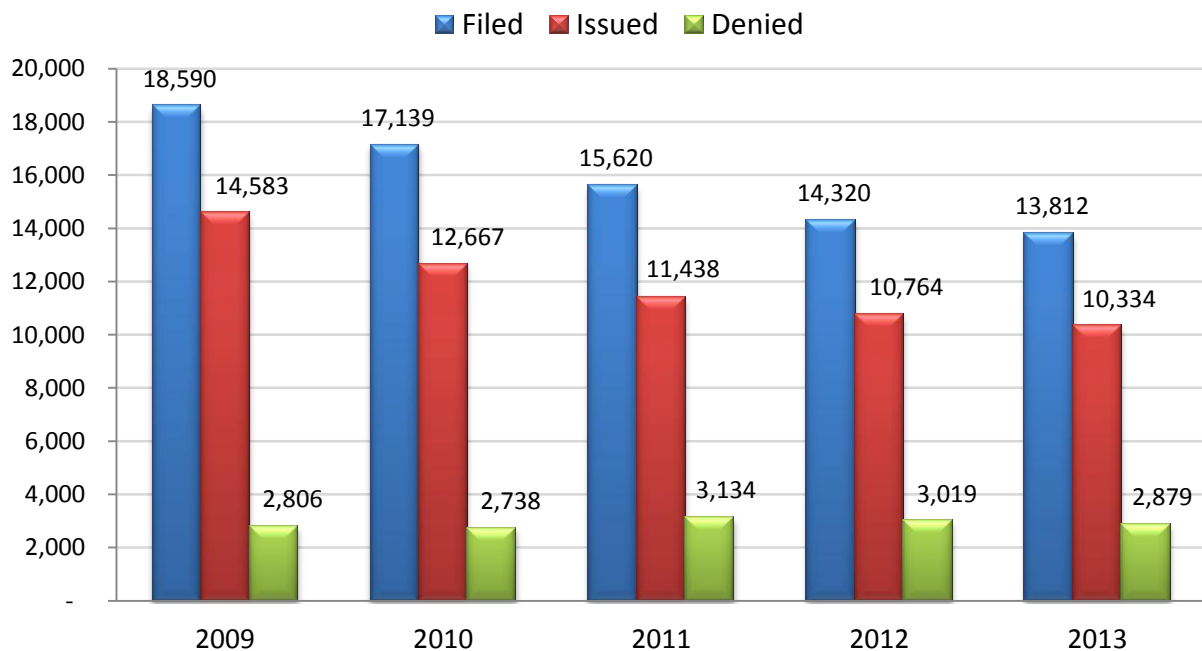
