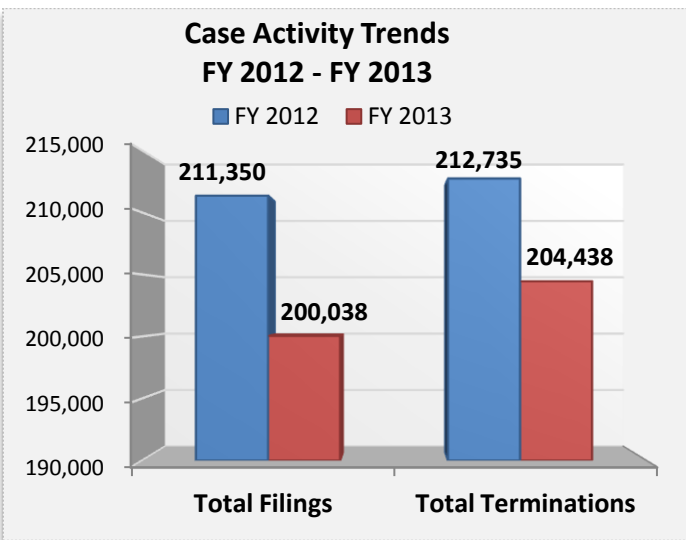
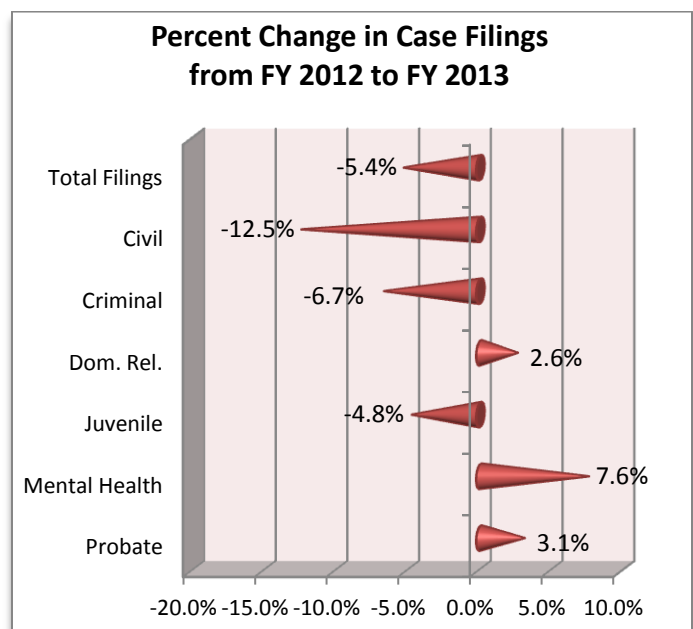
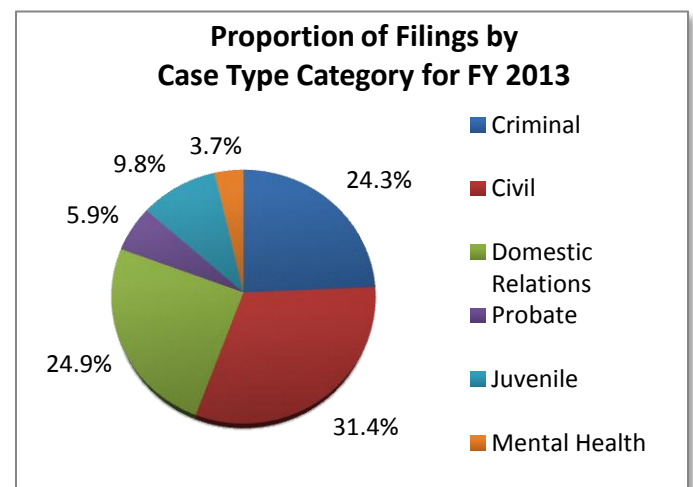
The Superior Court is the state's general jurisdiction trial court. Arizona's Superior Court has 15 branches, one for each county in the state. Superior Court has jurisdiction over all cases except small claims, petty offenses and violations of city ordinance/codes. The Superior Court also acts as an appellate court for justice and municipal courts.

Total filings (including transfers in) were down by 5.4%, from 211,350 in FY 2012 to 200,038 this fiscal year. Superior Court's largest category, civil filings, experienced a decrease of 12.5%, from 71,722 in FY 2012 to 62,770 in FY 2013. The second largest category, domestic relations filings, increased by 2.6% from 48,594 in FY 2012 to 49,860 in FY 2013. Criminal filings decreased by 6.7%, from 52,159 in FY 2012 to 48,654 in FY 2013. These three categories account for 80.6% of the total filings in Superior Court.

In FY 2013, filings for orders of protection and injunctions against harassment together decreased by 4.1%, from 15,753 in FY 2012 to 15,109 in FY 2013. Separately, orders of protection were down by 6.5% from FY 2012 while injunctions against harassment were up 6.6%. Superior Court held 4,270 review hearings during FY 2013 for both orders of protection and injunctions against harassment.

Total end of year pending cases decreased 1.9% from 208,894 in FY 2012 to 205,011 in FY 2013. The mental health category experienced a 35.0% increase in the pending caseload while the juvenile category increased by 8.4%. The remaining categories including; criminal, civil, domestic relations and probate, all experienced decreased pending caseloads from FY 2012 to FY 2013.

The Superior Court held 4,816 trials during FY 2013. Domestic relations trials account for 68.0% of the total trials held, while criminal trials make up the second largest category with 23.8%. Of the total trials held, 1,274 or 26.5% were jury trials.



Total dispositions (including transfers) decreased from 212,735 in FY 2012 to 204,438 in FY 2013, a decrease of 3.9%. Civil dispositions decreased by 14.3%, from 76,008 in FY 2012 to 65,148 in FY 2013. Domestic relations experienced an increase of 5.3% in dispositions, from 47,733 in FY 2012 to 50,259 in FY 2013. Criminal dispositions decreased by 4.3%, from 52,018 in FY 2012 to 49,782 in FY 2013. These three categories account for 80.8% of dispositions in Superior Court.

Data for all counties except Maricopa and Pima were estimated for FY 2013 due to the transition from the AZTEC case management system to the new case management system called AJACS (Arizona Judicial Automated Case System).

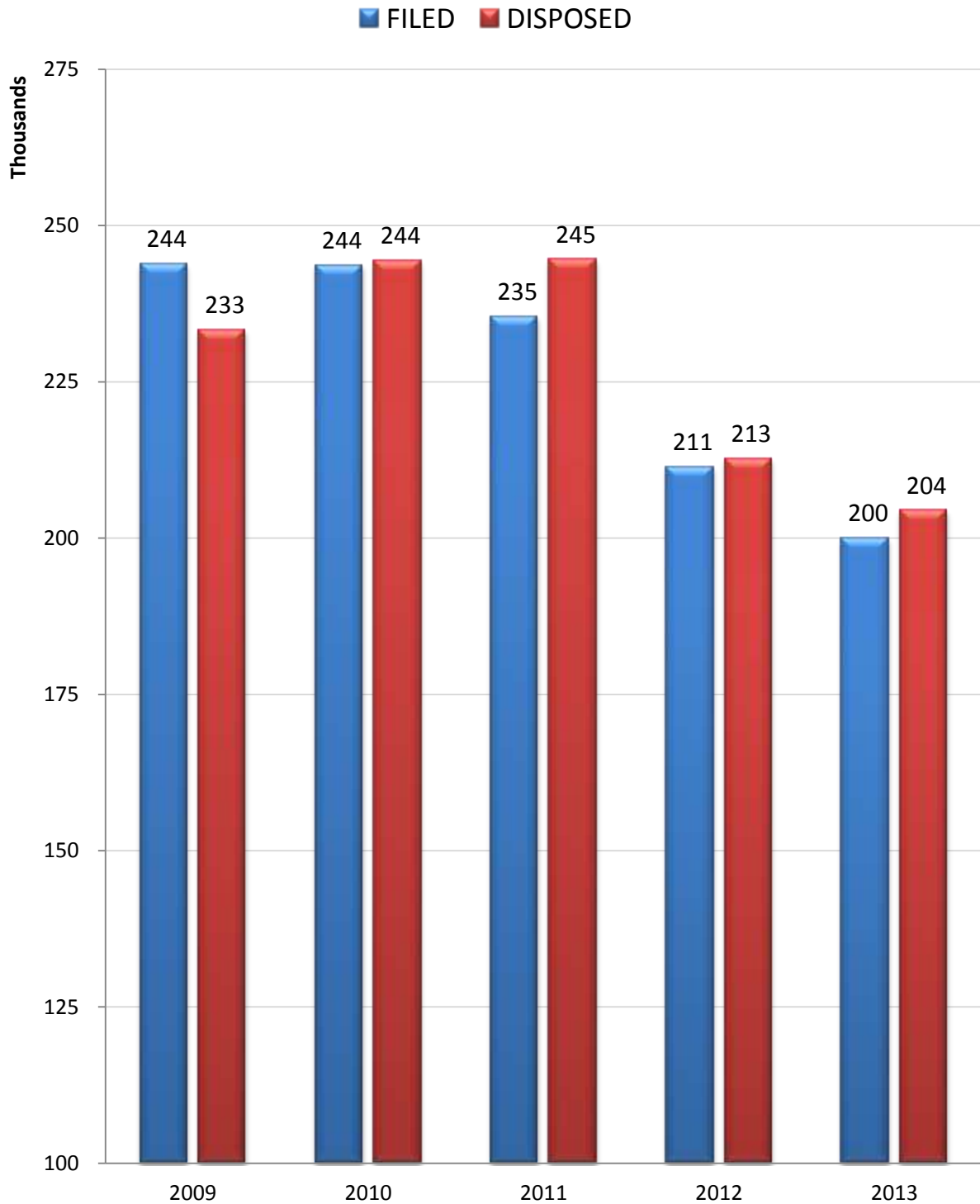

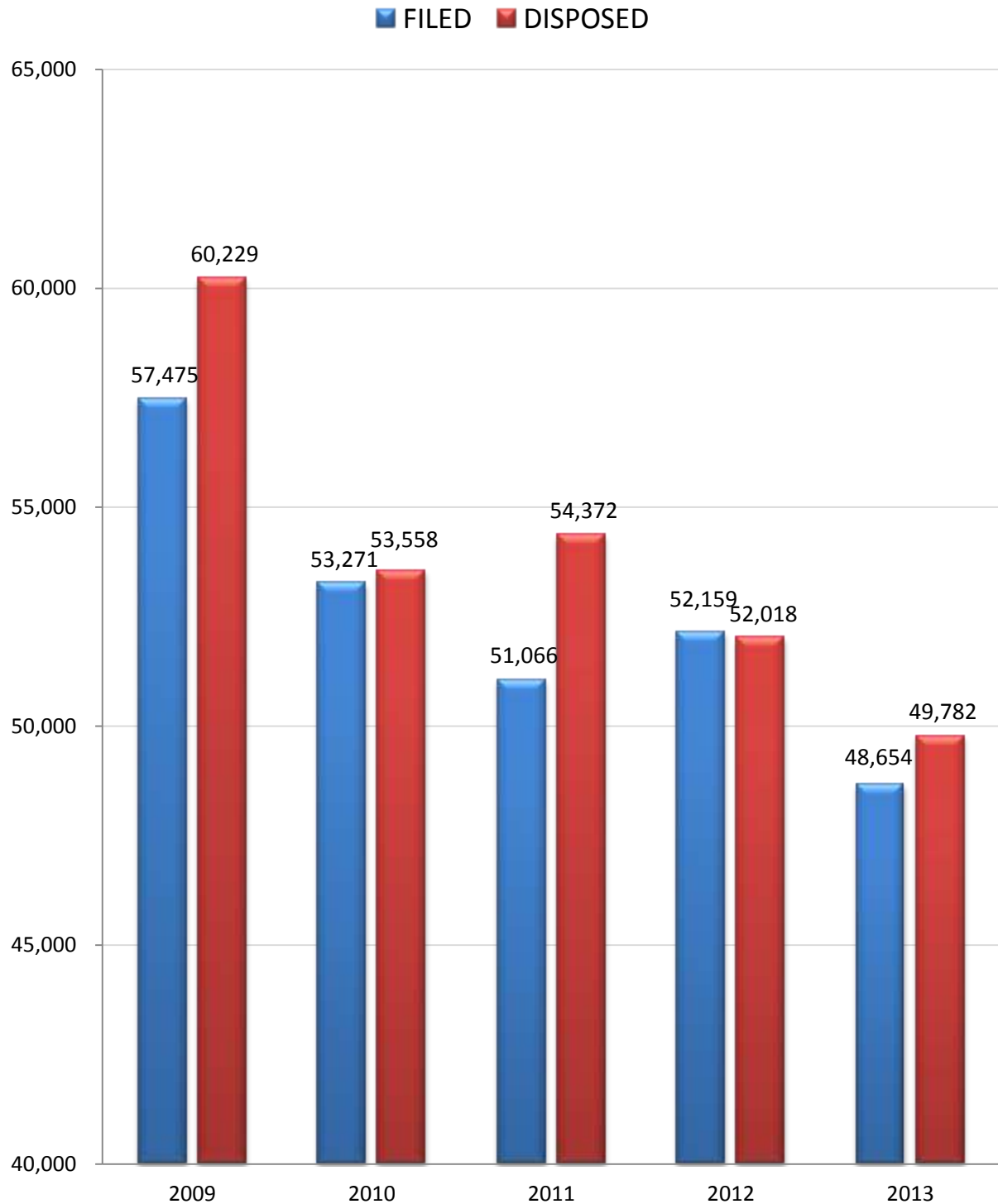

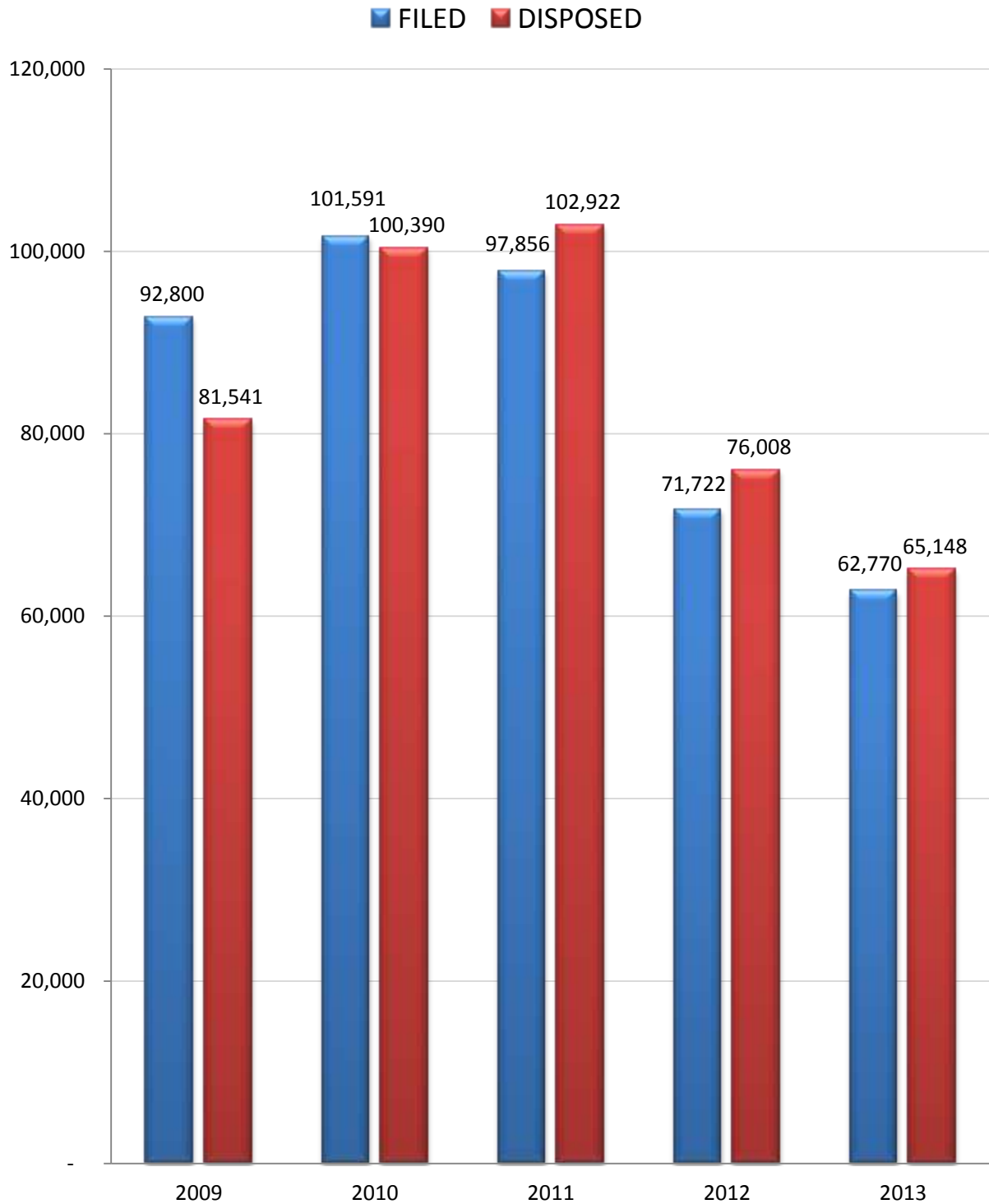
SUPERIOR COURT ANNUAL CASE ACTIVITY, FY 2009 - 2013 CASES FILED AND DISPOSED



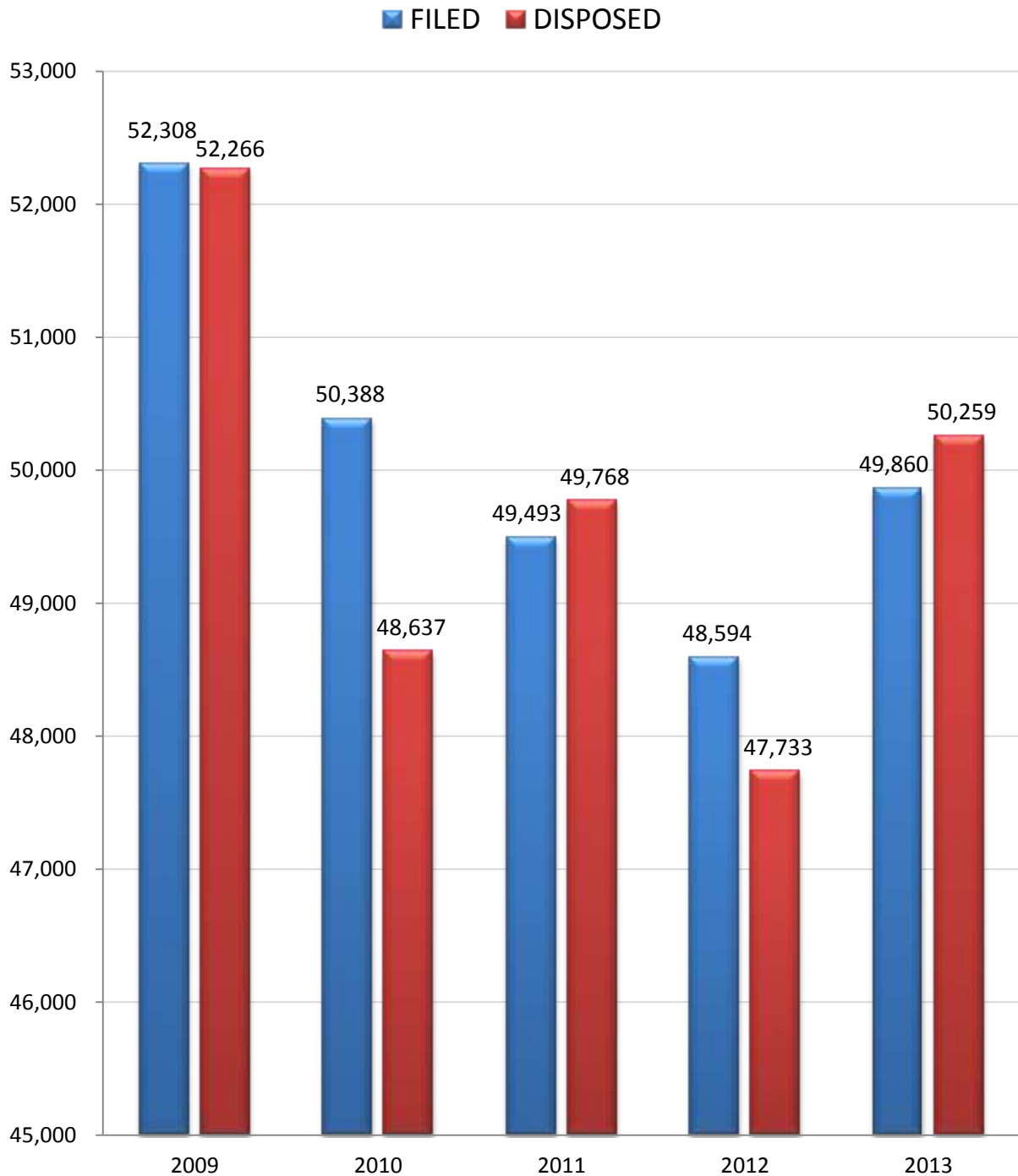
SUPERIOR COURT CRIMINAL CASE ACTIVITY, FY 2009 - 2013 CASES FILED AND DISPOSED



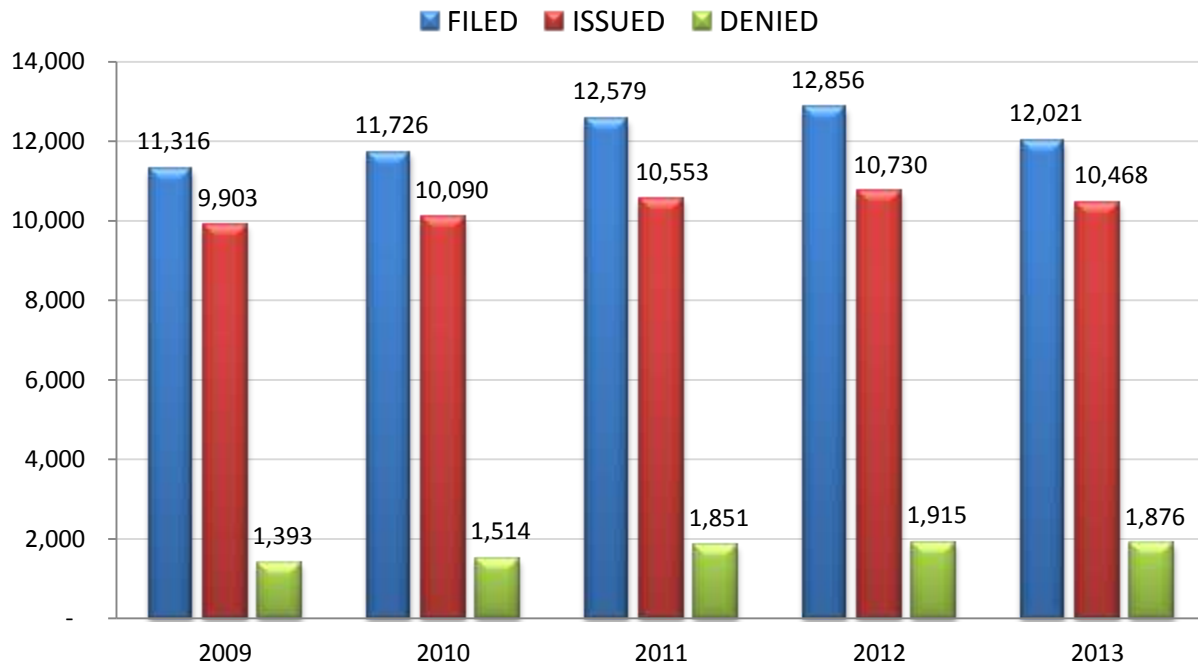
SUPERIOR COURT CIVIL CASE ACTIVITY, FY 2009 - 2013 CASES FILED AND DISPOSED



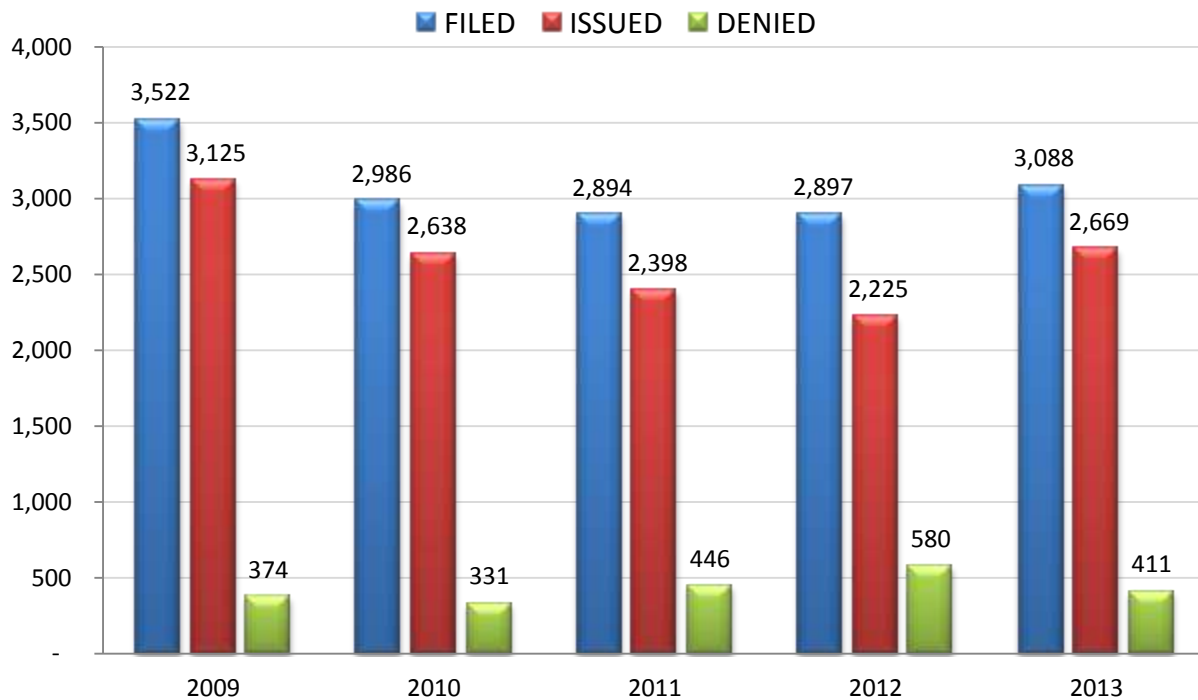
