

LIMITED JURISDICTION COURTS

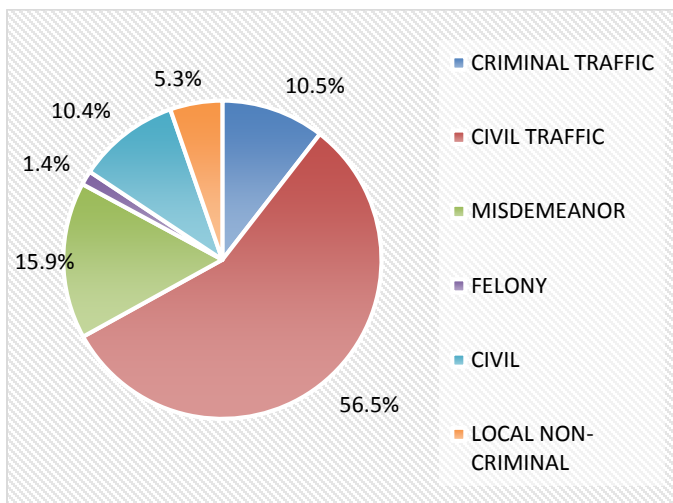
Narrative Summary

This section combines data from both Justice of the Peace and Municipal Courts and presents them statewide and by county. These data are intended for users who are concerned only with types of limited jurisdiction cases, irrespective of the specific court in which they occurred. Justice of the Peace and Municipal Courts are examined individually in subsequent sections.²

During FY 2014, 1,921,100 cases were filed in to the Limited Jurisdiction Courts statewide, an increase of 0.5% from FY 2013. From FY 2013 to FY 2014, Felony and misdemeanor case filings increased 7.3% and 3.8%, respectively. Overall traffic filings decreased by 0.8% from FY 2013 to FY 2014. Criminal traffic decreased by 3.0% and civil traffic decreased by 0.4%.

Statewide, limited jurisdiction courts terminated 2,119,696 cases during FY 2014, a 1.2% increase over the 2,093,782 cases terminated the prior fiscal year. Terminations increased across all case types except non-criminal cases, which decreased by 32.1%, and criminal traffic, which decreased by 3.4%. The statewide increase in terminations led to a decrease of 10.1% in pending cases in the limited jurisdiction courts. Overall pending cases decreased from 1,328,801 at the end of FY 2013 to 1,194,764 at the end of FY 2014, a drop of 134,037 in the pending caseload.

Orders of protection and injunctions prohibiting harassment petitions decreased slightly from FY 2013 to FY 2014. Petitions for orders of protection decreased from 22,125 in FY 2013 to 22,093 in FY 2014, a decline of 0.3%. Petitions for injunctions against harassment decreased from 13,815 in FY 2013 to 13,591 in FY 2014, a decrease of 1.6%. Limited jurisdiction courts held an additional 5,936 order of protection review hearings and 3,010 injunction against harassment review hearings during FY 2014.

Limited jurisdiction courts held 9,004 court trials and 906 jury trials during FY 2014. Of the total trials, 43.2% were for civil cases, 37.4% were misdemeanor charges and 19.4% were for criminal traffic charges. The courts held an additional 58,722 civil traffic hearings, 53,470 initial appearances and 3,769 small claims hearings. The courts issued 4,710 search warrants during the same period.

As of June 30, 2014 a total of 441,318 warrants were outstanding, 226,774 for criminal traffic violations and 214,544 for misdemeanor violations.

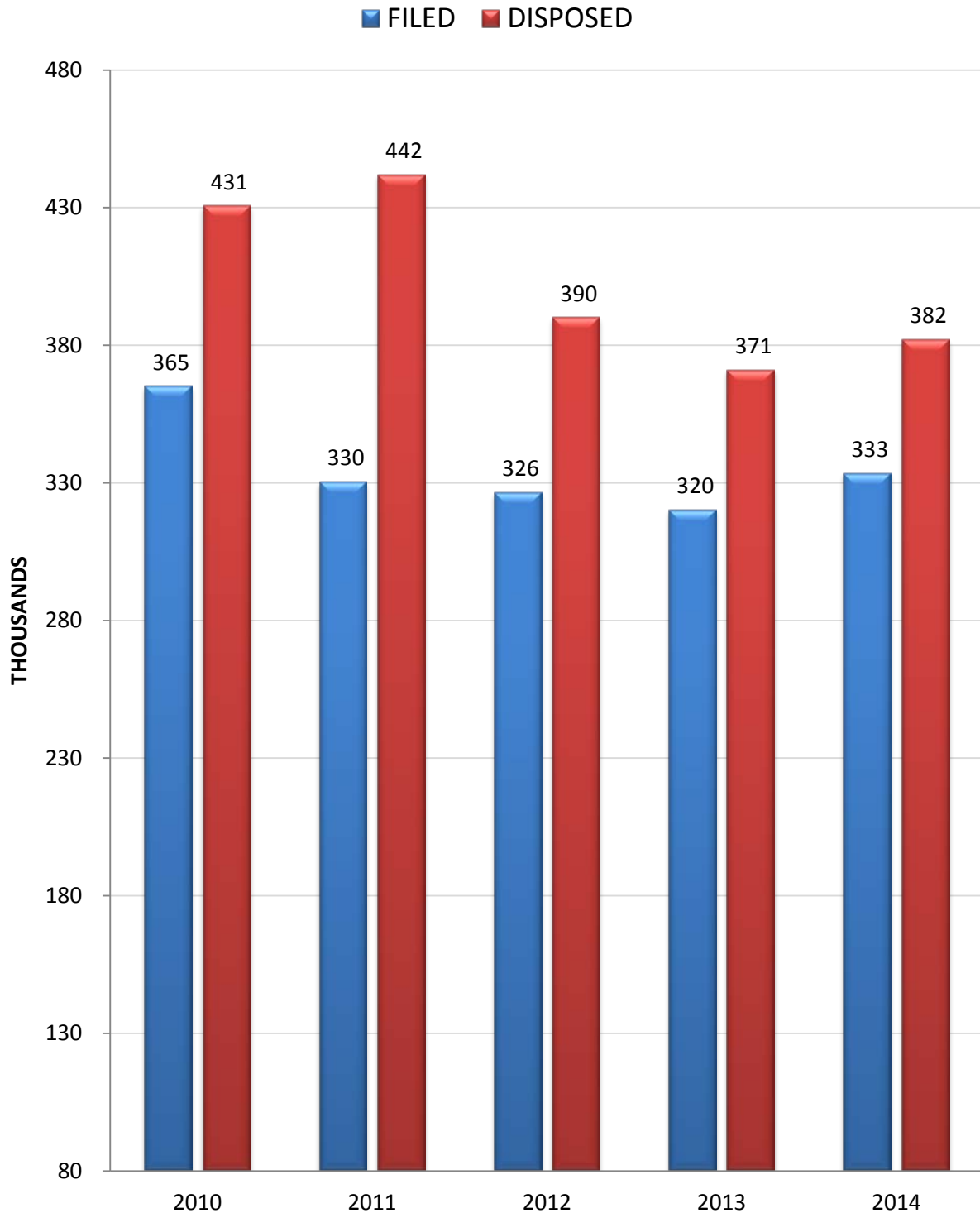

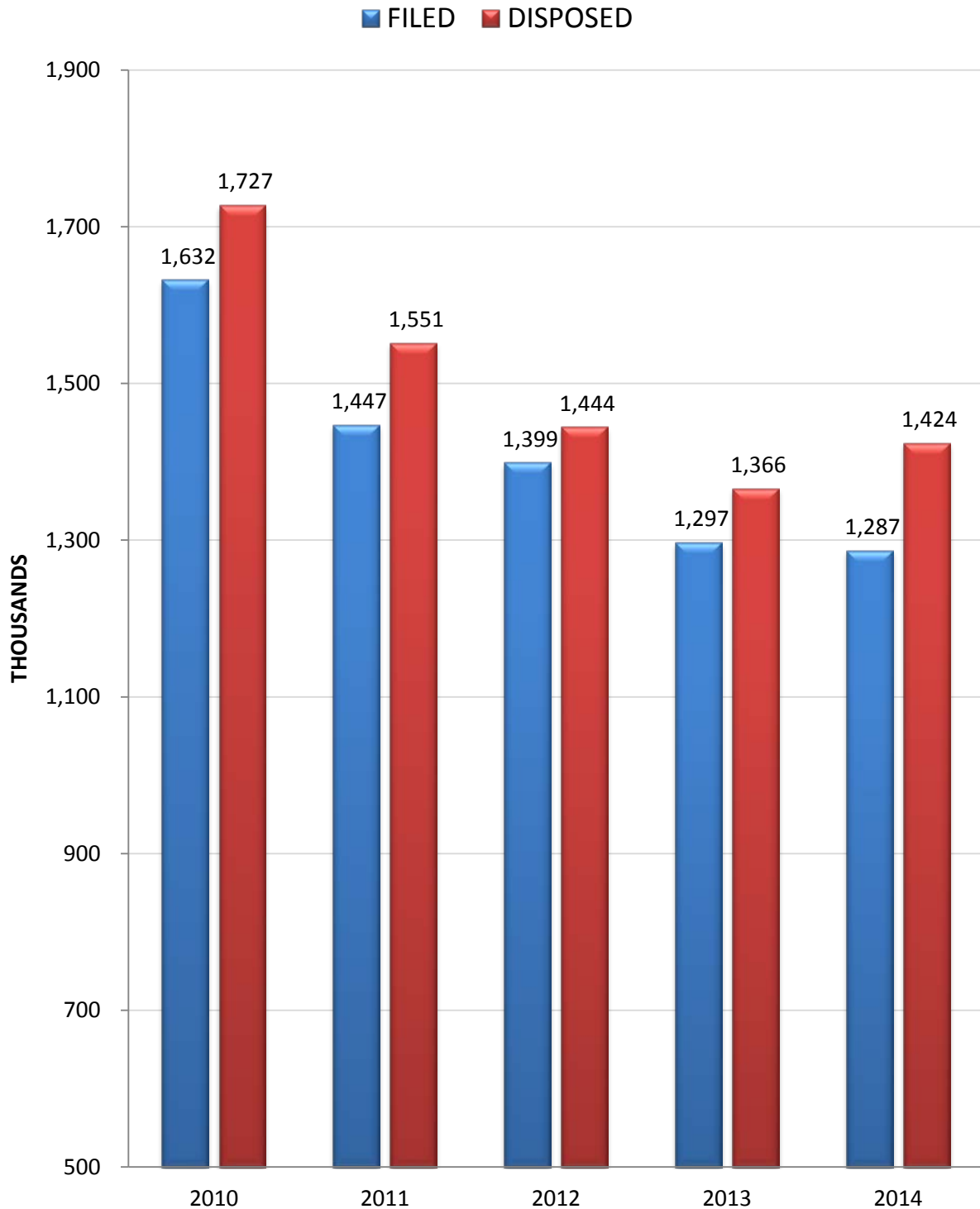

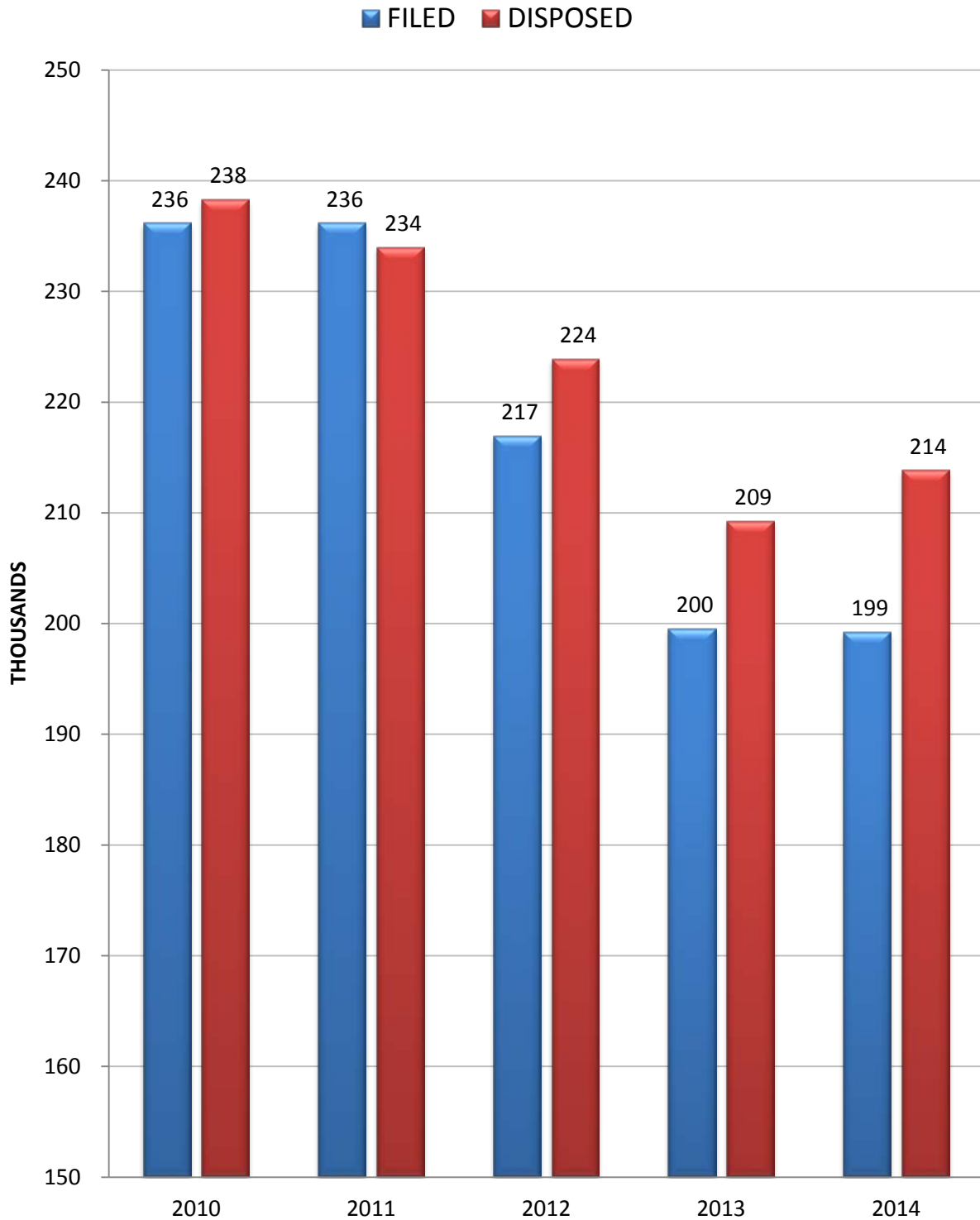

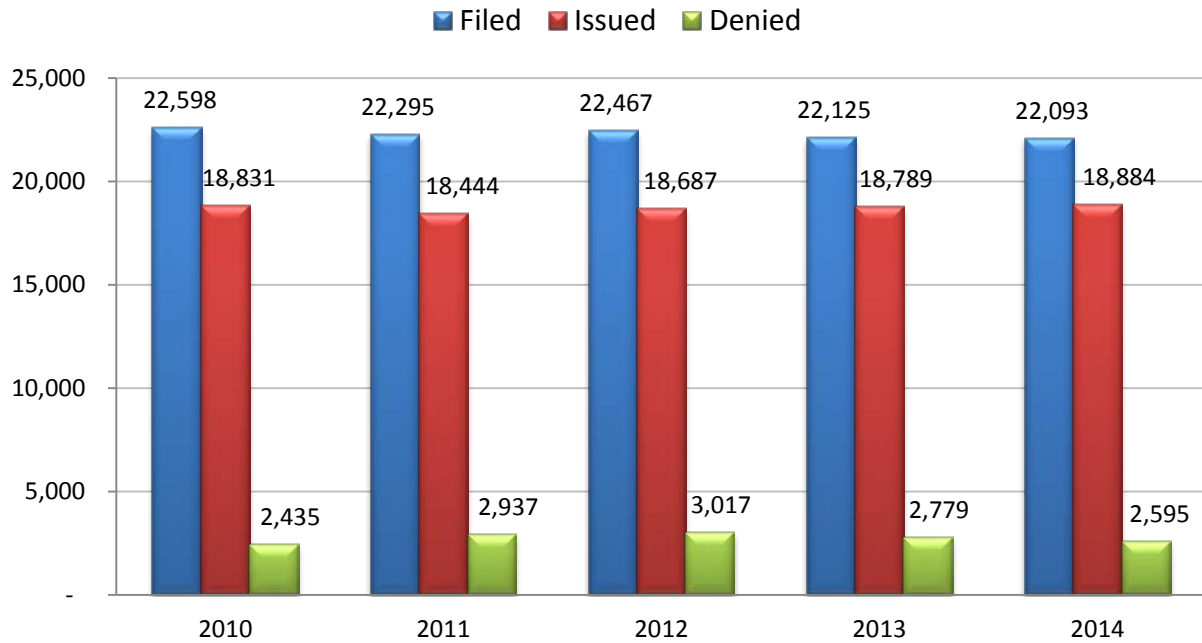
CIVIL CASE ACTIVITY, FY 2010 - 2014

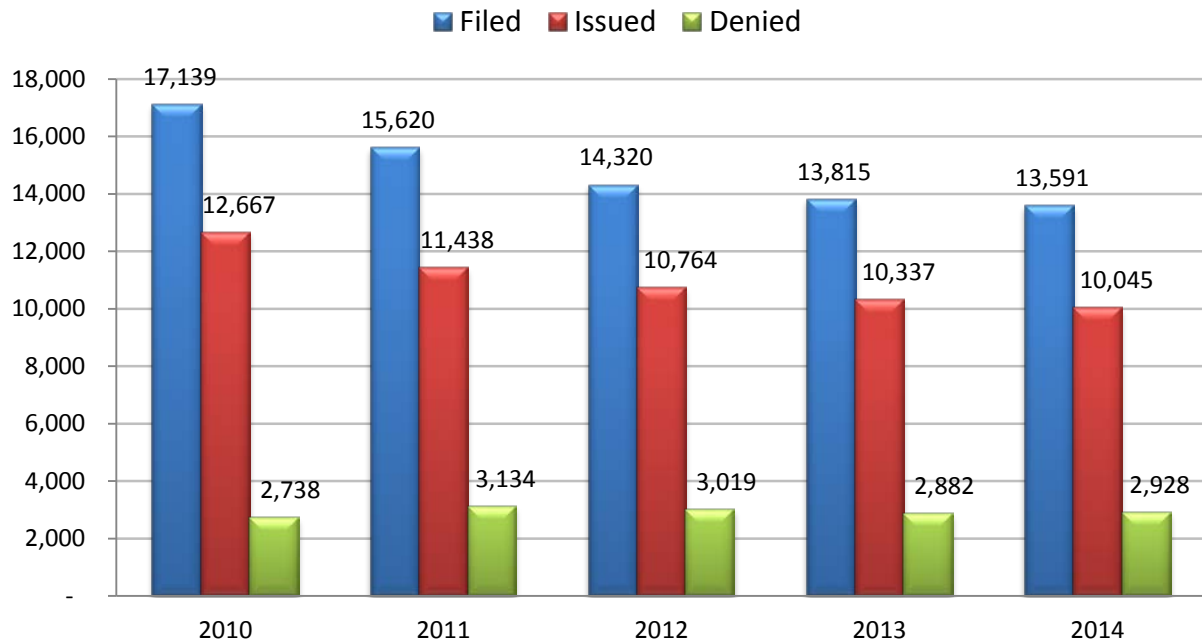
