

COURT PERSONNEL
Limited Jurisdiction Courts Narrative Summary

The limited jurisdiction summary illustrates all court positions in Justice of the Peace and Municipal Courts as of June 30, 2014 including positions funded from both primary and non-primary budget sources. The information was reported by the individual courts in response to the Supreme Court personnel survey which was electronically distributed in June 2014.

The total number of full-time positions in the Limited Jurisdiction Courts increased 0.4% from 1,834 in FY 2013 to 1,841 in FY 2014. There were 826 full-time positions in the Justice Courts in FY 2014, compared with 829 the previous year. Full-time positions in the Municipal Courts increased from 1,005 the previous fiscal year to 1,015 in FY 2014.

The Limited Jurisdiction Courts employed an additional 489 part-time personnel in FY 2014 compared to 466 in FY 2013, an increase of 4.9%. The Justice Courts employed 140 part-time personnel, compared to 129 the previous fiscal year. The Municipal Courts employed 349 part-time personnel in FY 2014, compared to 337 in FY 2013.

The Limited Jurisdiction Courts also received assistance from 74 regular volunteers in FY 2014. Volunteers include non-professionals and professionals who serve in various capacities, from support staff to on-call magistrates. The Justice Courts utilized 47 regular volunteers while the Municipal Courts received assistance from 27 volunteers.

Additionally, the Limited Jurisdiction Courts utilized 45,360 hours of temporary personnel assistance during FY 2014. The Justice Courts used 27,087 hours of temporary personnel, while the Municipal Courts used 18,273 hours.

Some of the FY 2013 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the report.
