

LIMITED JURISDICTION COURTS

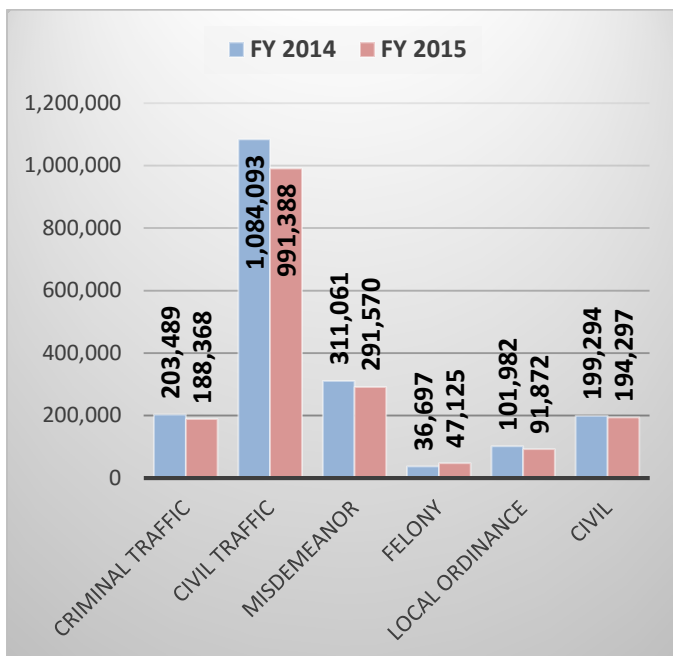
Narrative Summary

This section combines data from both Justice of the Peace and Municipal Courts and presents them statewide and by county. These data are intended for users who are concerned only with types of limited jurisdiction cases, irrespective of the specific court in which they occurred. Justice of the Peace and Municipal Courts are examined individually in subsequent sections.

Beginning with calendar year 2014, courts began counting all cases at the charge level for statistical reporting. In prior years, charges filed by long-form complaint were counted according to the primary charge, and those filed by citation were counted at the charge level. As a result, courts with higher volumes of long-form complaints may show increased criminal traffic and felony filings for this reporting period. 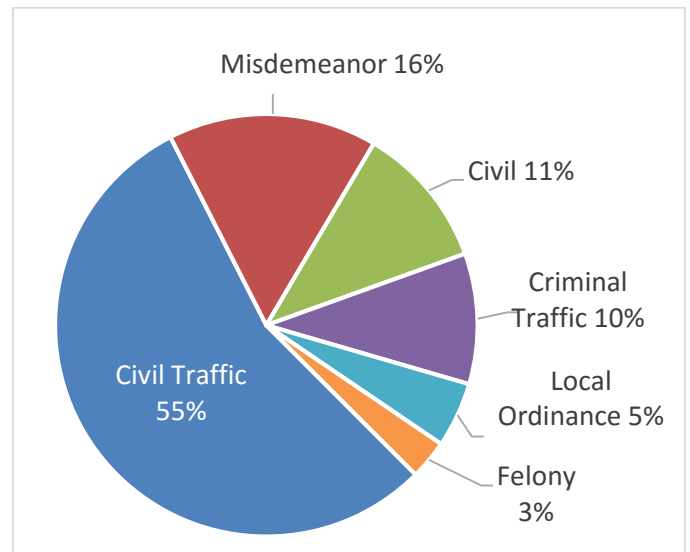
Statewide filings in limited jurisdiction courts decreased 6.8%, from 1,936,616 in FY 2014 to 1,804,620 in FY 2015. Traffic filings, including both civil and criminal traffic, decreased by 107,826 filings, or 8.4%. During the same period, misdemeanor non-traffic and felony cases decreased by 9,063 filings. Civil filings decreased by 2.5%, from 199,294 in FY 2014 to 194,297 in FY 2015.

Petitions for orders of protection increased from 22,093 in FY 2014 to 22,218 in FY 2015. Petitions for injunctions against harassment increased from 13,597 in FY 2014 to 13,704 in FY 2015. Limited jurisdiction courts held an additional 5,741 order of protection review hearings and 2,967 injunction against harassment review hearings during FY 2015.

Limited jurisdiction courts disposed of 1,938,335 cases during FY 2015, an 8.9% decrease compared to the 2,128,791 cases terminated the previous fiscal year. Terminations decreased across all case types except felony, which increased by 33.8%.

Cases pending in the limited jurisdiction courts increased by 1.1%, from 1,252,434 at the end of FY 2014 to 1,265,610 at the end of FY 2015.

The total number of trials held increased 5.5% from 9,928 in FY 2014 to 10,471 in FY 2015. Of the total trials held, 92.1% were court trials and 7.9% were jury trials.

As of June 30, 2015, a total of 44,765 criminal and criminal traffic warrants were outstanding in the limited jurisdiction courts statewide.

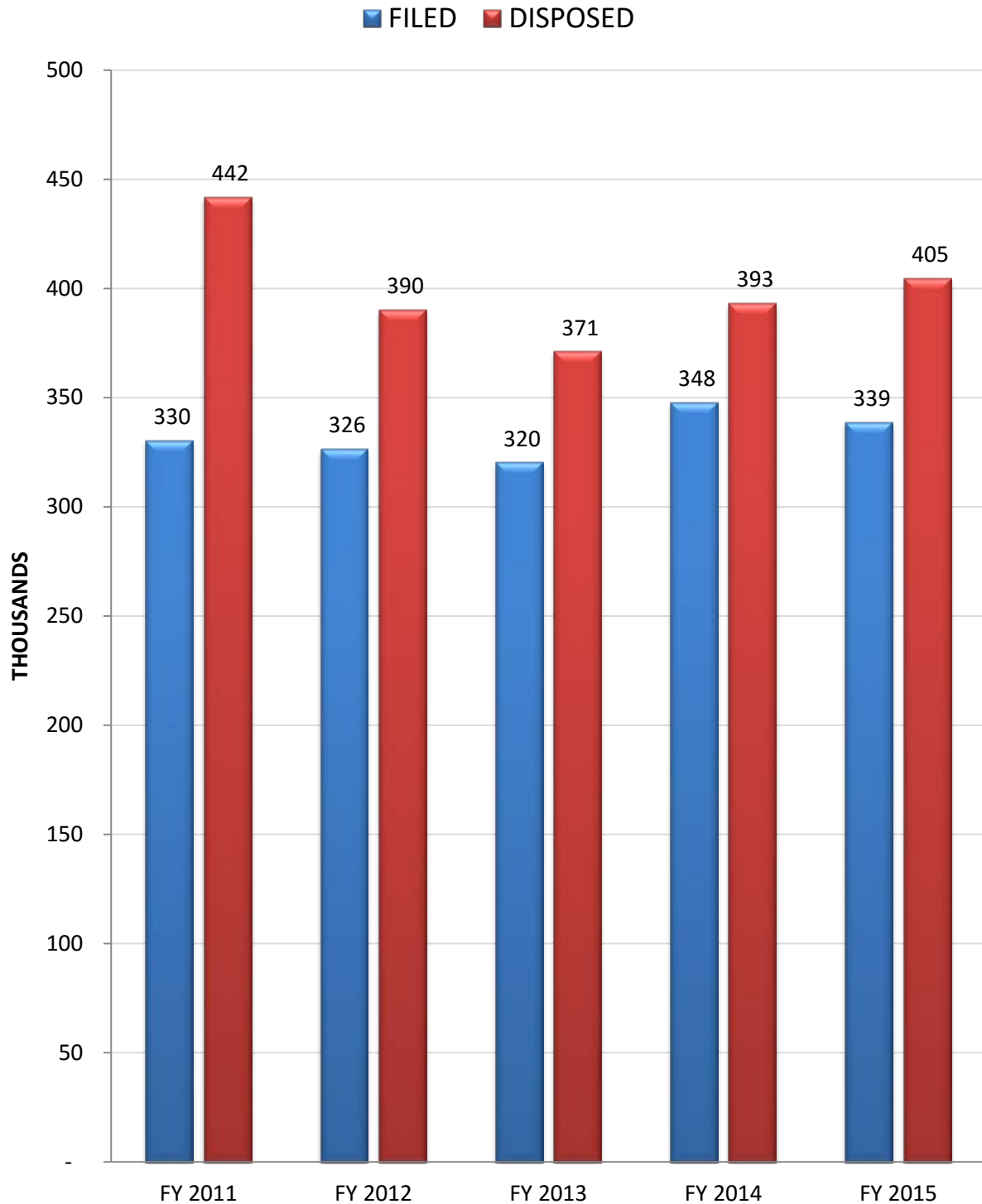

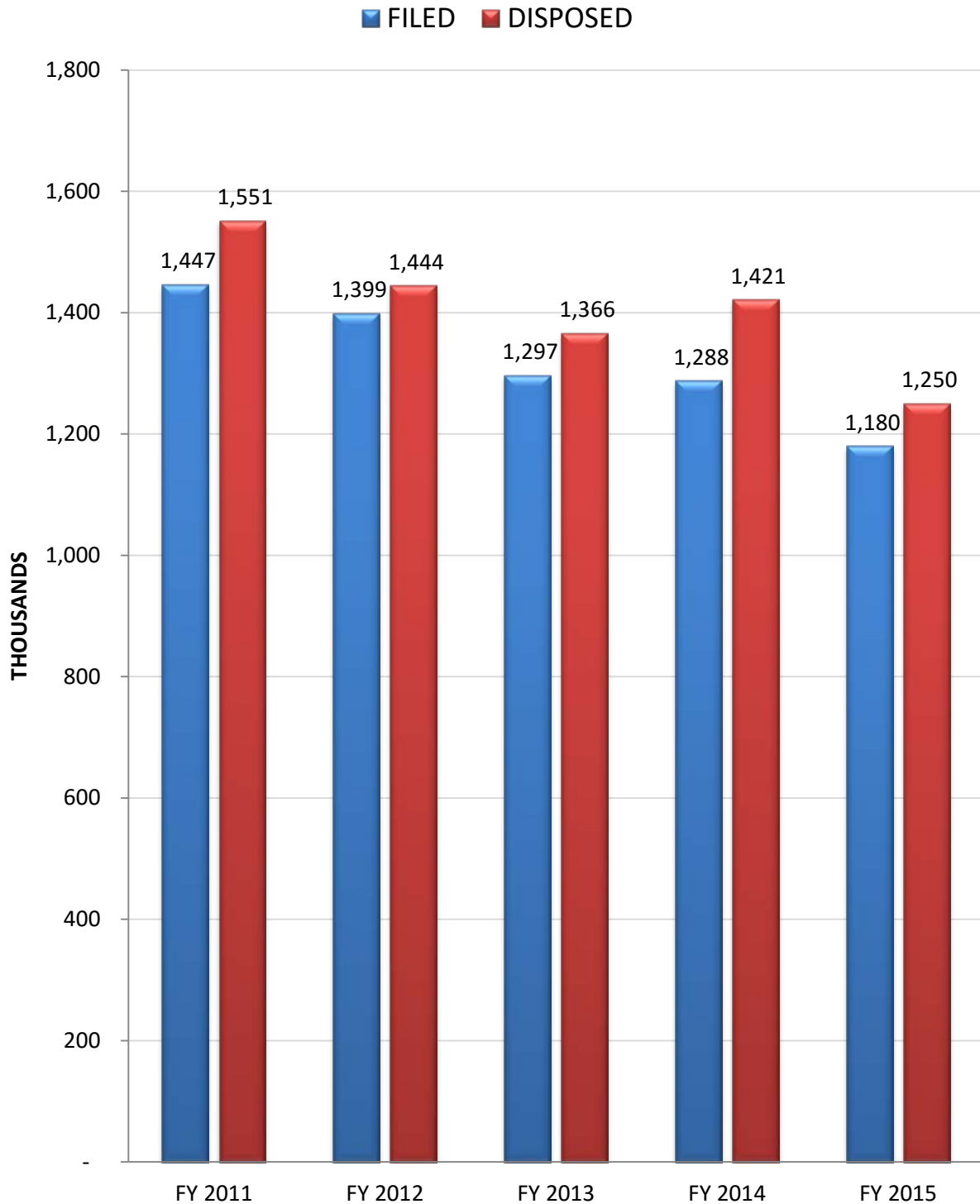

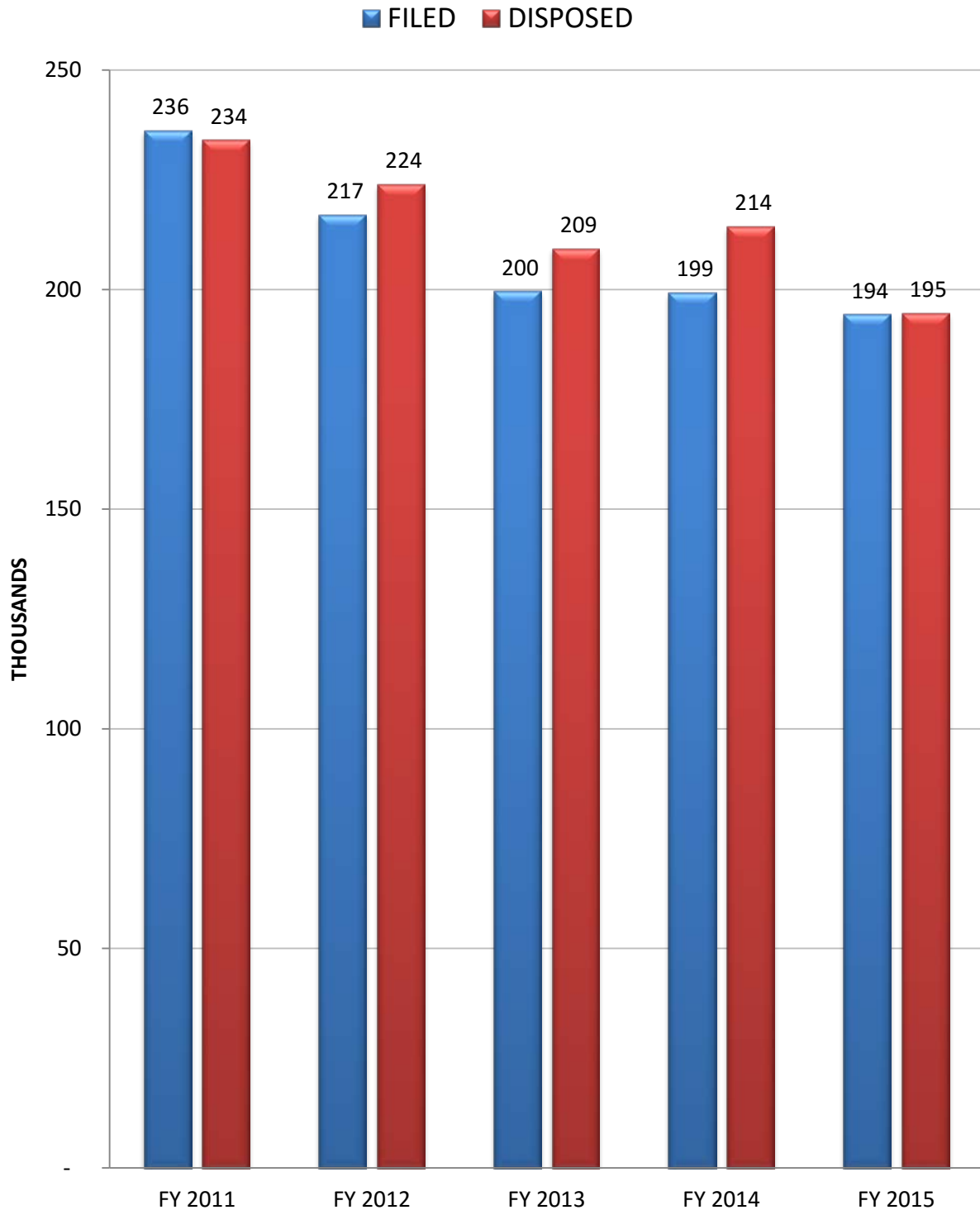

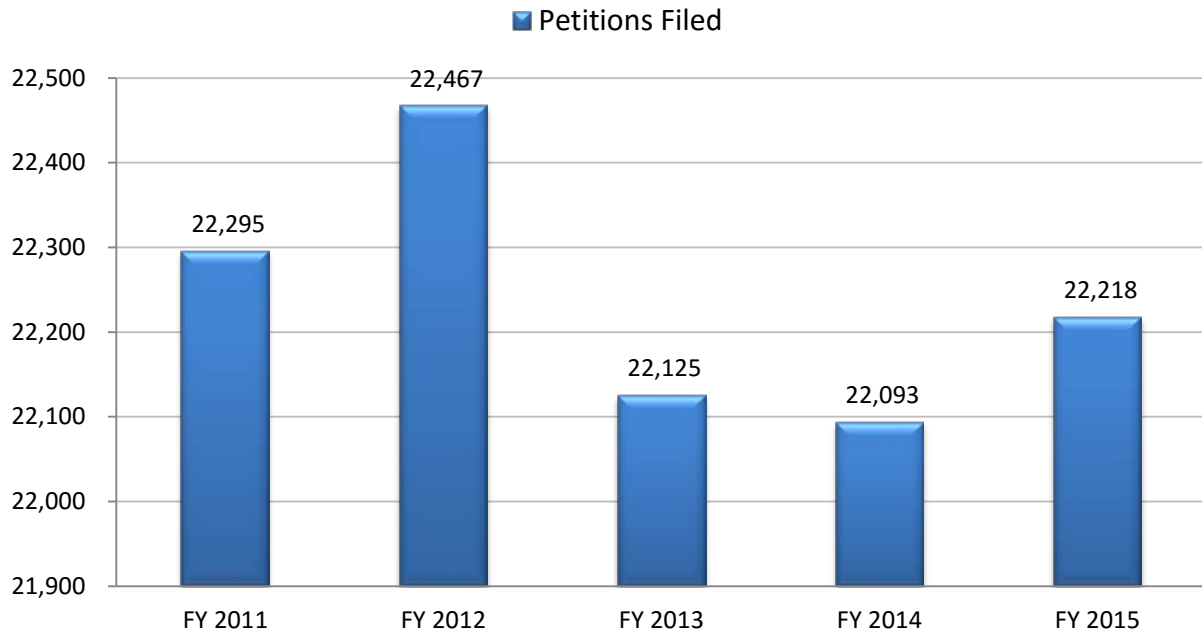
CIVIL CASE ACTIVITY, FY 2011 - 2015

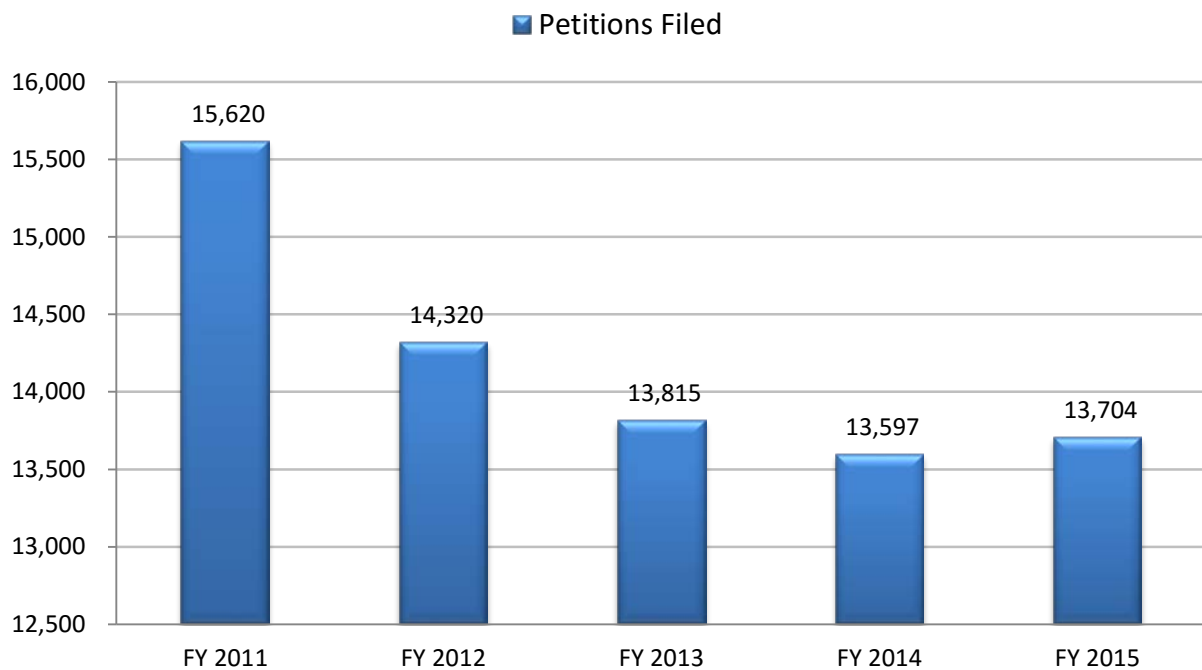
