

COURT PERSONNEL
Limited Jurisdiction Courts Narrative Summary

The limited jurisdiction summary illustrates all court positions in Justice of the Peace and Municipal Courts as of June 30, 2015 including positions funded from both primary and non-primary budget sources. The information was reported by the individual courts in response to the Supreme Court personnel survey which was electronically distributed in June 2015.

The total number of full-time positions in the Limited Jurisdiction Courts decreased 1.2% from 1,841 in FY 2014 to 1,819 in FY 2015. There were 799 full-time positions in the Justice Courts in FY 2015, compared with 826 the previous year. Full-time positions in the Municipal Courts increased from 1,015 the previous fiscal year to 1,020 in FY 2015.

The Limited Jurisdiction Courts employed an additional 480 part-time personnel in FY 2015 compared to 489 in FY 2014, a decrease of 1.8%. The Justice Courts employed 164 part-time personnel, compared to 140 the previous fiscal year. The Municipal Courts employed 316 part-time personnel in FY 2015, compared to 349 in FY 2014.

The Limited Jurisdiction Courts also received assistance from 83 regular volunteers in FY 2015. Volunteers include non-professionals and professionals who serve in various capacities, from support staff to on-call magistrates. The Justice Courts utilized 46 regular volunteers while the Municipal Courts received assistance from 37 volunteers.

Additionally, the Limited Jurisdiction Courts utilized 36,027 hours of temporary personnel assistance during FY 2015. The Justice Courts used 20,900 hours of temporary personnel, while the Municipal Courts used 15,127 hours.

Some of the FY 2014 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the report.
