

SUPERIOR COURT Narrative Summary

The Superior Court is the state's only general jurisdiction trial court. Arizona's Superior Court has 15 branches, one for each county in the state. Superior Court has jurisdiction over all cases except small claims, petty offenses and violations of city ordinance/codes. The Superior Court also acts as an appellate court for justice and municipal courts.

Total filings (including transfers in) decreased 5.3%, from 201,299 in FY 2014 to 190,611 this fiscal year. Civil filings, which decreased by 17.7%, had the greatest impact on the overall decline in case filings over the year. Criminal and domestic relations categories also saw decreased filings of 1.6% and 1.2%, respectively. Probate, Juvenile, and Mental Health filings increased from FY 2014 to FY 2015.

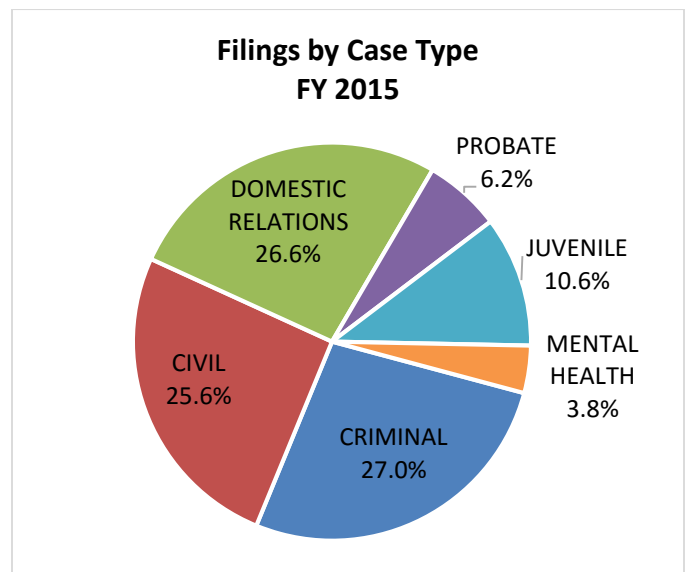
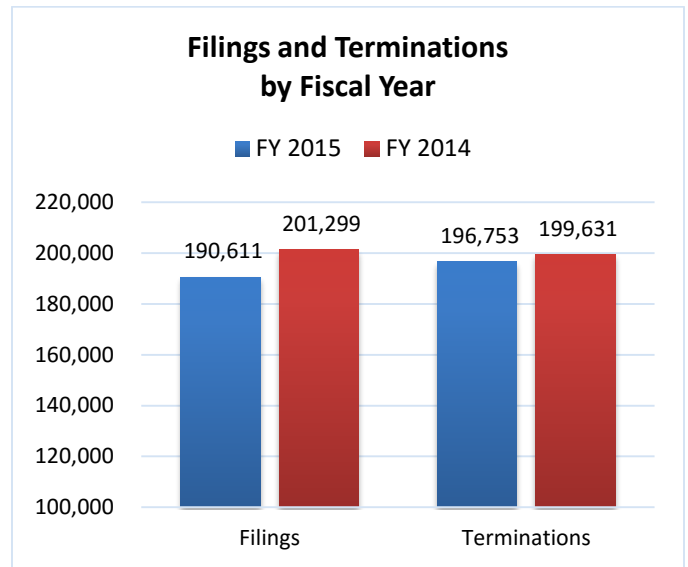
Civil filings account for 25.6% of the total filings in Superior Court. Case filings in this category decreased by 10,464 from FY 2014 to FY 2015. Decreases in Non-classified and Contract filings had the greatest impact on the overall decrease. Together these two case type categories account for 80.1% of the total civil filings.

Within the Juvenile case type, Dependency cases increased from 6,962 in FY 2014 to 7,643 in 2015, an increase of 9.8%. The Mental Health case type category also saw increased filings of 3.2% from FY 2014 to FY 2015.

Petitions for orders of protection increased 4.9%, from 12,384 in FY 2014 to 12,991 in FY 2015. Petitions for injunctions against harassment increased 9.8%, from 2,935 in FY 2014 to 3,224 in FY 2015. Of the total protective order petitions filed, 83.8% of petitions for Orders of Protection were issued and 92.4% of Injunctions against Harassment were issued.

Total dispositions (including transfers) decreased 1.4% from 199,631 in FY 2014 to 196,753 in FY 2015. As of June 30, 2015, there were 206,693 cases pending, a slight increase over the 205,554 pending at the end of FY 2014.

Superior Court held 5,425 trials during FY 2015 compared to 5,640 in FY 2014. Of the 5,425 total trials in FY 2015, 4,076 (75.1%) were court trials and 1,349 (24.9%) were jury trials. Of the court trials, 92.1% were for domestic relations cases, 4.0% for Civil, 3.7% for Criminal and the remaining were appeals from the lower courts. Of the jury trials held, 82.0% were criminal trials and 18.2% were civil trials.



Data for all counties except Maricopa and Pima were estimated for FY 2015 due to courts transitioning to a new case management system.

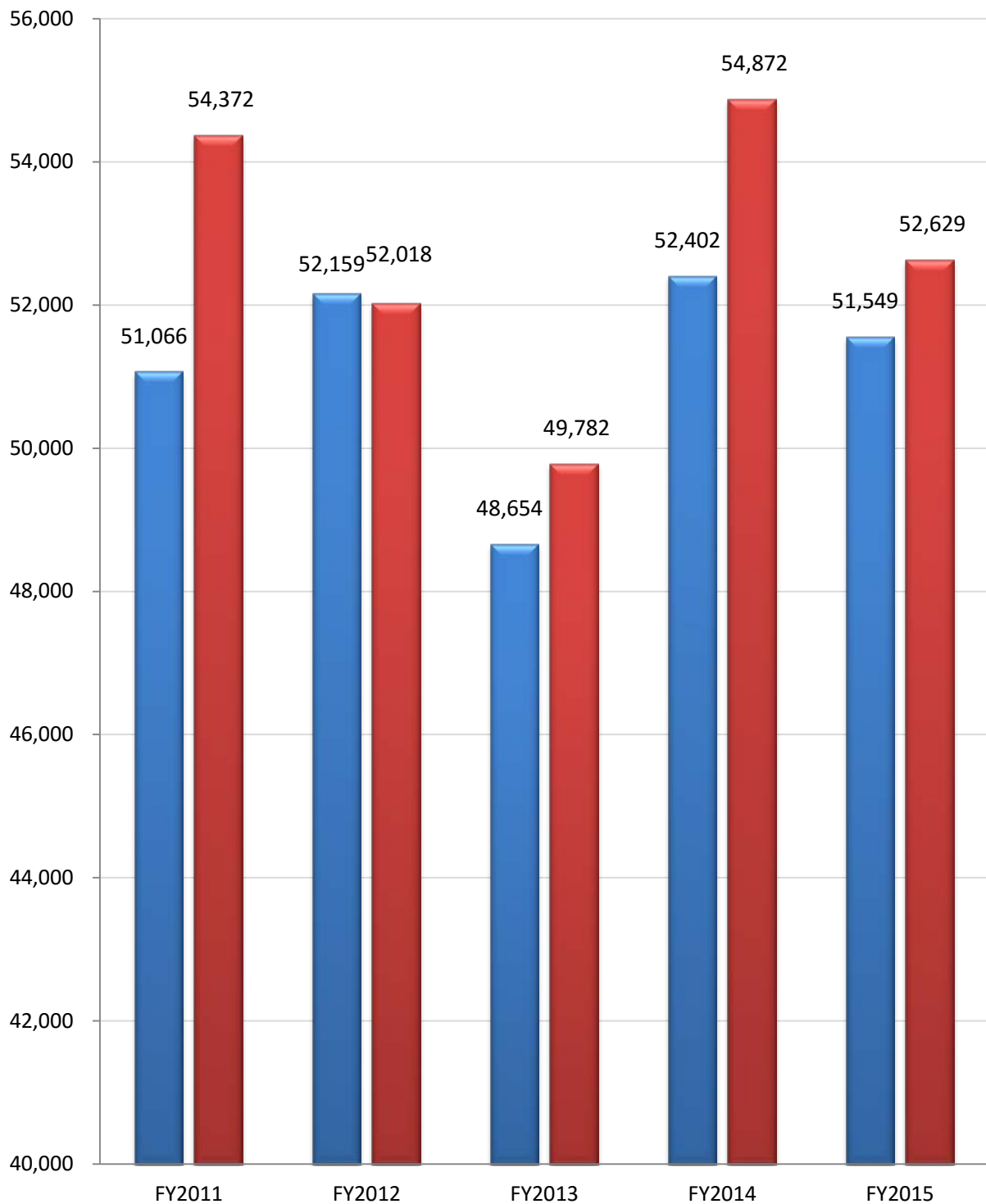

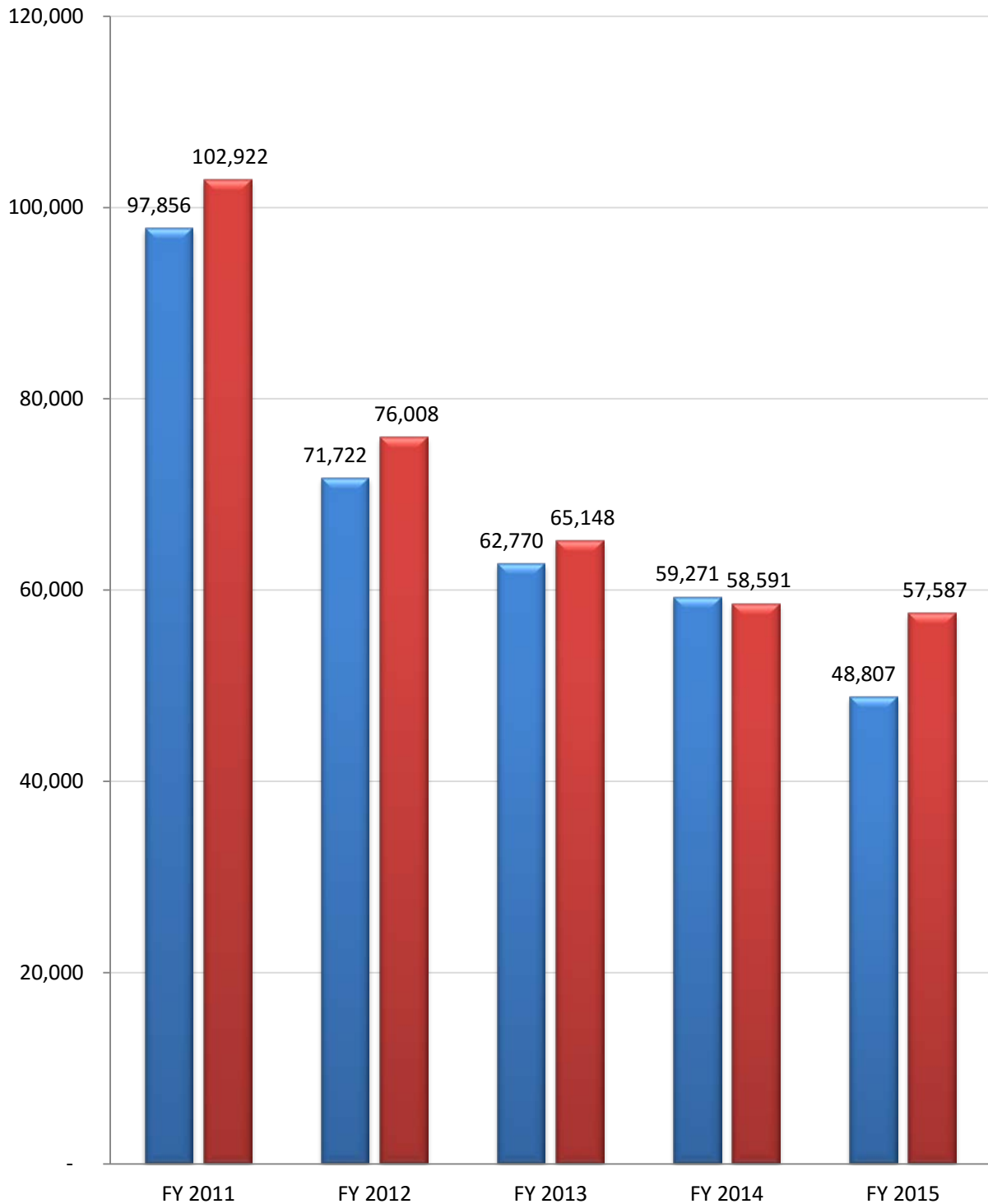

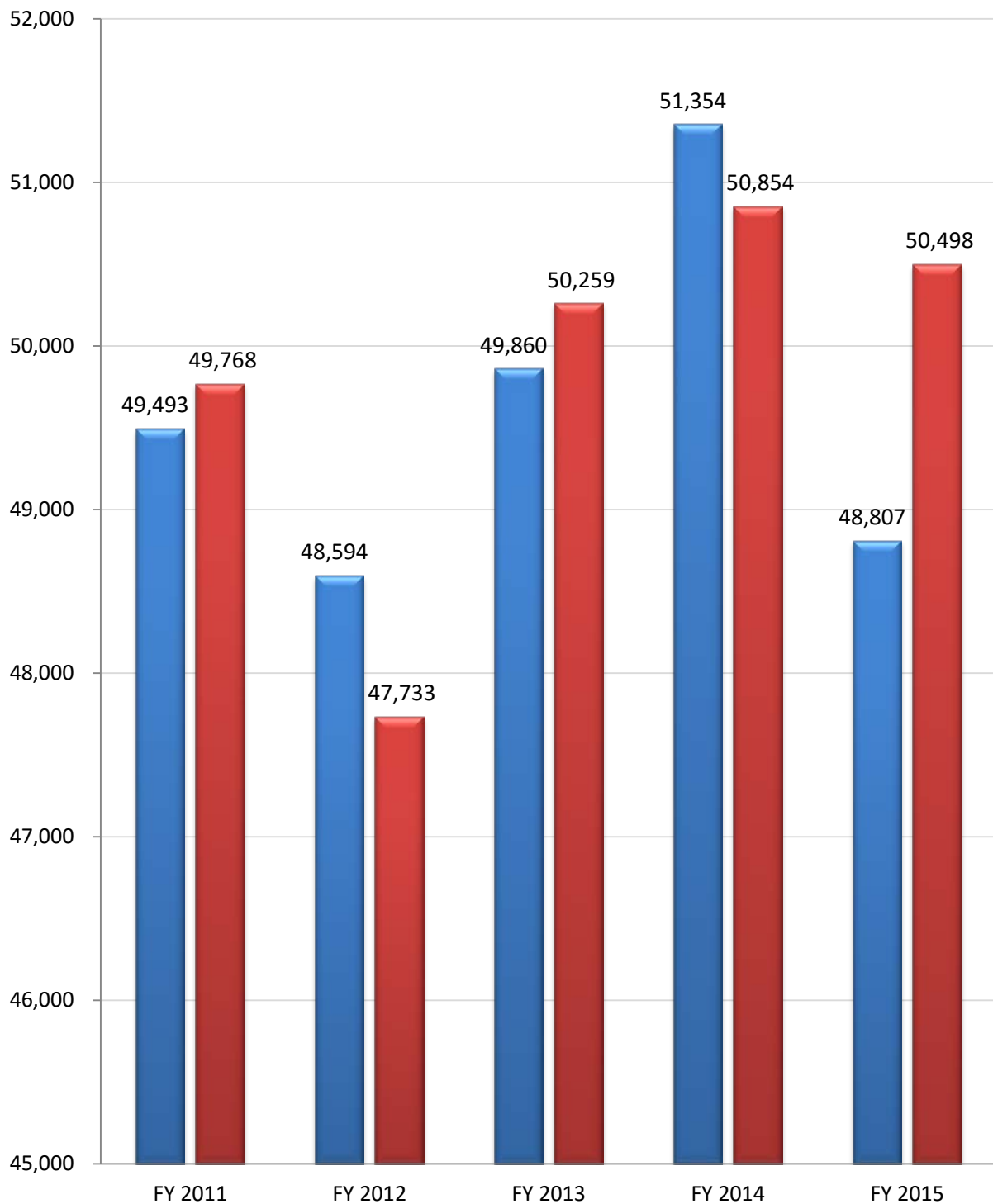

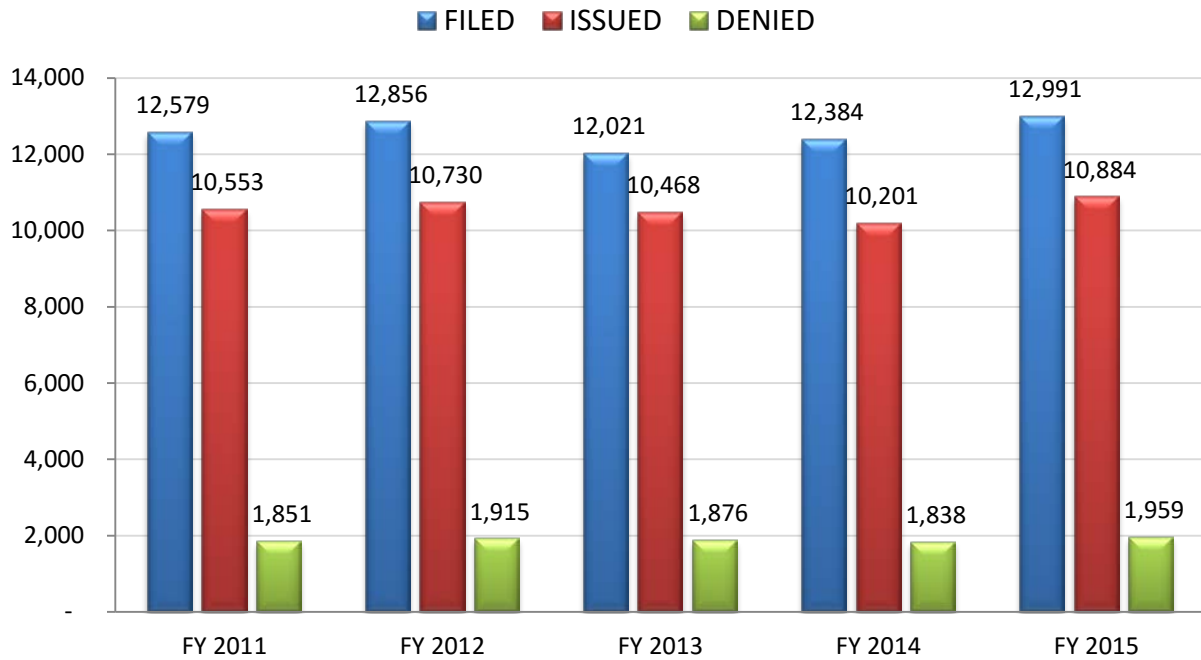

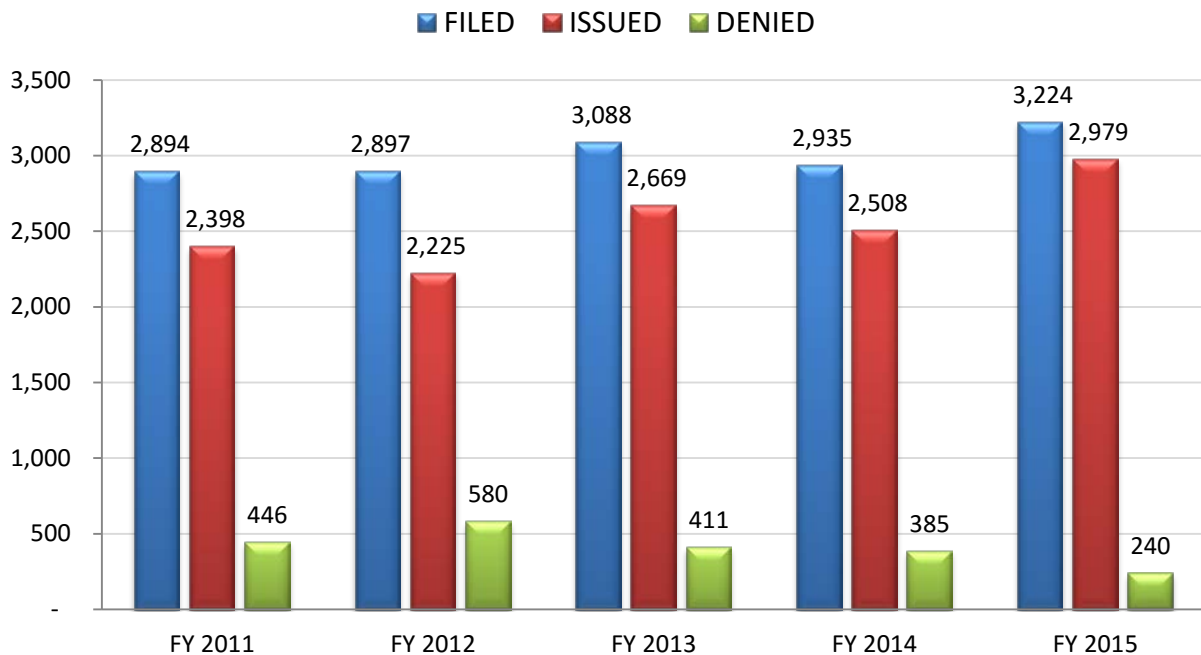
