

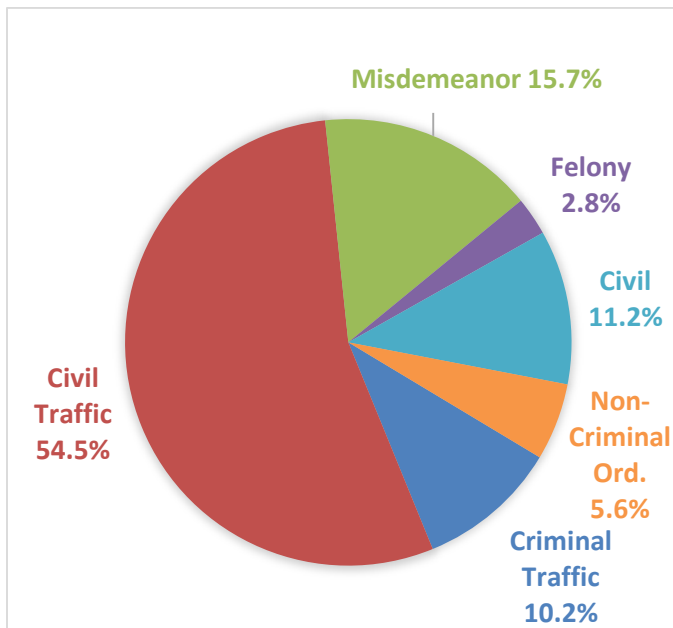
LIMITED JURISDICTION COURTS Narrative Summary

This section combines data from both Justice of the Peace and Municipal Courts, presented statewide and by county. Justice of the Peace and Municipal Courts are examined individually in subsequent sections.

During FY 2016, 1,718,975 cases were filed into the Limited Jurisdiction Courts statewide, a decrease of 4.7% from FY 2015. Misdemeanor case filings decreased 7.3%, from 291,570 in FY 2015 to 270,219 in FY 2016. Combined criminal and civil traffic filings decreased by 67,055 or 5.7%. Within the civil category, small claims and other civil case filings increased 5.7% and 1.8%, respectively, while forcible detainer case filings decreased 5.5% during the same period. Petitions for Orders of Protection and Injunctions Against Harassment decreased 1.6% from 35,922 in FY 2015 to 35,341 in FY 2016.

Civil Traffic accounts more than half of the total filings in limited jurisdiction courts statewide. 74.3% of the total civil traffic cases are filed in Maricopa and Pima Counties. The second largest category, Misdemeanor Non-Traffic, accounts for 15.7% of the total cases filed in limited jurisdiction courts.

CASE FILING DISTRIBUTION BY CASE TYPE FY 2016



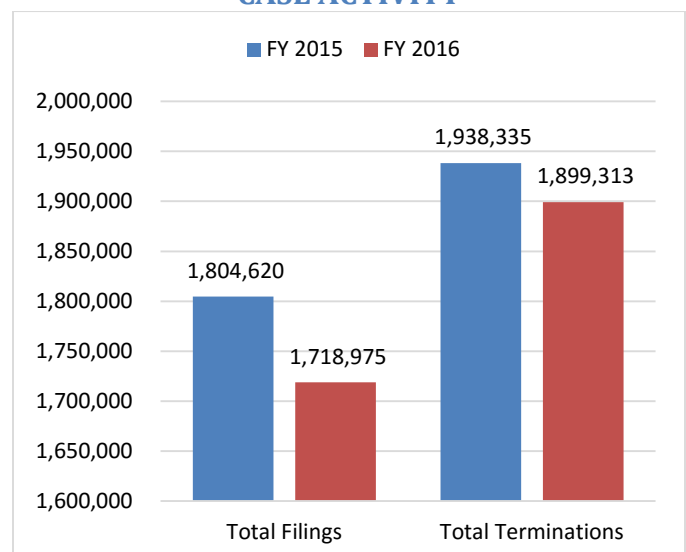
Limited jurisdiction courts terminated 1,899,313 cases during FY 2016, a 2.0% decrease from 1,938,335 cases terminated the previous fiscal year. Overall pending cases decreased from 1,265,610 at the end of FY 2015 to 1,178,709 at the end of FY 2016, a reduction of 86,901 cases.

Limited Jurisdiction Courts held 8,450 court trials and 736 jury trials during FY 2016. Of the total trials, 42.4% were for civil cases, 40.1% were misdemeanor charges and 17.5% were for criminal traffic charges. The courts held an additional 58,686 civil traffic hearings, 52,555 initial appearances and 3,203 small claims hearings. During the same period, the courts issued 5,216 search warrants.

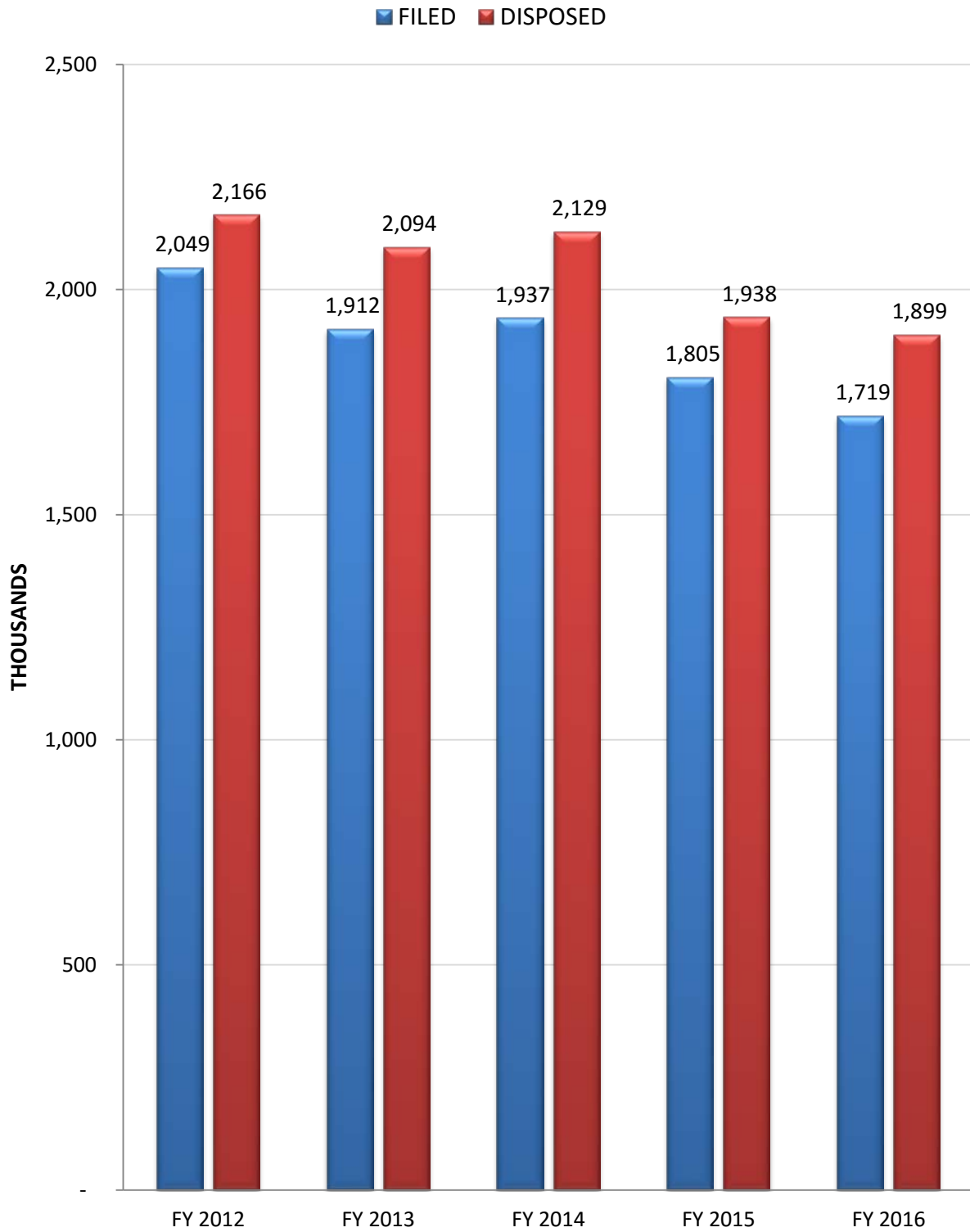

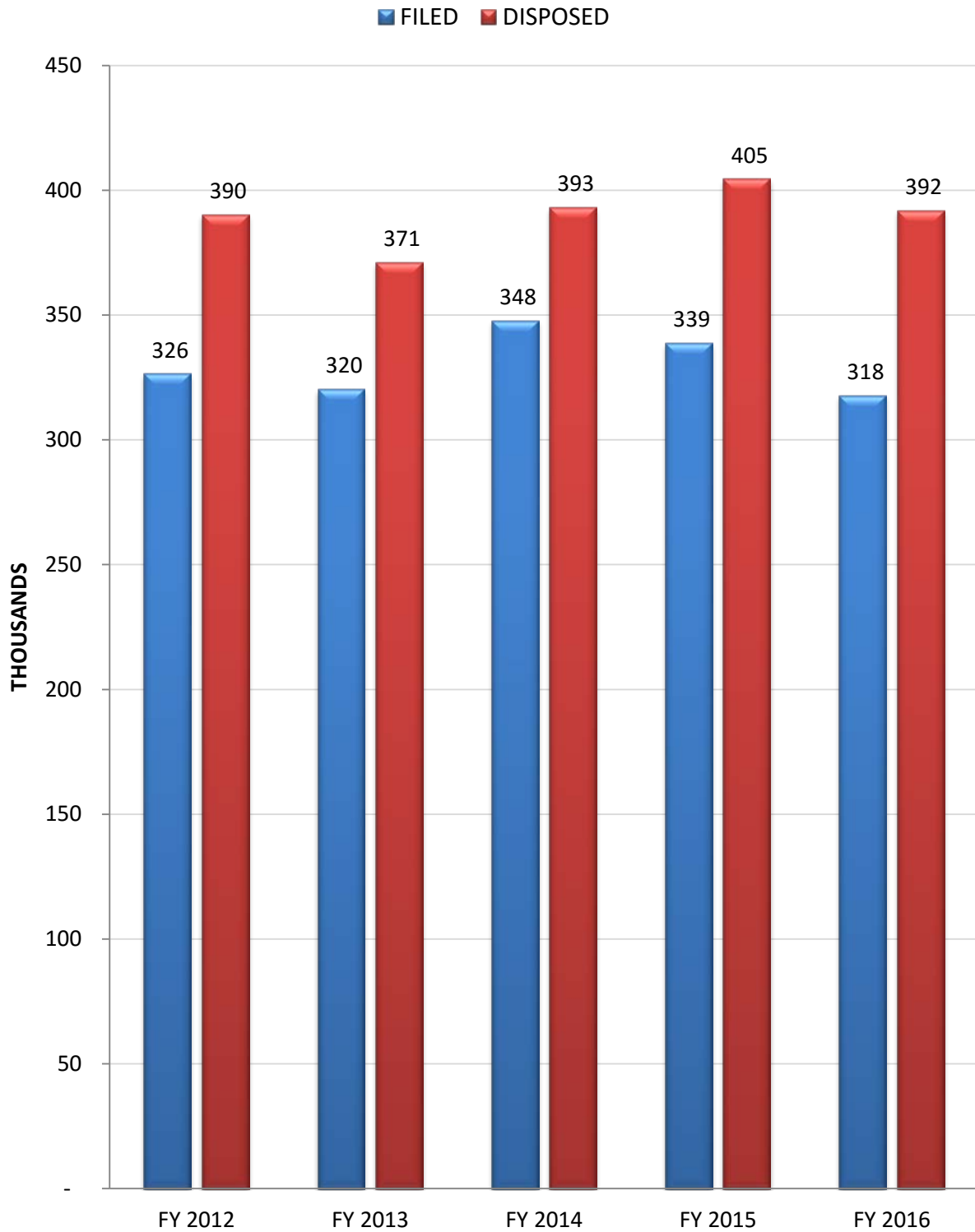

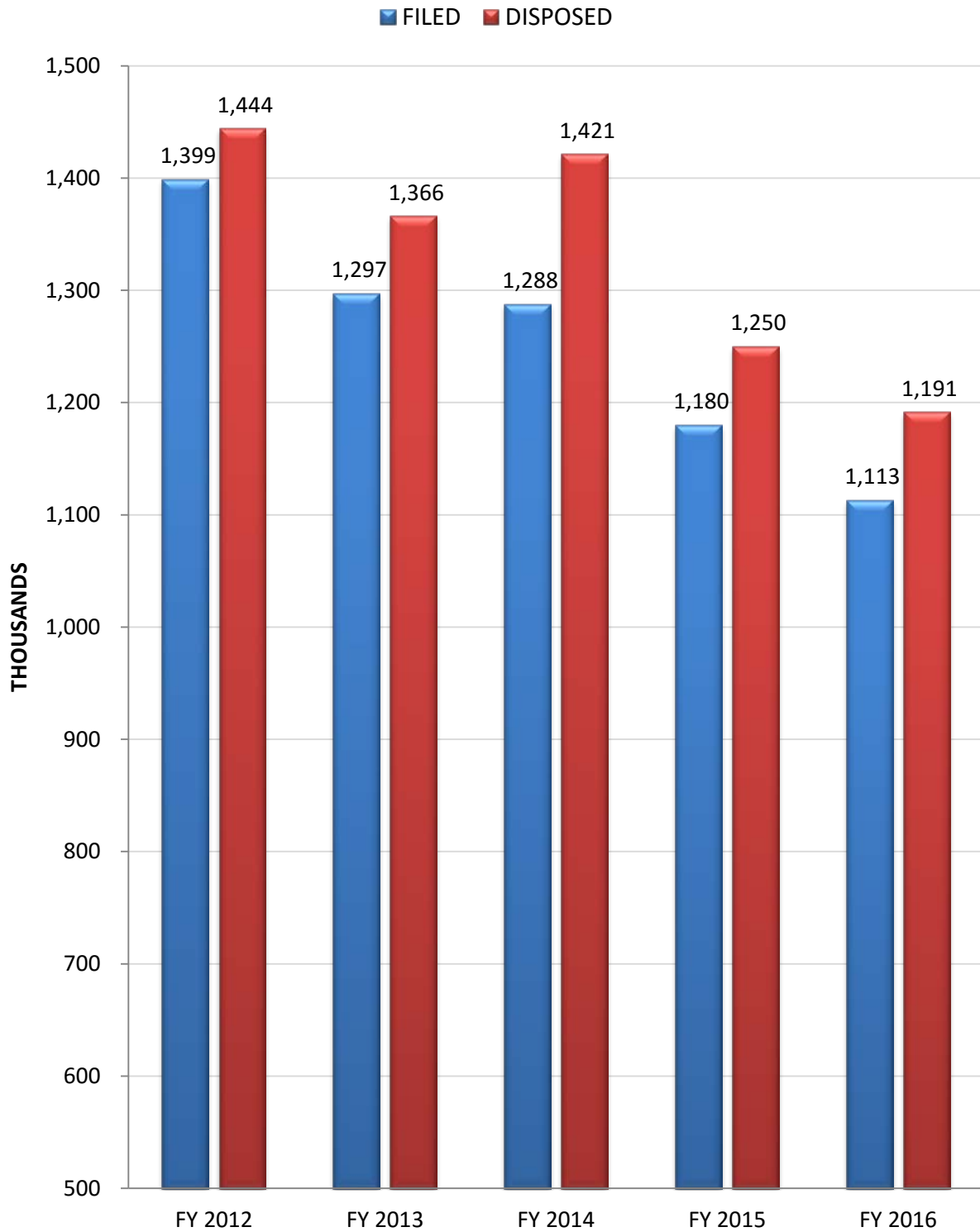

CASES FILED AND DISPOSED**



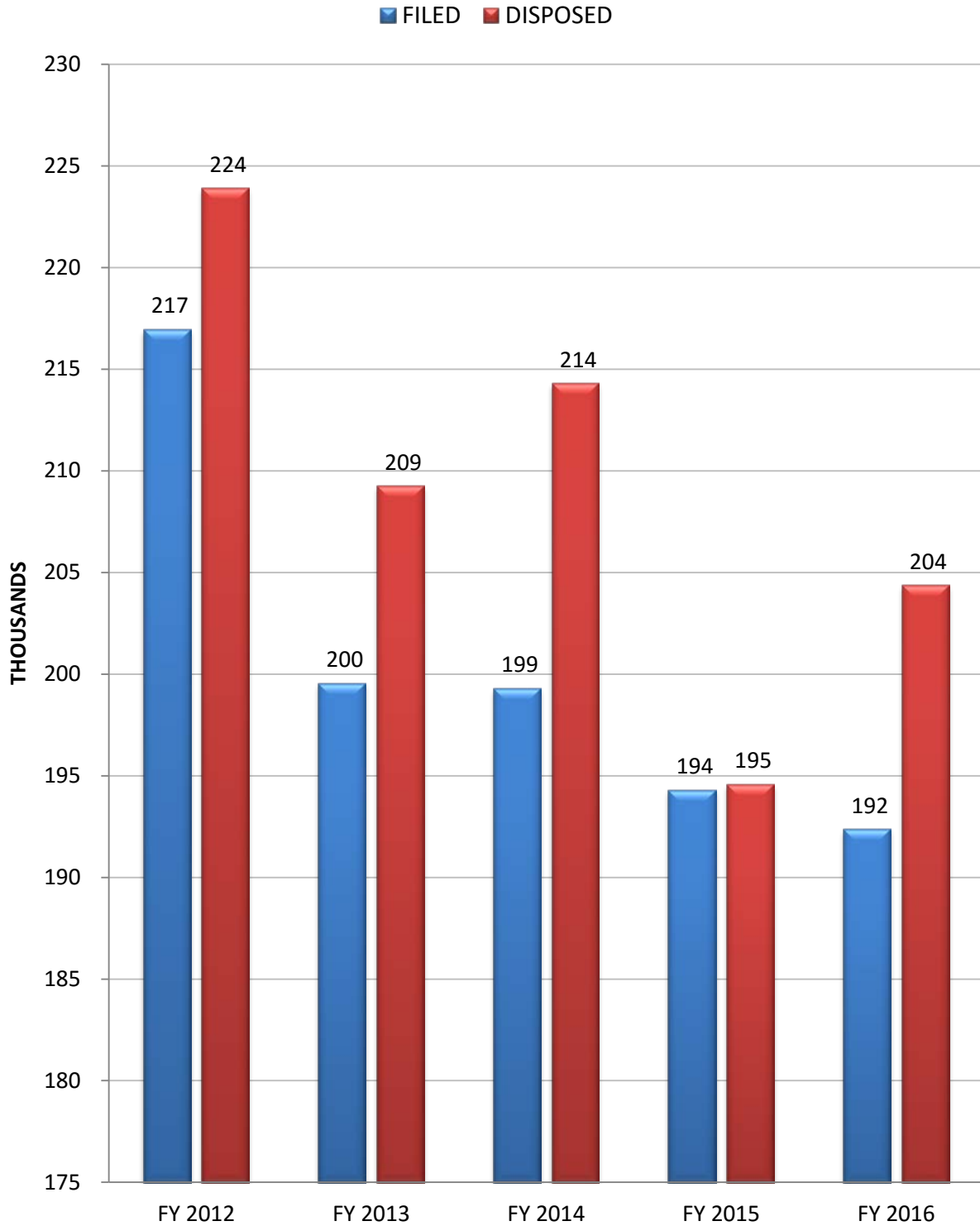

CASES FILED AND DISPOSED**



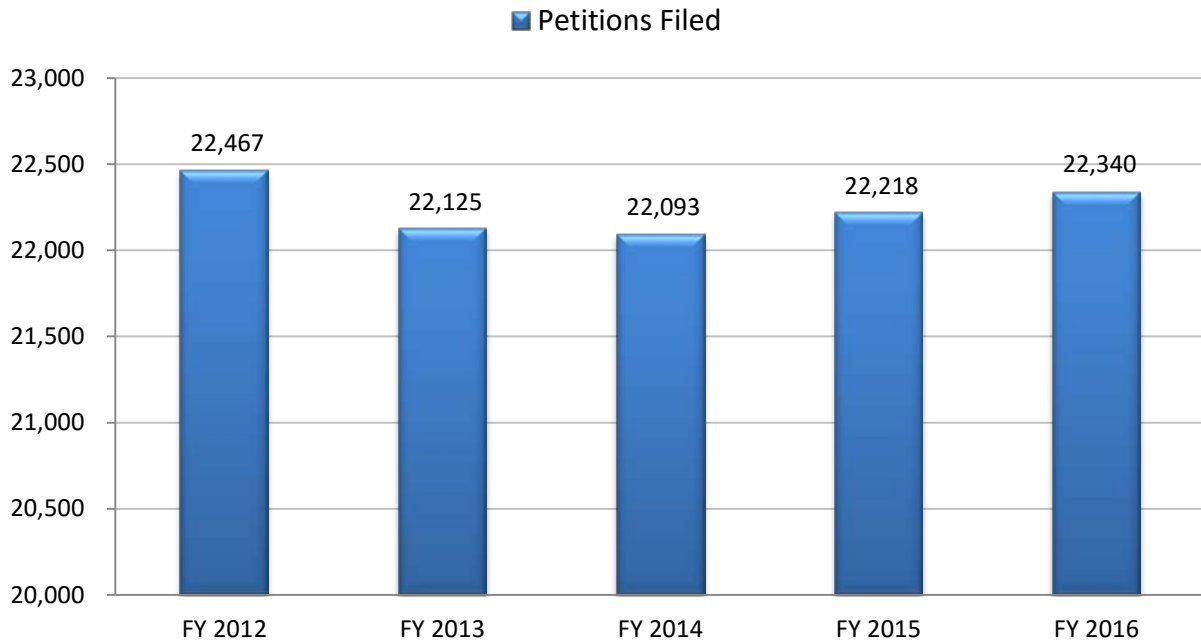

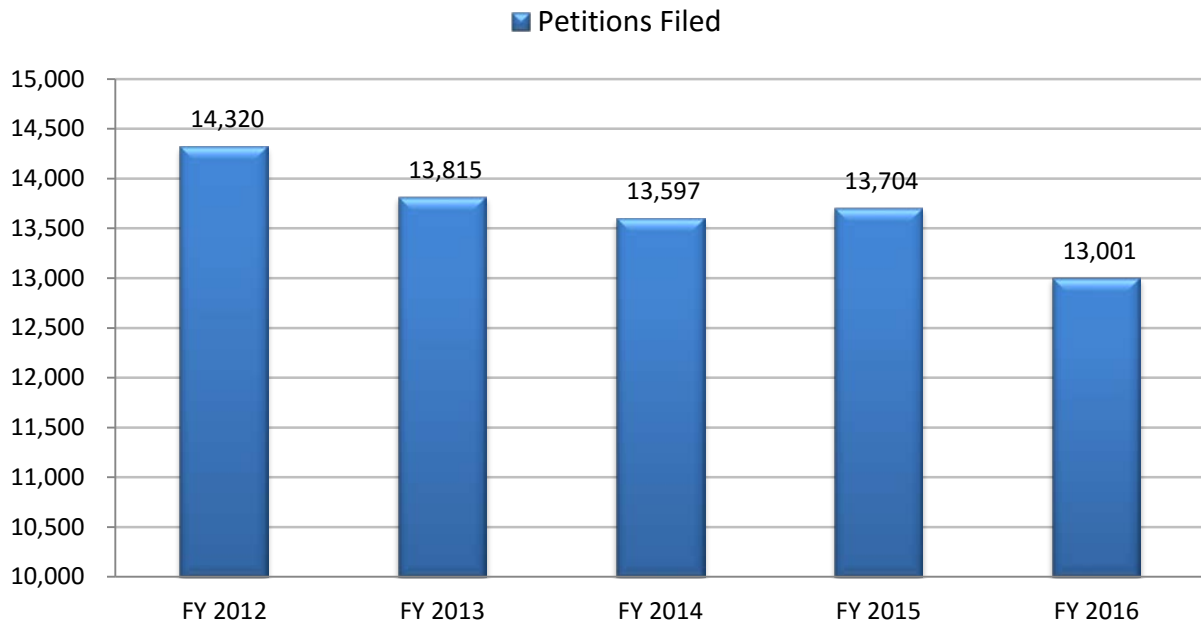
