Limited Jurisdiction Courts Narrative Summary

The limited jurisdiction summary illustrates all court positions in Justice of the Peace and Municipal Courts as of June 30, 2016, including positions funded from both primary and non-primary budget sources. The information was reported by the individual courts in response to the Supreme Court personnel survey which was electronically distributed in June 2016.

The total number of full-time positions in the Limited Jurisdiction Courts decreased by 16 positions from 1,819 in FY 2015 to 1,803 in FY 2016. There were 800 full-time positions in the Justice Courts in FY 2016, compared with 799 the previous year. Full-time positions in the Municipal Courts decreased from 1,020 the previous fiscal year to 1,003 in FY 2016.

The Limited Jurisdiction Courts employed an additional 484 part-time personnel in FY 2016, compared to 480 in FY 2015, an increase of 4 positions. The Justice Courts employed 164 part-time personnel and the Municipal Courts employed 317 part-time personnel in FY 2016.

The Limited Jurisdiction Courts also received assistance from 81 regular volunteers in FY 2016. Volunteers include non-professionals and professionals who serve in various capacities, from support staff to on-call magistrates. The Justice Courts utilized 35 regular volunteers, while the Municipal Courts received assistance from 46 volunteers.

Additionally, the Limited Jurisdiction Courts utilized 38,336 hours of temporary personnel assistance during FY 2016. The Justice Courts used 24,096 hours of temporary personnel, while the Municipal Courts used 14,240 hours.

Some of the FY 2015 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the report.
