Limited Jurisdiction Courts Narrative Summary

The revenue data provided here are for the Limited Jurisdiction Courts of Arizona. The figures were compiled from monthly revenue surveys submitted to the Supreme Court during fiscal year 2016. Major revenue categories shown represent monies collected from four sources:

- **FINES, SANCTIONS, FORFEITURES:** Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that were forfeited;
- **SURCHARGES:** Revenue from monetary assessments authorized by statute above and beyond criminal and traffic penalties and certain civil and other fees;
- **FEES:** Revenue from collectible fees for services of the court and chargeable aspects of case processing; and,
- **OTHER REVENUE:** Revenue from sources not otherwise specified.

Revenue collected from Limited Jurisdiction courts decreased from \$280,664,032 in FY 2015 to \$270,280,008 in FY 2016, a decrease of 3.7%. Justice Court revenue increased from \$102,733,301 in FY 2015 to \$103,499,015 in FY 2016, while Municipal Court revenue decreased 6.3% from \$177,930,731 in FY 2015 to \$166,780,993 in FY 2016.

The fines category is the largest with \$106,638,956 collected during FY 2016, accounting for 39.5% of the total limited jurisdiction court revenue. Most of these fines (\$69,363,935 or 65.0%) were assessed in Municipal Courts. Surcharges accounted for 26.1% of the total limited jurisdiction court revenue with \$70,526,230 collected during FY 2016. Combined fine and surcharge revenue decreased 6.4% from \$189,295,316 in FY 2015 to \$177,165,186 in FY 2016. An additional \$93,062,445 was collected during FY 2016 for revenue originating from court fees. The majority of fee revenue is collected by the municipal courts (\$53,095,372 or 57.1%).

Maricopa and Pima County Justice Courts comprise 55.3% of all justice court revenue. Municipal courts from these two counties constitute 83.6% of all municipal court revenue. The two largest municipal courts--Phoenix and Tucson--not only account for 32.6% of all municipal court revenue, but 20.1% of the revenue from all Arizona limited jurisdiction courts.

The Annual Trust Money Collection Summaries show that the limited jurisdiction courts processed \$39,037,859 in "pass-through" trust monies during FY 2016, most of which were for bail bonds.

Some of the FY 2015 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report. Revenue reports received from courts are checked for mathematical accuracy, but are not audited by the Supreme Court.
