

SUPERIOR COURT Narrative Summary

The Superior Court is the state's only general jurisdiction trial court. Arizona's Superior Court has 15 branches, one for each county in the state. Superior Court has jurisdiction over all cases except small claims, petty offenses and violations of city ordinance/codes. The Superior Court also acts as an appellate court for justice and municipal courts.

Total filings (including transfers in) decreased 1.0%, from 190,611 in FY 2015 to 188,720 this fiscal year. Civil filings, which decreased 6.2% from FY 2015 to FY 2016, account for the majority of the overall decrease in filings. During the same period, Probate and Mental Health filings increased 8.3% and 9.5%, respectively. There was no significant change in filings for the Criminal and Domestic Relations categories during FY 2016.

Criminal filings account for the largest portion of the total filings in Superior Court statewide (27.3%). During FY 2016, 51,599 Criminal cases were filed, a difference of only 50 cases from the previous fiscal year. The second largest category, Domestic Relations, also maintained the same level of filings in FY 2016 as compared with FY 2015.

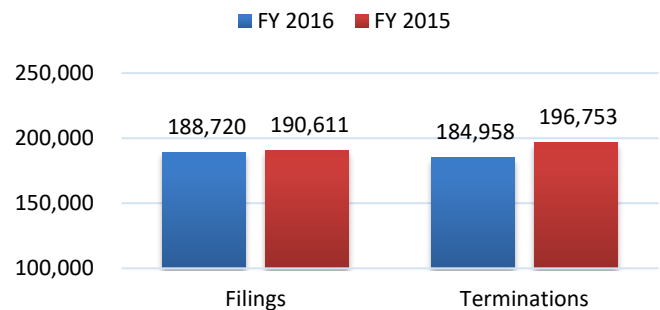
Within the Juvenile case type, Delinquency cases decreased 9.6%, while Adoption cases increased 7.1% and Dependency cases were about the same. Mental Health filings increased by 9.5% or 698 filings, from 7,334 in FY 2015 to 8,032 in FY 2016.

Petitions for Orders of Protection decreased 3.2%, from 12,991 in FY 2015 to 12,569 in FY 2016. Petitions for Injunctions Against Harassment increased 11.0%, from 3,224 in FY 2015 to 3,579 in FY 2016. Of the total protective orders filed, 85.0% of Orders of Protection were issued and 85.6% of Injunctions Against Harassment were issued.

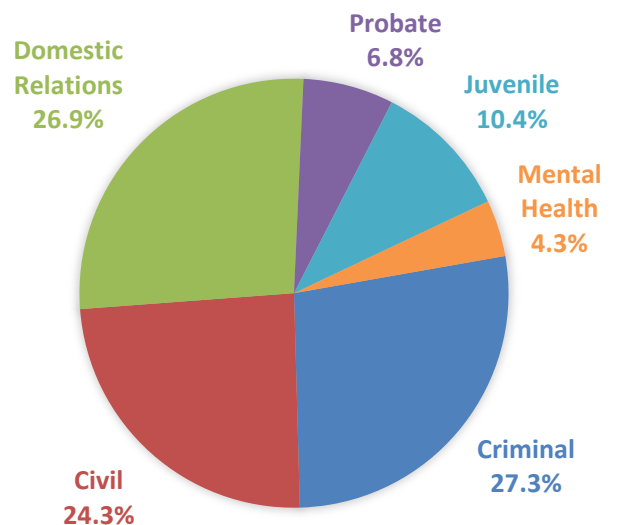
Total dispositions (including transfers) decreased 6.0% from 196,753 in FY 2015 to 184,958 in FY 2016. As of June 30, 2016, there were 214,534 cases pending, an increase of 2.7% over the 208,944 pending at the end of FY 2015.

Superior Court held 5,962 trials during FY 2016 compared to 5,425 in FY 2015. Of the trials in FY 2016, 4,714 (79.1%) were court trials and 1,248 (20.9%) were jury trials. Of the court trials, 93.2% were for domestic relations cases, 3.7% for Civil, 2.7% for Criminal and the remaining were appeals from the limited jurisdiction courts. Of the jury trials held, 81.2% were criminal trials and 18.8% were civil trials.

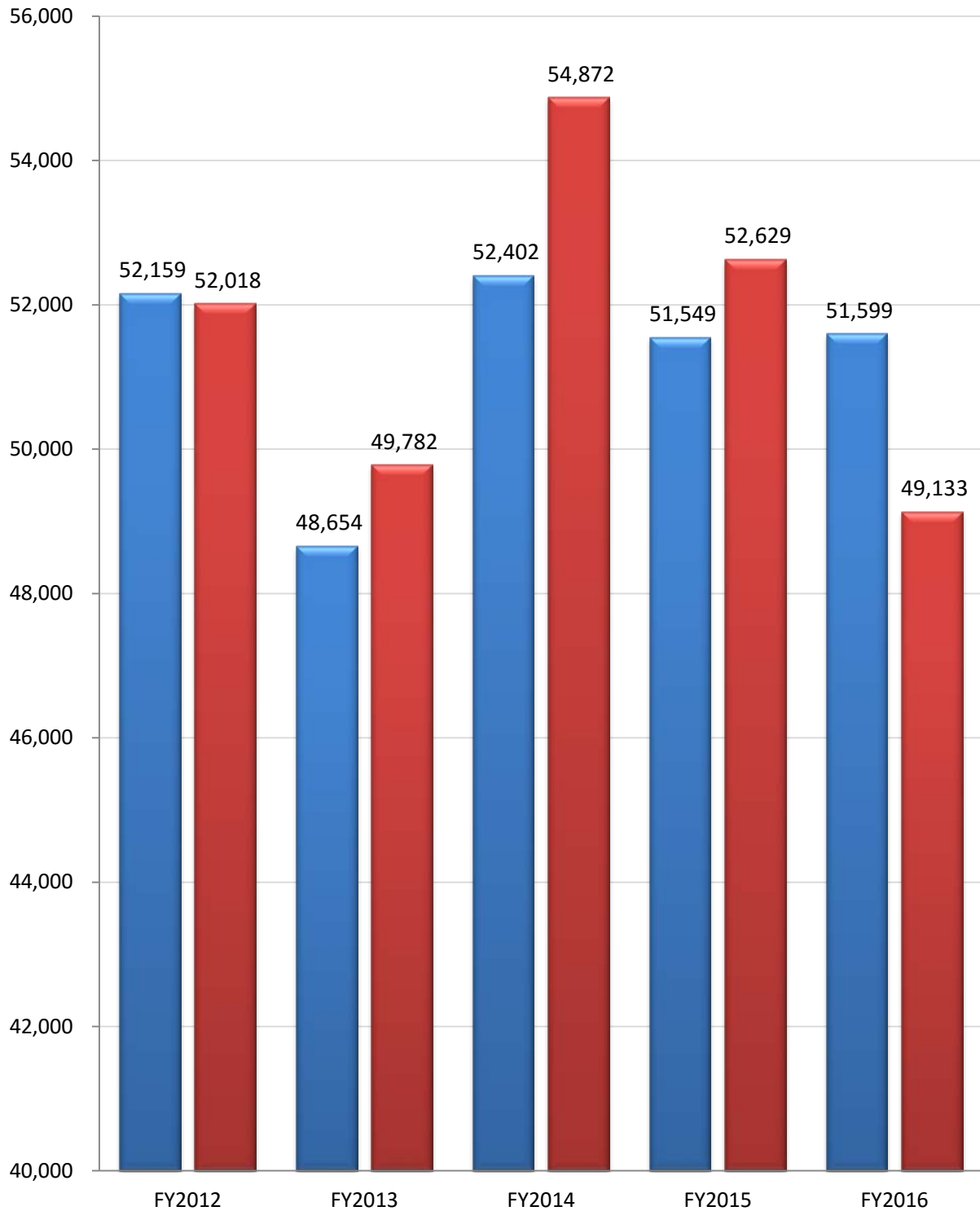

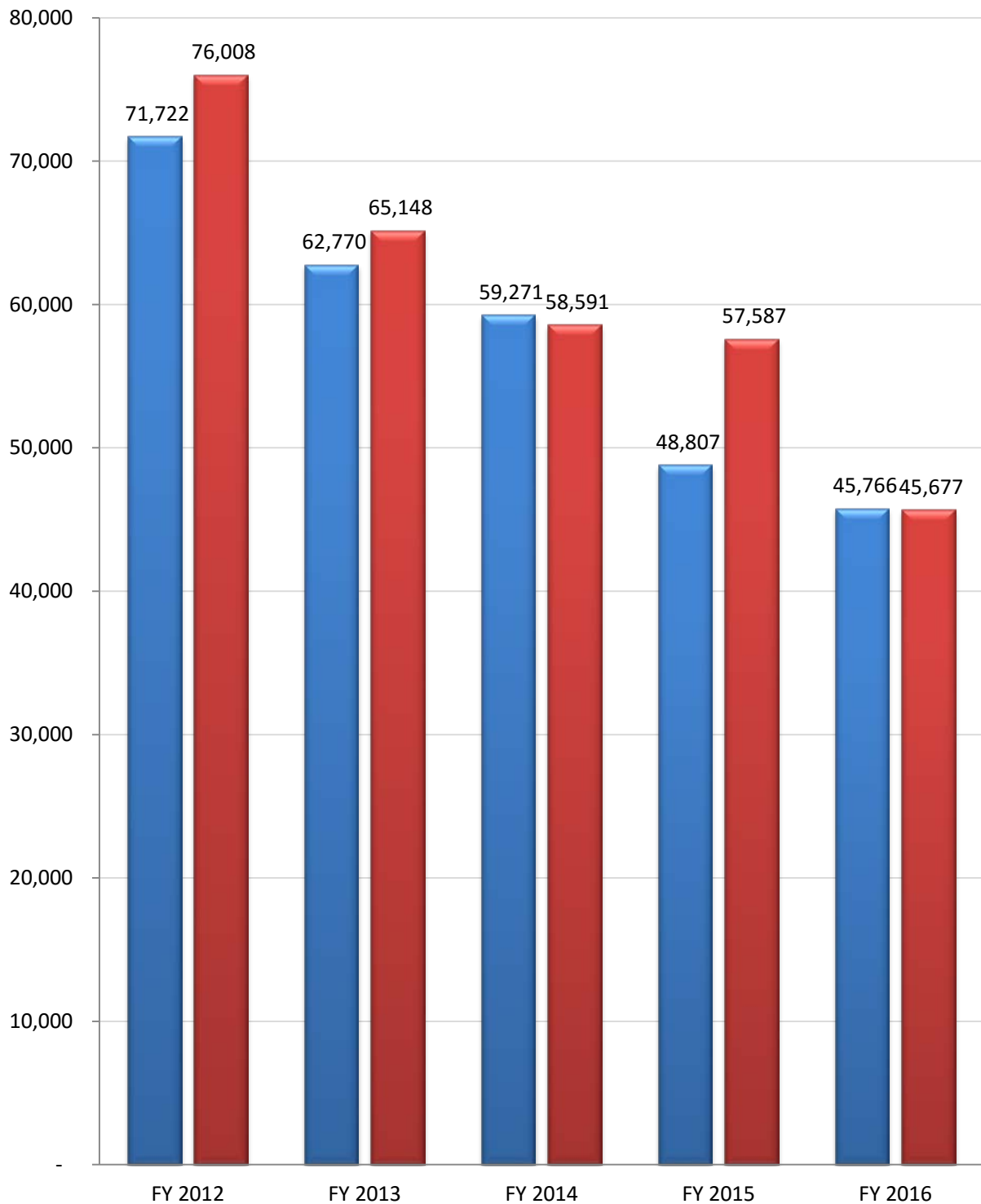

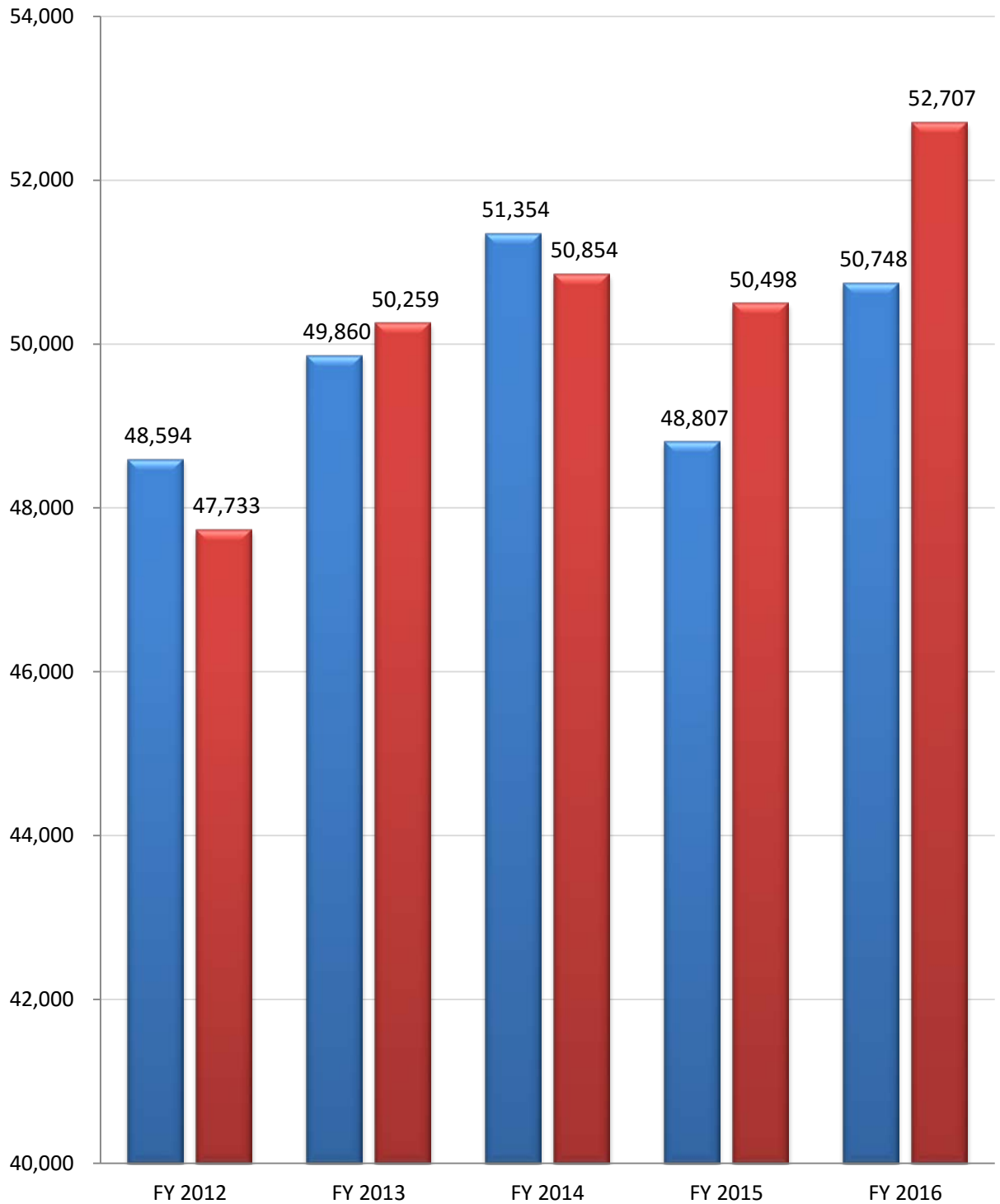

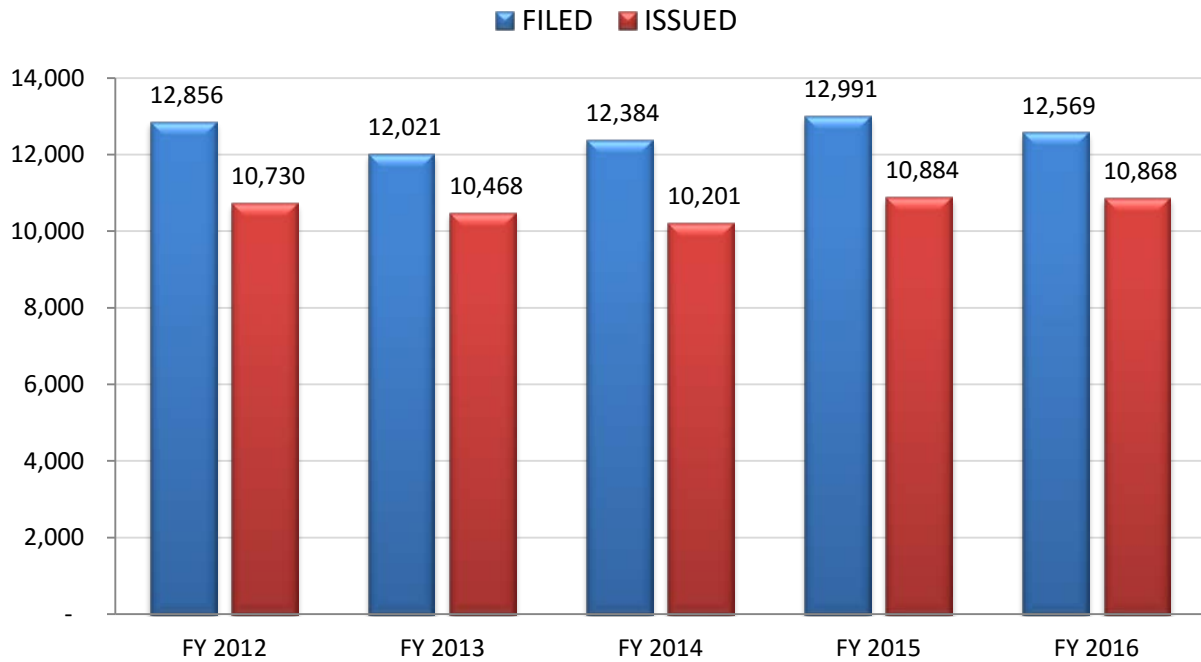

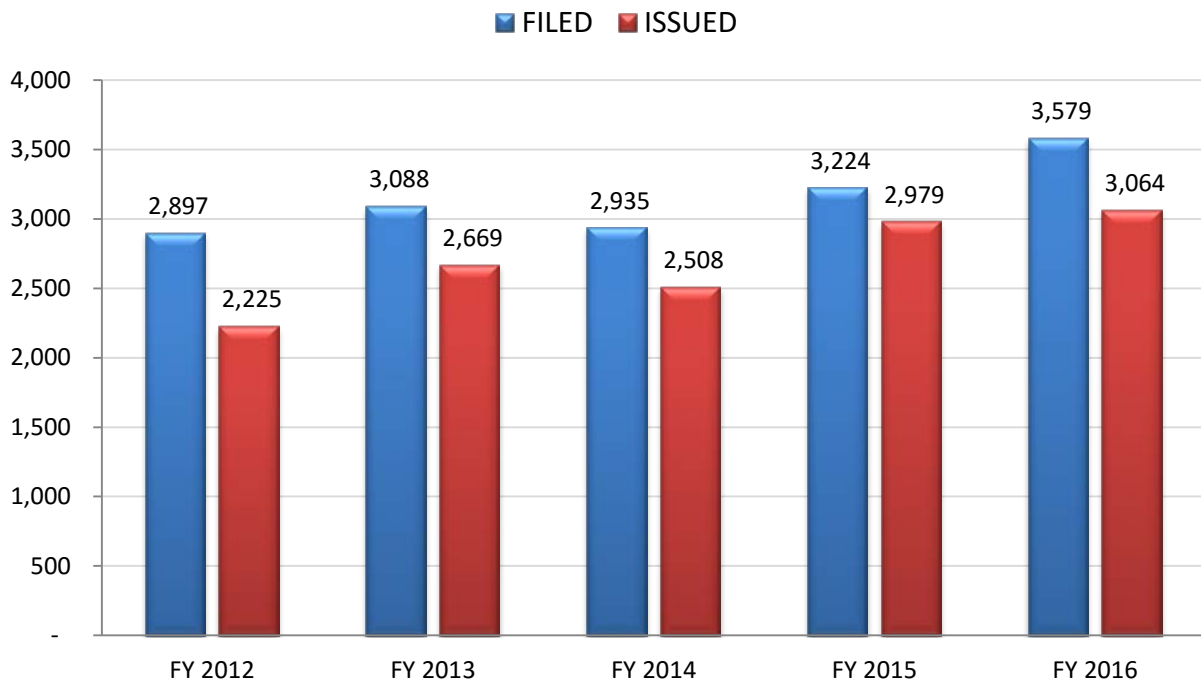
