

SUPERIOR COURT Narrative Summary

The Superior Court is the state's only general jurisdiction trial court. Arizona's Superior Court has 15 branches, one for each county in the state. Superior Court has jurisdiction over all cases except small claims, petty offenses and violations of city ordinance/codes. The Superior Court also acts as an appellate court for justice and municipal courts.

Total filings (including transfers in) increased from 188,720 in FY 2016 to 190,158 this fiscal year. Probate, Mental Health, and Domestic Relations categories all saw increased filings from last fiscal year. While Criminal, Civil, and Juvenile categories experienced a decrease in filings.

During FY 2017, Domestic Relations cases accounted for most filings with 27.2% of the total filing caseload. Criminal and Civil filings account for 26.2% and 23.8%, respectively. Mental health filings continue to increase and now account for 5.4% of the total case filings during FY 2017.

Beginning with FY 2017, the Supreme Court began collecting more detailed data for the Criminal case categories. Category ranking is determined by the most severe charge on the case for the defendant. Table 1 illustrates the distribution of felony case filings by primary case type at filing. During FY 2017, most defendants with felony filings were charged with drug and property crimes.

Within the Juvenile case type, Adoption case filings increased 18.5% while Dependency cases decreased 9.6%, while Delinquency filings decreased slightly. Within the Civil category, Tort Motor and Contract filings increased 15.4% and 16.7%, respectively. While Non-classified, Eminent Domain, and Medical Malpractice filings all saw decreased filings compared to last fiscal year.

Petitions for Orders of Protection increased 1.7%, from 12,569 in FY 2016 to 12,778 in FY 2017. Petitions for Injunctions Against Harassment increased 3.9%, from 3,579 in FY 2016 to 3,717 in FY 2017. Of the total protective orders adjudicated, 86.6% of Orders of Protection and 82.3% of Injunctions Against Harassment were issued.

Total dispositions (including transfers) increased 1.3% from 184,958 in FY 2016 to 187,280 in FY 2017. As of June 30, 2017, there were 191,837 cases pending, a decrease of 10.6% from the 214,534 pending at the end of FY 2016.

Superior Court held 5,879 trials during FY 2017 compared to 5,989 in FY 2016. Of the trials in FY 2017, 4,879 (83.0%) were court trials and 1,000 (17.0%) were jury trials. Of the court trials, 93.5% were for domestic relations cases, 3.8% for Civil, 2.3% for Criminal and the remaining were appeals from the limited jurisdiction courts. Of the jury trials held, 79.5% were criminal trials and 20.5% were civil trials.

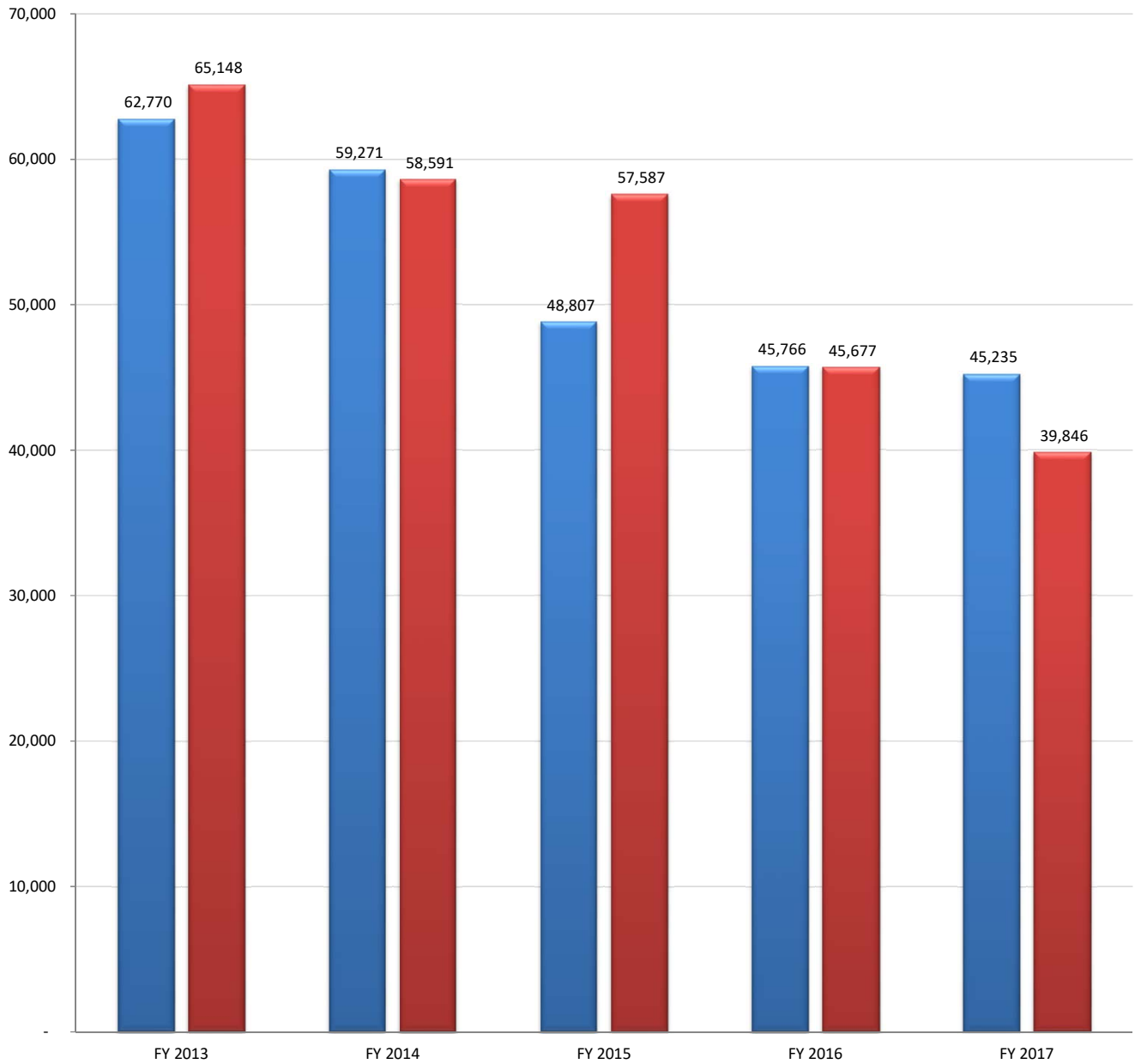

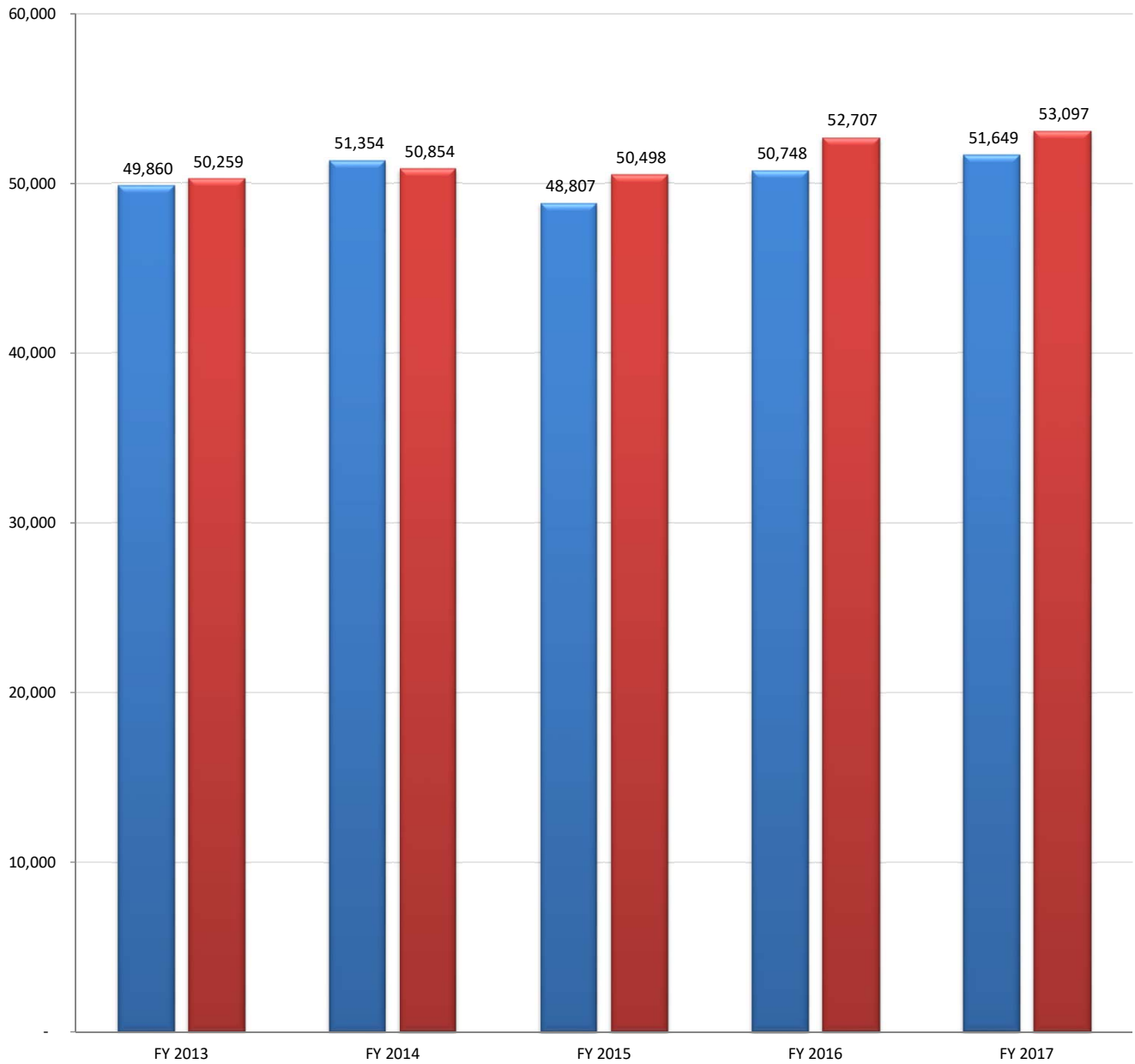

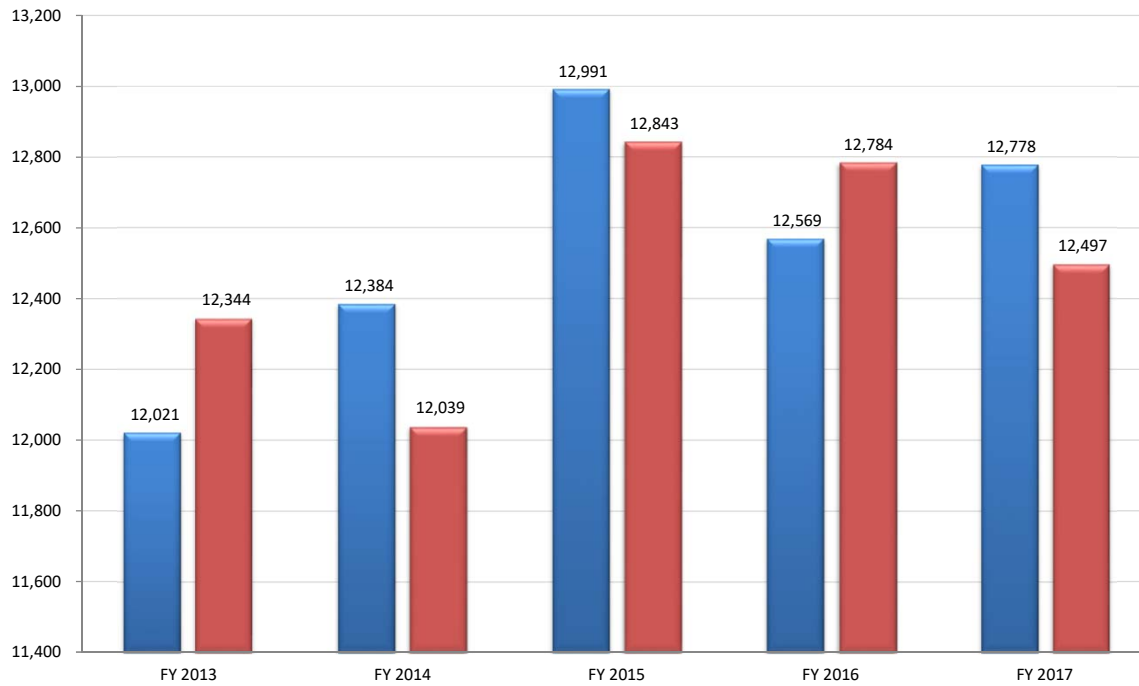

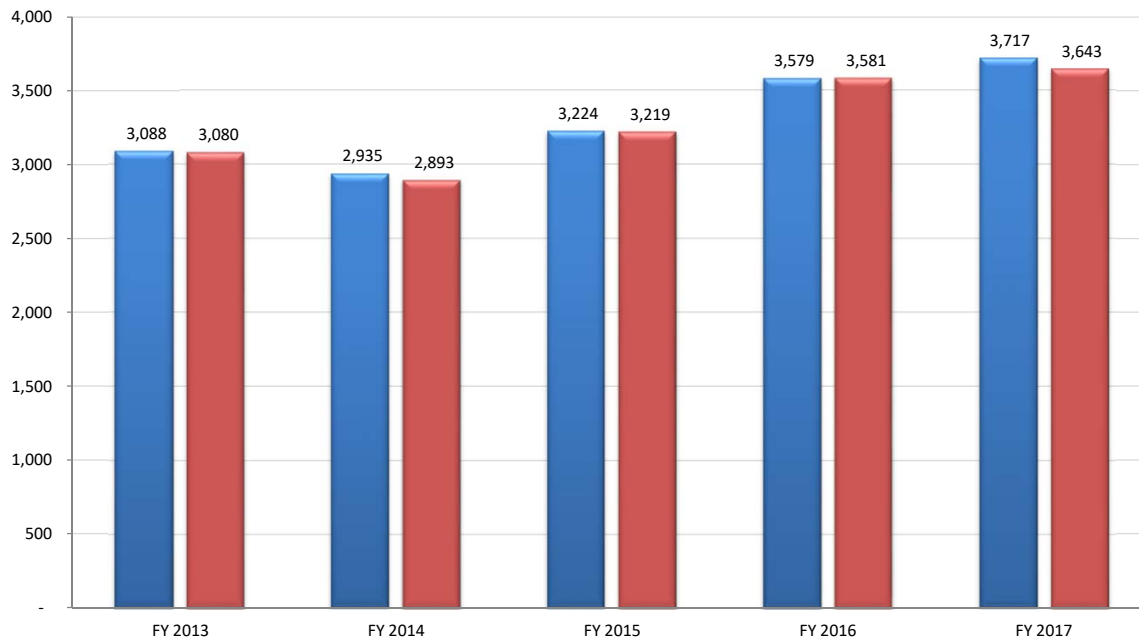
