

COURT PERSONNEL

Appellate and Superior Court Narrative Summary

The annual personnel summary shows all Appellate Court, Superior Court and Adult/Juvenile Probation positions as of June 30, 2018, including positions funded from both primary and non-primary budget sources. The information was reported by the individual courts in response to the Supreme Court personnel survey distributed in June 2018.

The total number of full-time funded positions in the Supreme Court increased by 4 positions, from 500 in FY 2017 to 504 in FY 2018. Most of the full-time employees in the Supreme Court work for the Administrative Office of the Courts (454 of the 504). Court of Appeals full time employees (both divisions) decreased from 137 to 132 positions during FY 2018. Full-time employees in Superior Court (including the clerk's office) increased from 3,274 to 3,306 this fiscal year, an increase of 32 positions or less than 1%. Superior Court Probation (comprising adult, juvenile, and combined departments) full-time employees increased from 3,571 in FY 2017 to 3,656 in FY 2018, an increase of 2.4%.

The Supreme Court and Court of Appeals had the services of 1,932 regular volunteers in FY 2018. The Superior Court had the services of 772 regular volunteers, while Superior Court Probation reported 521 regular volunteers. These volunteers include professionals and non-professionals who serve in many different capacities. In the Supreme Court, the regular volunteers are comprised of Court Appointed Special Advocates (CASA) and members of the Foster Care Review Board (FCRB).

Additionally, the Supreme Court utilized 1,456 hours of temporary personnel assistance while the Superior Court utilized 117,708 hours of temporary personnel assistance. Superior Court Probation utilized 68,370 hours of temporary personnel assistance.

Some of the FY 2017 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.
