

## **COURT PERSONNEL**

### **Limited Jurisdiction Courts Narrative Summary**

The limited jurisdiction summary illustrates all court positions in Justice of the Peace and Municipal Courts as of June 30, 2018, including positions funded from both primary and non-primary budget sources. The information was reported by the individual courts in response to the Supreme Court personnel survey which was electronically distributed in June 2018.

The total number of full-time positions in the Limited Jurisdiction Courts decreased by 20 positions from 1,820 in FY 2017 to 1,800 in FY 2018. There were 807 full-time positions in the Justice Courts in FY 2018, compared with 821 the previous year. Full-time positions in the Municipal Courts decreased from 999 the previous fiscal year to 993 in FY 2018.

The Limited Jurisdiction Courts employed 461 part-time personnel in FY 2018, compared to 472 in FY 2017, a decrease of 11 positions. The Justice Courts employed 132 part-time personnel and the Municipal Courts employed 329 part-time personnel in FY 2018.

The Limited Jurisdiction Courts also received assistance from 181 regular volunteers in FY 2018. Volunteers include non-professionals and professionals who serve in various capacities, from support staff to on-call magistrates. The Justice Courts utilized 30 regular volunteers, while the Municipal Courts received assistance from 151 volunteers.

Additionally, the Limited Jurisdiction Courts utilized 31,370 hours of temporary personnel assistance during FY 2018. The Justice Courts used 20,314 hours of temporary personnel, while the Municipal Courts used 11,056 hours.

Some of the FY 2017 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the report.
