Limited Jurisdiction Courts Narrative Summary

The revenue data provided here are for the Limited Jurisdiction Courts of Arizona. The figures were compiled from monthly revenue surveys submitted to the Supreme Court during fiscal year 2018. Major revenue categories shown represent monies collected from four sources:

- **FINES, SANCTIONS, FORFEITURES:** Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that were forfeited;
- **SURCHARGES:** Revenue from monetary assessments authorized by statute above and beyond criminal and traffic penalties and certain civil and other fees;
- **FEES:** Revenue from collectible fees for services of the court and chargeable aspects of case processing; and,
- **OTHER REVENUE:** Revenue from sources not otherwise specified.

Revenue collected from Limited Jurisdiction courts increased from \$251,765,037 in FY 2017 to \$255,573,325 in FY 2018, an increase of 1.5%. Justice Court revenue increased 2.2%, from \$105,675,113 in FY 2017 to \$108,025,070 in FY 2018. During the same period, Municipal Court revenue increased less than 1% from \$146,089,924 to \$147,548,255.

The fines category is the largest with \$96,829,948 collected during FY 2018, accounting for 37.9% of the total limited jurisdiction court revenue. Most of these fines (\$60,754,359 or 23.8%) were assessed in Municipal Courts. Surcharges accounted for 25.3% of the total limited jurisdiction court revenue with \$64,618,751 collected during FY 2018. Combined fine and surcharge revenue decreased 1.1% from \$163,235,861 in FY 2017 to \$161,448,699 in FY 2018. An additional \$94,057,055 was collected during FY 2018 for revenue originating from court fees. The majority of fee revenue is collected by the municipal courts (\$47,490,806 or 50.5%).

Maricopa and Pima County Justice Courts comprise 57.2% of all justice court revenue. Municipal courts from these two counties constitute 83.3% of all municipal court revenue. The two largest municipal courts--Phoenix and Tucson--not only account for 29.4% of all municipal court revenue, but 17.0% of the revenue from all Arizona limited jurisdiction courts.

The Annual Trust Money Collection Summaries show that the limited jurisdiction courts processed \$35,288,931 in "pass-through" trust monies during FY 2018, most of which were for bail bonds.

Some of the FY 2017 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report. Revenue reports received from courts are checked for mathematical accuracy, but are not audited by the Supreme Court.
