

ARIZONA COURT REVENUE
Limited Jurisdiction Court Narrative Summary
State Fiscal Year 2019

The revenue data for Arizona's limited jurisdiction (LJ) courts, which are comprised of both justice and municipal courts, are summarized in this report. The figures were compiled from monthly revenue surveys submitted to the Supreme Court during the state fiscal year (FY) 2019. The major revenue categories represent monies collected from four sources:

- **FINES, SANCTIONS, FORFEITURES:** Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that were forfeited;
- **SURCHARGES:** Revenue from monetary assessments authorized by statute in addition to criminal and traffic penalties and certain civil and other fees;
- **FEES:** Revenue from collectible fees for services of the court and chargeable aspects of case processing; and,
- **OTHER REVENUE:** Revenue from sources not otherwise specified.

Revenue collected from limited jurisdiction courts decreased from \$255,419,972 in FY 2018 to \$250,228,235 in FY 2019, a slight percent decrease of 2.0%. The justice court revenue decreased slightly by 1.1%, from \$107,871,717 in FY 2018 to \$106,653,151 in FY 2019. During the same period, municipal court revenue decreased 2.7% from \$147,548,255 to \$143,575,084. Combined fine and surcharge revenue decreased 2.6% from \$161,294,509 in FY 2018 to \$157,061,866 in FY 2019.

Revenue from fines, sanctions and forfeitures, which totaled \$95,468,730 collected during FY 2019, accounted for 38.2% of the total limited jurisdiction courts. Revenue from court fees, the second largest revenue source, accounted for 37.2% (\$93,078,970) of the total LJ court revenue. An additional \$61,593,136 (24.6%) were collected during FY 2019 for revenue originated from surcharges.

Municipal courts contributed to the largest proportion of fines (63.0% or \$60,138,055) and surcharges (60.9% or 37,535,611). About half (49.3% or \$45,874,806) of all court fees were collected by the municipal courts.

Two counties, Maricopa County and Pima County justice courts generated 57.4% of all justice court revenue. In addition, municipal courts from these two counties constituted 83.4% of all municipal court revenue. The two largest municipal courts - Phoenix and Tucson - not only accounted for 29.9% of all municipal court revenue, but 17.1% of the revenue from all Arizona limited jurisdiction courts.

The Annual Trust Money Collection Summaries show that the limited jurisdiction courts processed \$35,539,236 in "pass-through" trust monies during FY 2019, most of which were for bail bonds.

Note. Some of the FY 2018 figures may not correspond to figures published in the previous year's Data Report due to corrected information received subsequent to publication of the report. Revenue reports received from courts are checked for mathematical accuracy but are not audited by the Supreme Court.
