

ARIZONA COURT REVENUE
Statewide Narrative Summary
State Fiscal Year 2019

Statewide revenue data for all the court levels -- Supreme Court, Court of Appeals, Superior Court and the limited jurisdiction courts -- are summarized in this report. The figures were compiled from probation fee reports and the monthly revenue surveys distributed by the Supreme Court for state fiscal year (FY) 2019. Major revenue categories listed below represent monies collected from four sources:

- FINES, SANCTIONS, FORFEITURES: Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that are forfeited;
- SURCHARGES: Revenue from monetary assessments authorized by statute in addition to criminal and traffic penalties assessed and certain civil and other fees;
- FEES: Revenue from collectible fees for court services and chargeable aspects of case processing; and,
- OTHER REVENUE: Revenue from sources not otherwise specified.

Annual Revenue Summary

Total revenue collected by the Arizona courts declined slightly (0.9%), from \$347,644,860 in FY 2018 to \$344,350,702 in FY 2019. Statewide, the courts collected \$108,853,148 in fines, sanctions, and bond forfeitures during FY 2019, a decrease of 1.1% from \$110,105,180 collected in FY 2018. Revenue from court surcharges decreased from \$68,849,217 in FY 2018 to \$65,663,156 in FY 2019 (a 4.3% decline). Fee revenue slightly increased from \$167,620,547 in FY 2018 to \$168,261,983 in FY 2019 (a 0.4% decline).

In FY 2019, revenue collected from court fees made up the largest portion of statewide court revenue comprising 48.9% of the total. Revenue from fines, sanctions and forfeitures accounted for 31.6% of state revenues and court surcharges accounted for 19.1% of the total statewide revenue collected in FY 2019. The municipal courts generated the largest proportion of total statewide court revenue: 41.7% (\$143,575,084). The justice courts generated 31% (\$106,654,148) and the Superior Court generated 25.9% (\$89,190,096) of the annual court revenue.

Revenue Distribution Summary

According to the revenue distribution summary, 42.4% of the FY 2019 court revenue was distributed to the state, 34.8% to counties and 22.9% to municipalities.

Trust Money Collection Summary

The Arizona courts processed \$142,886,985 in "pass-through" trust monies, of which restitution accounted for \$21,372,904 of the total. The majority (45.3%) of trust monies were collected from bail bonds.

A central support payment clearinghouse was established in FY 1998 to assume responsibility for receiving, disbursing and monitoring child support payments, pursuant to Title IV-D of the Social Security Act. All child support payments collected by the courts are turned over to the Arizona Department of Economic Security. The Superior Court collected \$9,285,426 in child support during FY 2019, a 5.0% decrease from FY 2018.

Note. Some of the FY 2018 figures may not correspond to figures published in the previous year's Data Report due to corrected information received subsequent to publication of the Report. Revenue reports received from courts are checked for mathematical accuracy but are not audited by the Supreme Court.
