

ARIZONA SUPERIOR COURTS
Narrative Summary
Fiscal Year 2019

The Superior Court is the state’s general jurisdiction trial court. Arizona’s Superior Court has 15 branches, one for each county in the state. Superior Court has jurisdiction over all cases except small claims, petty offenses and violations of city ordinance/codes. The Superior Court also acts as an appellate court for Justice and Municipal Courts.

Total Case Activity

Total filings (including transfers in), increased slightly by 2.5% from 204,993 in state fiscal year (FY) 2018 to 210,083 in FY 2019. Criminal and Domestic Relations experienced an increased in filings; whereas, Civil and Juvenile had a decrease in filings.

Civil Case Type

Civil filings, which includes real property and probate/estate filings, accounted for 34.9% of the case filings. Within the Civil category, Tort Motor decreased by 4.2% while and Contract filings increased slightly by 2.3%.

Domestic Relations

During FY 2019, Domestic Relations cases, which includes protective order petitions, accounted for 32.8% of the filing caseload. Mental Health filings accounted for 5.3% of the total case filings during FY 2019.

Criminal Case Type

Criminal filings accounted for 26.1% of case files. Table 1 illustrates the distribution of felony case filings by primary case type at filing. During FY 2019, drug charges were the most frequently occurring case type, accounting for 46.4% of defendants with felony filings.

Juvenile Case Type

Juvenile case filings accounted for 6.2% of total case files. Dependency case filings increased by 5.4%, while delinquent/incorrigible case filing decreased by 5.8%.

Dispositions

Total dispositions (including transfers) increased 4.1% from 202,921 in FY 2018 to 211,203 in FY 2019.

Protective Orders

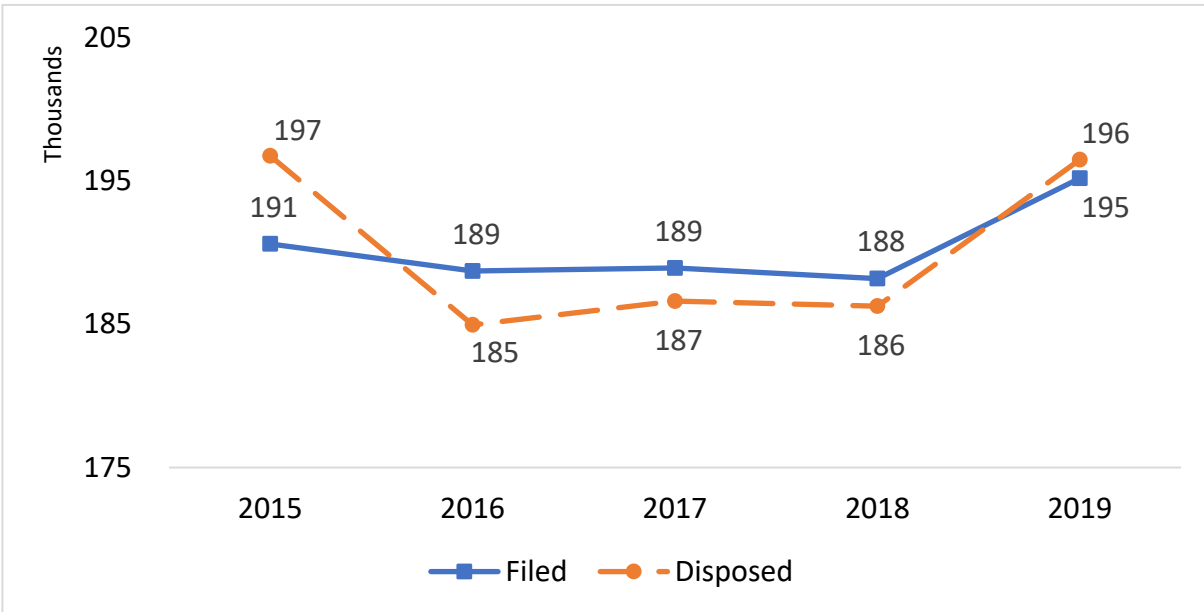
Petitions for both Orders of Protections and Injunctions Against Harassment accounted for 7.5% of the total case filings. Petitions for Orders of Protection increased 9.6%, from 11,145 in FY 2018 to 12,214 in FY 2019. Conversely, petitions for Injunctions Against Harassment decreased by 7.7%, from 3,760 in FY 2018 to 3,469 in FY 2019.

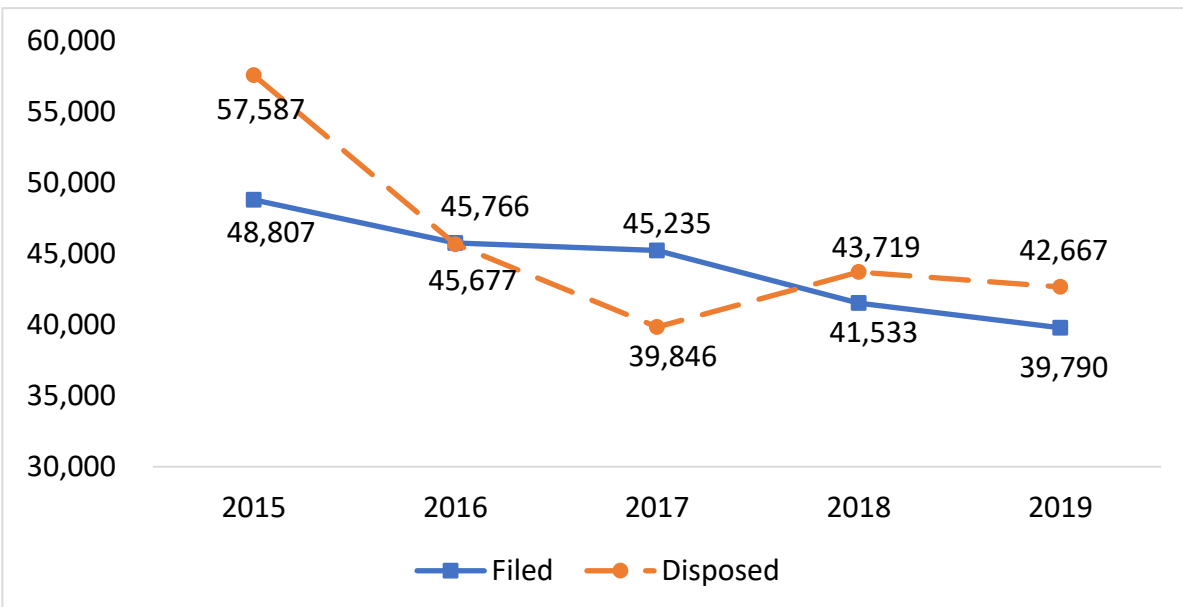
*Superior Court Filed and Disposed **Annual** Case Files from FY 2015 to FY 2019*

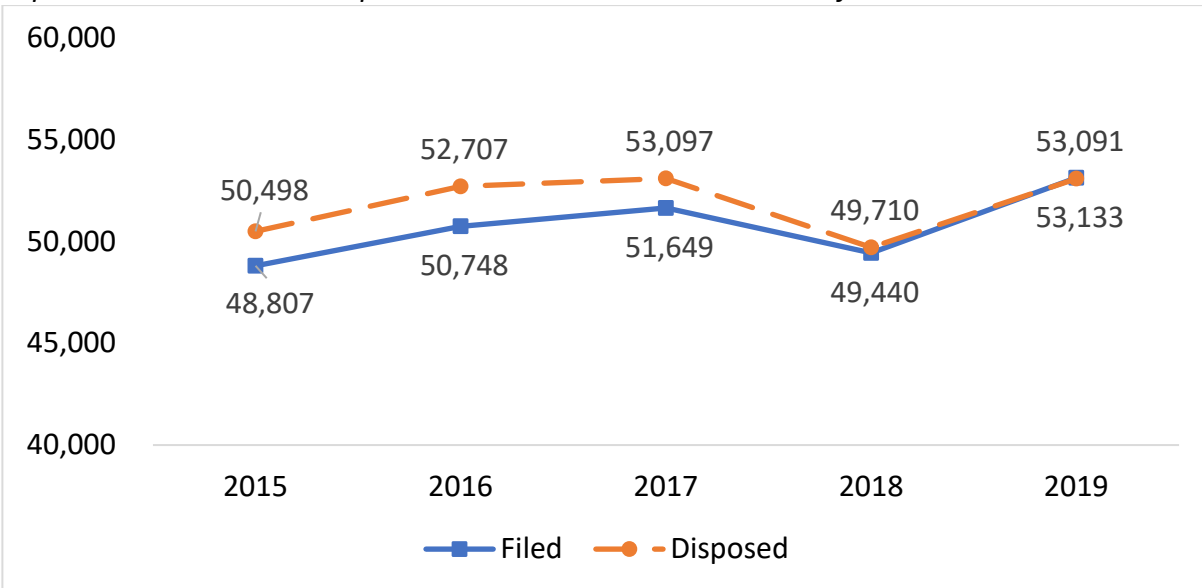
*Superior Court Filed and Disposed **Civil** Case Files from FY 2015 to FY 2019*

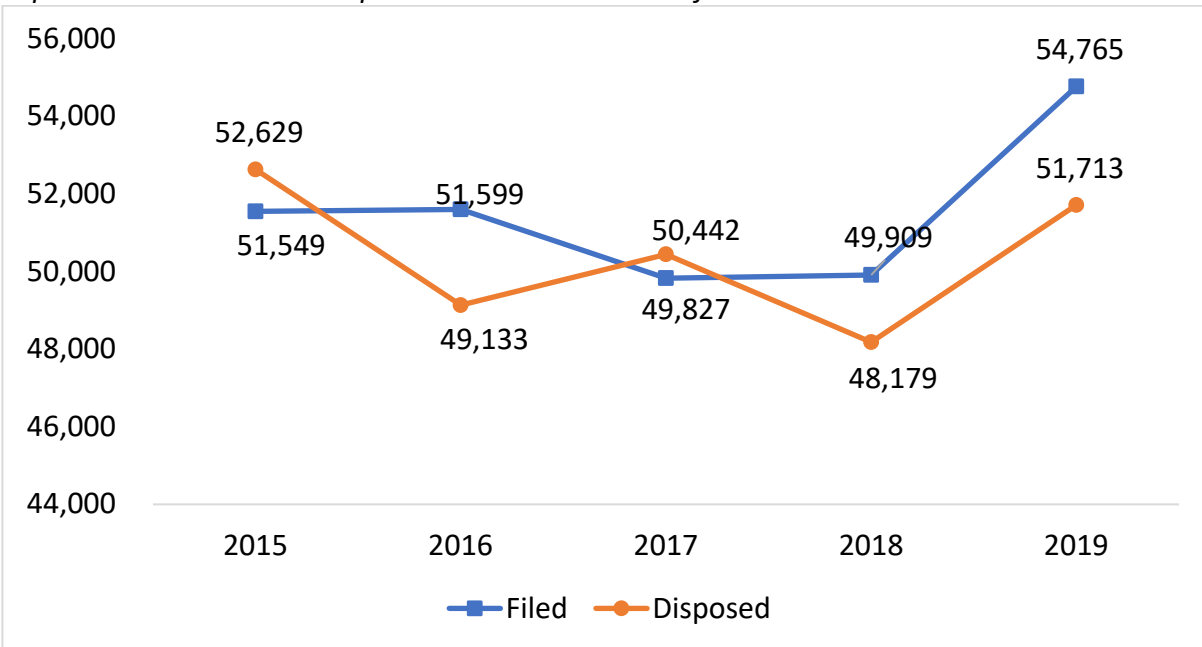
Superior Court Filed and Disposed **Domestic Relations** Case Files from FY 2015 to FY 2019

Superior Court Filed and Disposed **Criminal** Case Files from FY 2015 to FY 2019

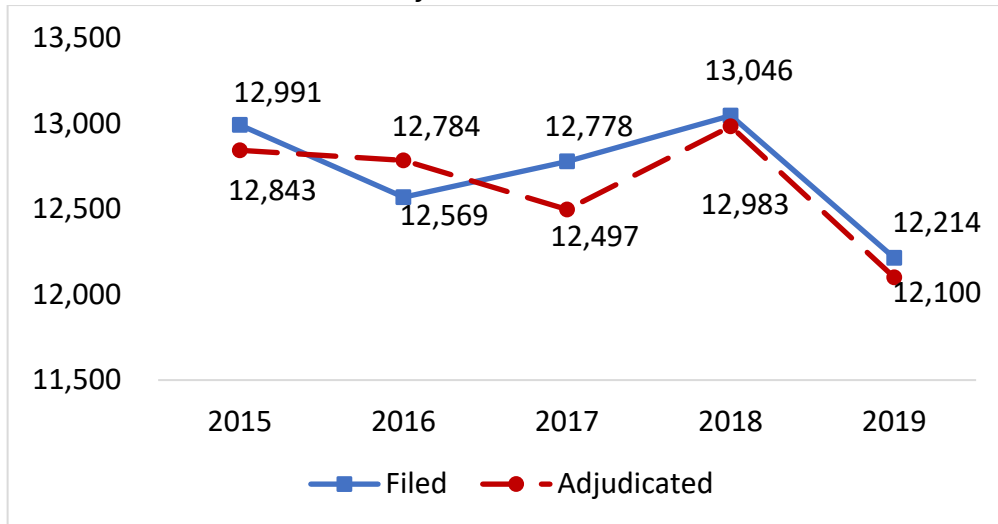

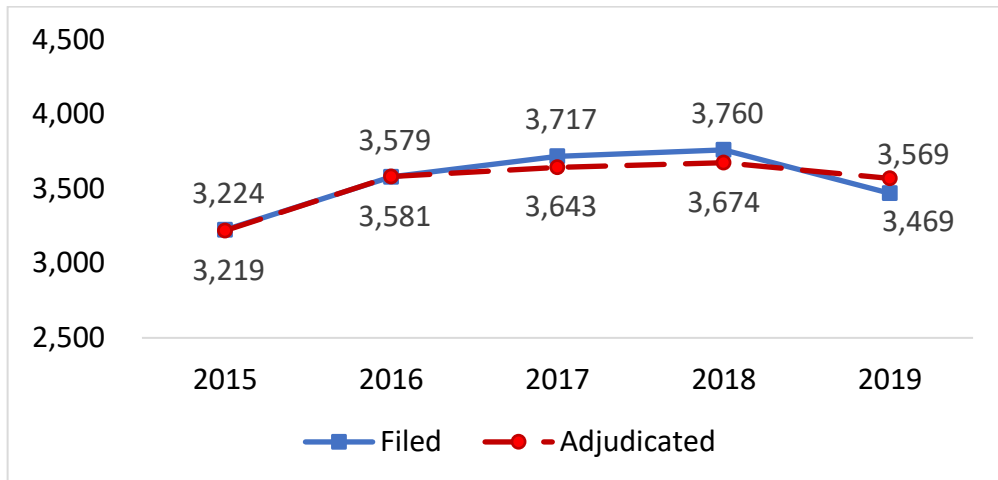
