

**ARIZONA COURT REVENUE**  
**Limited Jurisdiction Court Narrative Summary**  
**State Fiscal Year 2020**

The revenue data for Arizona's limited jurisdiction (LJ) courts, which are comprised of both justice and municipal courts, are summarized in this report. The figures were compiled from monthly revenue surveys submitted to the Supreme Court during the state fiscal year (FY) 2020. The major revenue categories represent monies collected from four sources:

- **FINES, SANCTIONS, FORFEITURES:** Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that were forfeited;
- **SURCHARGES:** Revenue from monetary assessments authorized by statute in addition to criminal and traffic penalties and certain civil and other fees;
- **FEES:** Revenue from collectible fees for services of the court and chargeable aspects of case processing; and,
- **OTHER REVENUE:** Revenue from sources not otherwise specified.

### **Revenue**

**Change Across Time.** Revenue collected from limited jurisdiction courts decreased from \$250,228,235 in FY 2019 to 227,452,657 in FY 2020, a decrease of 9.1%. The justice court revenue decreased 7.9%, from \$106,653,151 in FY 2019 to \$98,238,404 in FY 2020. During the same period, municipal court revenue decreased 10.0% from \$143,575,084 to \$129,214,254. Combined fine and surcharge revenue decreased 8.5% from \$157,061,866 in FY 2019 to \$143,637,722 in FY 2020.

**Source.** Revenue from fines, sanctions and forfeitures, which totaled \$89,654,610 collected during FY 2020, accounted for 39.4% of the total limited jurisdiction courts. Revenue from court fees, the second largest revenue source, accounted for 36.8% (\$83,730,601) of the total LJ court revenue. An additional \$53,983,112 (23.7%) were collected during FY 2020 for revenue originated from surcharges.

**Limited Jurisdiction.** Municipal courts contributed to the largest proportion of fines (62.7% or \$56,257,394) and surcharges (60.5% or 32,635,369). About half (48.1% or \$40,275,928) of all court fees were collected by the municipal courts.

Two counties, Maricopa County and Pima County justice courts generated 56.0% of all justice court revenue. In addition, municipal courts from these two counties constituted 82.3% of all municipal court revenue. The two largest municipal courts - Phoenix and Tucson - not only accounted for 29.7% of all municipal court revenue, but 16.9% of the revenue from all Arizona limited jurisdiction courts.

### **Trust**

The Annual Trust Money Collection Summaries show that the limited jurisdiction courts processed \$31,757,254 in "pass-through" trust monies during FY 2020, most of which were for bail bonds.
