

## **ADULT PROBATION**

### **Narrative Summary**

There are two pages of tables for statewide and county adult probation activity. The first page includes Standard and Intensive Adult Probation Case Activity and Probationers with Petitions to Revoke. The second table summarizes Community Restitution Hours, Monetary Collections and Probation Reports. Note that absconder statistics are not reported in these statistics.

Direct adult probationers are the number of probationers sentenced in Superior or Limited Jurisdiction Courts residing in each county for whom direct supervision is being provided. Probationers indirectly supervised by each county are not counted because these probationers may already be counted in other counties and would cause these probationers to be double counted for statistical purposes.

There were a total of 16,523 individuals added to the active standard and intensive probation population during FY 2021. At the end of FY 2021, there were 40,933 active standard and intensive probationers. A total of 17,623 petitions to revoke were filed during the fiscal year. Of all the probation violation matters brought back before the court in FY 2021, dispositions were achieved in 9,319 cases. Standard and intensive probationers paid \$41,572,385 in restitution, reimbursement, fines, surcharges and fees. Restitution accounted for 32.4% of the money collected. Note that absconder statistics are not reported in these statistics.

There were 15,350 individuals added to the active standard probation population in FY 2021. During the fiscal year, 18,165 individuals were terminated from standard probation. On June 30, 2021, there were 38,335 active standard probationers. A total of 14,860 petitions to revoke were filed on standard probationers during FY 2021. Of all the standard probation violation matters brought back before the court, dispositions were achieved in 6,774 cases. Standard probationers paid \$41,247,071 in restitution, reimbursement, fines, surcharges and fees. Restitution accounted for 32.6% of the money collected.

During FY 2021, 1,173 individuals were added to the active intensive probation population. Over the course of the fiscal year, 1,073 individuals were terminated from intensive probation\*. At the close of the fiscal year there were 2,598 active intensive probationers. A total of 2,763 petitions to revoke were filed on intensive probationers during FY 2021. Of all the intensive probation violation matters brought before the court, 2,545 reached disposition. Intensive probationers paid \$325,314 in fines, restitution and other monies. Restitution accounted for 15.2% of the money collected.
