

**ARIZONA COURT REVENUE**  
**Statewide Narrative Summary**  
**State Fiscal Year 2021**

Statewide revenue data for all the court levels -- Supreme Court, Court of Appeals, Superior Court and the limited jurisdiction courts -- are summarized in this report. The figures were compiled from probation fee reports and the monthly revenue surveys distributed by the Supreme Court for state fiscal year (FY) 2021. Major revenue categories listed below represent monies collected from four sources:

- FINES, SANCTIONS, FORFEITURES: Revenue from monetary penalties assessed in criminal, traffic, and juvenile matters, and bond monies that were forfeited;
- SURCHARGES: Revenue from monetary assessments authorized by statute in addition to criminal and traffic penalties assessed and certain civil and other fees;
- FEES: Revenue from collectible fees for court services and chargeable aspects of case processing; and,
- OTHER REVENUE: Revenue from sources not otherwise specified.

**Annual Revenue Summary**

Total revenue collected by the Arizona courts slightly declined (1.5%), from \$317,008,114 in FY 2020 to \$312,278,375 in FY 2021. Statewide, the courts collected \$103,157,683 in fines, sanctions, and bond forfeitures during FY 2021, increased slightly (0.4%) from \$102,768,869 collected in FY 2020. Revenue from court surcharges decreased from \$58,279,759 in FY 2020 to \$57,345,923 in FY 2021 (1.6% decline). Fee revenue decreased from \$155,218,865 in FY 2020 to \$149,015,904 in FY 2021 (a 4.0% decline).

In FY 2021, revenue collected from court fees made up the largest portion of statewide court revenue comprising 47.7% of the total. Revenue from fines, sanctions and forfeitures accounted for 33.0% of state revenues and court surcharges accounted for 18.4% of the total statewide revenue collected in FY 2021. The municipal courts generated the largest proportion of total statewide court revenue: 40.3% (\$125,793,273). The justice courts generated 29.5% (\$91,976,252) and the Superior Court generated 29.0% (\$90,666,340) of the annual court revenue.

**Revenue Distribution Summary**

According to the revenue distribution summary, 43.5% of the FY 2021 court revenue was distributed to the state, 35.1% to counties and 21.4% to municipalities.

**Trust Money Collection Summary**

The Arizona courts processed a total of \$135,564,248 in "pass-through" trust monies, of which restitution accounted for 13.7% (\$18,635,668) of the total. The majority of trust monies were collected from bail bonds 46.5% (\$62,969,954).

A central support payment clearinghouse was established in FY 1998 to assume responsibility for receiving, disbursing and monitoring child support payments, pursuant to Title IV-D of the Social Security Act. All child support payments collected by the courts are turned over to the Arizona Department of Economic Security. The Superior Court collected \$6,416,904 in child support during FY 2021, a 16.4% decrease from FY 2020.

*Note.* Some of the FY 2020 figures may not correspond to figures published in the previous year's Data Report due to corrected information received subsequent to publication of the Report. Revenue reports received from courts are checked for mathematical accuracy but are not audited by the Supreme Court.
