

ARIZONA COURT REVENUE
Appellate and Superior Court Narrative Summary
State Fiscal Year 2022

The revenue data provided in this summary represent revenue generated by the appellate and superior courts of Arizona. The appellate courts consist of the Supreme Court, Division 1 and 2, and the Appellate Court. The Superior Court, which is the state's general jurisdiction court, is a single entity with locations in each county. The figures were compiled from probation fee reports and the monthly revenue surveys distributed by the Supreme Court during the state fiscal year (FY) 2022. The major revenue categories listed below represent monies collected from four sources:

- **FINES, SANCTIONS, FORFEITURES:** Revenue from monetary penalties assessed in criminal and juvenile matters, and bond monies that were forfeited;
- **SURCHARGES:** Revenue from monetary assessments authorized by statute and in addition to criminal penalties assessed and certain civil fees;
- **FEES:** Revenue from collectible fees for court services and chargeable aspects of case processing; and,
- **OTHER REVENUE:** Revenue from sources not otherwise specified.

Appellate Courts

Total revenue collected by the Supreme Court increased from \$3,536,472 in FY 2021 to \$3,615,914 in FY 2022 an increase of 2.2%. Most of this revenue originated from Defensive Driving and JCEF Diversion fees which are sent directly to the Administrative Office of the Courts. The revenue for the Court of Appeals increased from \$306,766 in FY 2021 to \$330,369 in FY 2022, an increase of 7.7%.

Superior Court

Superior Court revenue (including revenue collected by probation) decreased from \$90,666,340 in FY 2021 to \$88,388,594 in FY 2022, a decrease of 2.5%. Maricopa County's superior court accounted for 62.3% of all Superior Court's state revenue, followed by Pima County with 11.5%.

Fees made up the largest proportion of the Superior Court revenue (including revenue collected by probation), a total of \$68,334,189, or 77.3%. Fines levied by the Superior Court comprised the second largest revenue source and totaled \$14,488,349, or 16.4% for FY 2022.

According to the Annual Trust Money Collection Summary, Arizona superior courts processed \$130,639,486 in "pass-through" trust monies during FY 2022.
