10-01 Application for Ordinary Disability Benefits

Board Member Jason Hathcock address the Board with some discrepancies between what the medical evidence, submitted by the claimant, states and the CORP Physical Exam taken June 26, 2007. To resolve these discrepancies, the Board agreed to refer applicant #10-01 for an Independent Medical Examination (IME) to obtain a diagnosis of the onset of the applicant's current medical condition.

MOTION: A motion was made by J. Hathcock to refer case #10-01 for an IME. Motion was seconded and passed with a four to one vote. **CORP 2010-19**

The Attorney advised that since there was discussion of the factual basis of the application the verbatim transcripts should be sent to the IME doctor along with all medical evidence.
