The Office of the Fund Manager (PSPRS) is requesting a Board decision on whether these individuals are eligible to participate in CORP after making an irrevocable decision to "Opt-out. After consideration of the language contained in the "Opt-out" form and information received from the Board's attorney, the Local Board determined that the Board lacked the authority to approve the requests of these ASRS members to revoke their prior elections to remain in ASRS.
