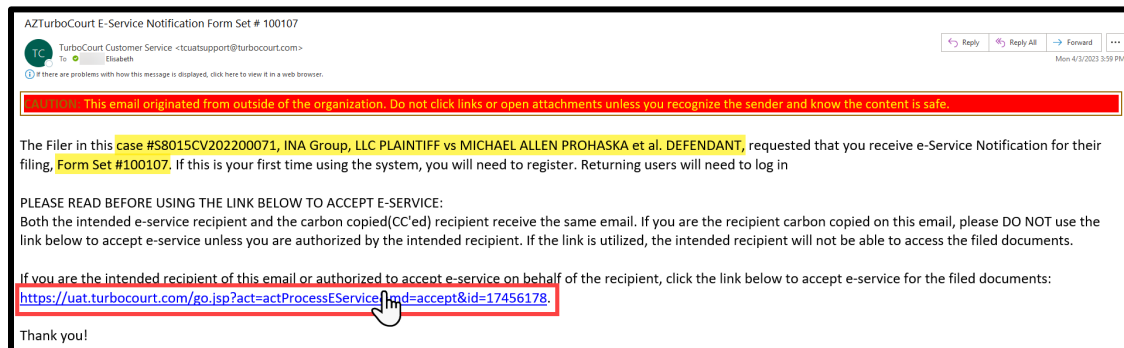


How to Retrieve eServed Documents

When a case participant has been eServed with documents, an email will be received from tcsupport@turbocourt.com. The email will provide basic case/filing information and a hyperlink to access/view the eServed documents. eServed documents may be accessed from (1) the [link provided in the eService email](#) or (2) the [User Menu in TurboCourt](#).

- To access eServed documents from the **eService email**, select the **link** in the body of the email



- The eService Confirmation page will open > Enter **the email address that received the eService link** > Select **Submit**
