**ORDER OF INTERIM  
SUSPENSION**

On November 16, 2018, the State Bar filed with the disciplinary clerk, pursuant to Rule 61, Ariz. R. Sup. Ct., a Notice of Felony Conviction. Scott Allan Maasen was convicted in *United States of America v. Scott A. Maasen*, No. CR-16-01357-001-PHX-DGC dated November 14, 2018, of a Class D Felony, Concealment of Assets in Bankruptcy. No motion showing good cause why an interim suspension should not be entered was filed. Rule 61(c)(A).

Now Therefore,

**IT IS ORDERED** pursuant to Rule 61, Ariz. R. Sup. Ct., suspending **SCOTT ALLAN MAASEN, Bar No. 018073**, from the practice of law effective immediately on an interim basis.

**IT IS FURTHER ORDERED** as provided in Rule 61(d), Ariz. R. Sup. Ct., such suspension shall continue in force until final disposition of all pending disciplinary proceedings against Scott Allan Maasen, unless vacated or modified.

**IT IS FURTHER ORDERED** effective immediately, Scott Allan Maasen shall not accept for representation any clients and is precluded from accepting funds for that purpose.

**IT IS FURTHER ORDERED** under Rule 72(a), Ariz. R. Sup. Ct., Scott Allan Maasen, shall notify all his clients of the terms of this order within ten (10) days from the date of this order, and shall timely file with the Disciplinary Clerk and the Supreme Court, notice of his compliance as provided by Rule 72(e), Ariz. R. Sup. Ct.

**IT IS FURTHER ORDERED** setting the underlying matter for telephonic status review on **March 5, 2019 at 11:30 a.m.** This status review shall automatically be vacated without further order upon the filing of a formal complaint or consent regarding this matter.
