Having considered Applicant, **J. CRAIG MEHRENS'**, request for reinstatement and affidavit filed June 10, 2016, pursuant to Rule 64(e)(2), Ariz. R. Sup. Ct., and there being no objection by the State Bar; accordingly:

IT IS ORDERED Applicant, **J. CRAIG MEHRENS**, be reinstated to the active practice of law in Arizona effective the date of this order.

IT IS FURTHER ORDERED Applicant, **J. CRAIG MEHRENS** is placed on probation for two (2) years effective the date of this order and under the following terms and conditions:

Terms and Conditions of Probation

1. Mr. Mehrens shall contact the State Bar Compliance Monitor at (602) 340-7258, within ten (10) days from the date of this order, to schedule an assessment under LRO MAP (Anger Management) and LRO MAP Alcohol Screening Assessment. The Compliance Monitor shall develop terms and conditions of participation if the results of the assessment so indicate and the terms, including reporting requirements, shall be incorporated herein. Mr. Mehrens shall be responsible for any costs associated with participation with compliance.
2. The State Bar shall report material violations of the terms of probation pursuant to Rule 60(a)(5), Ariz. R. Sup. Ct., and a hearing may be held within thirty (30) days to determine if the terms of probation have been

violated and if an additional sanction should be imposed. The burden of proof shall be on the State Bar to prove non-compliance by a preponderance of the evidence.
